

ORDINANCE NO. 23-08

AN ORDINANCE AMENDING ORDINANCE NO. 20-14, SERIES OF 2020, ENTITLED, "AN ORDINANCE INTEGRATING AND HARMONIZING ALL PERTINENT ORDINANCES RELATING TO FISHERIES AND PROTECTION OF THE PRINCIPAL WATERS OF THE MUNICIPALITY OF INOPACAN, LEYTE" AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Bayan of Inopacan, Leyte that;

SECTION 1. Article V (Prohibited Acts and Penalties), Section 2 (Other Prohibitions) is hereby amended to delete the word *Fishery Vessel* and shall be read as:

Seized fishing gear, paraphernalia and other items used in the commission of the prohibited acts shall be forfeited in favor of the municipal government of Inopacan, Leyte.

SECTION 2. Repealing Clause. All other existing resolutions, ordinances or rules which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 3. Separability Clause. Should any section or provision of this ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This ordinance shall take effect upon its approval.
