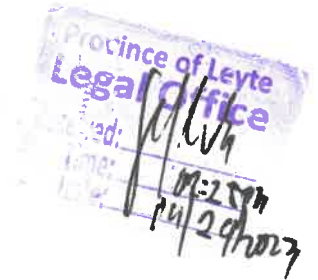

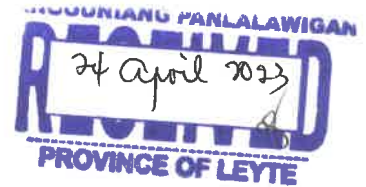

ORDINANCE NO. 23-09

AN ORDINANCE AMENDING ORDINANCE NO. 23-06, SERIES OF 2023 ENTITLED, "AN ORDINANCE IMPOSING REGULATORY FEE FOR VISITING TOURIST BOUND FOR APID, MAHABA AND DIGYO ISLETS OF THE MUNICIPALITY OF INOPACAN, PROVINCE OF LEYTE"

BE IT ORDAINED by the Sangguniang Bayan of Inopacan, Leyte that;

SECTION 1. The third whereas is hereby deleted.

SECTION 2. Section 4, Section 5, Section 6, Section 7, Section 8, and Section 9 are hereby amended and shall be read as Section 6, Section 7, Section 8, Section 9, Section 10 and Section 11.

SECTION 3. Section 4 shall be read as:

Trust Fund Account. There shall be created a special trust fund account of which Php 100.00 of the Php 120.00 regulatory fee per person shall be deposited. This fund shall be committed solely for the purchase of lots as resettlement site and construction of housing units for resettled households from Digyo within the period 2025-2027.

The remaining Php 20.00 per person of the Php 120.00 regulatory fee shall accrue to the municipal coffer to help defray expenses like manpower complement and other maintenance and operating expenses.

SECTION 4. Section 5 shall be read as:

Mandatory Review. This ordinance shall be subject for mandatory review after LGU-Inopacan in coordination with DENR-PAMB has declared that the purchase of lots as resettlement site and construction of housing units for resettled households from Digyo has been successfully implemented as reflected in the "One Island, One Destination" program for CIPLS which was approved on Feb. 23,2023 by DENR-PAMB.

SECTION 5. Repealing Clause. All ordinances, resolutions, orders and/or rules and regulations inconsistent herewith are hereby repealed and modified accordingly.

SECTION 6. Separability Clause. If any section or provision of this ordinance is declared void or unconstitutional, the remaining section or provision thereof shall not be affected by such declaration.

SECTION 7. Effectivity Clause. This ordinance shall take effect after its approval.

ENACTED this 18th day of April 2023 at Inopacan, Leyte.
