**BE IT ORDAINED**, by the Sangguniang Bayan of PASTRANA, PROVINCE OF LEYTE to enact the following Ordinance;

**SECTION 1. TITLE**, this ordinance shall be known as AN ORDINANCE IMPOSING TRUCK BAN HOURS FROM 6:00 P.M. TO 6:00 A.M. IN THE HAULING AND TRANSPORTING OF SAND AND GRAVEL WITHIN THE MUNICIPALITY OF PASTRANA PROVINCE OF LEYTE AND PROVIDING PENALTIES THEREOF.

**SECTION 2.** all cargo vehicles, including trailer trucks with six (6) wheels and above, irrespective of its gross weight, are hereby restricted or prohibited to haul sand and gravel from 6:00 o'clock in the evening to 6:00 o'clock in the morning.

**SECTION 3. DEFINITION OF TERMS**, for the purpose of this ordinance, the following terms are defined as follows,

- a. **PENALTY** – the suffering in person, rights, or property that is annexed by law or judicial decision to the commission of a crime or public offense.
- b. **IMPOUND** – to seize and hold in the custody of the law.
- c. **IMPOUNDMENT** – the state of being impounded.
- d. **MUNICIPAL CASH TICKET** – shall refer to the official ticket issued to the designated personnel and staff of the municipal treasurer's office.
- e. **TRUCK BAN HOURS** – shall refer to the period 6:00 o'clock in the evening to 6:00 o'clock in the morning, wherein six (6) wheeler and up, cargo vehicles or trucks are prohibited to haul sand and gravel in the Truck Ban Hour.

**SECTION 4. PENALTY CLAUSE**, all person or drivers found violating any provision of this ordinance shall be penalized by:

First Offense – Ten (10) cubic meter up is five thousand pesos (5,000.00) below ten (10) cubic meter – two thousand five hundred pesos (2,500.00)

Second Offense – Ten (10) cubic meter up is ten thousand pesos (10,000.00) below ten (10) cubic meter is five thousand pesos (5,000.00)

Third Offense – Ten (10) cubic meter up is twenty thousand pesos (20,000.00) and the vehicle/truck will be impounded. Below ten (10) cubic meter is ten thousand pesos (10,000.00) and the vehicle/truck will be impounded.

**SECTION 5. ENFORCEMENT:** The LGU Monitoring Team, the Philippine National Police stationed at LGU Pastrana, Leyte, the Municipal Treasure's Office and other concerned government agencies shall ensure the strict implementation of this ordinance.

**SECTION 6. NON-APPLICABILITY CLAUSE:** This ordinance shall not apply to all trucks or vehicles hauling or transporting sand and gravel on correct

and agreed time as stated in the ORDINANCE and must be of correct cubic meter of at least ten (10) cubic meter above;

**SECTION 7. SEPARABILITY CLAUSE-** If for any reason, any provision portion or part of this ORDINANCE is found to be inconsistent with any law, other provision or part of parts thereof not so affected shall remain in full force and effect

**SECTION 8. REPEALING OR AMENDATORY CLAUSE:** All Ordinance rules and regulation or part of parts thereof, which are inconsistent or in conflict with the provision, of this Ordinance are hereby repealed, amended and or modified accordingly.


**SECTION 9. EFFECTIVITY,** This Ordinance shall take effect upon its approval and publication in the Local Newspaper of general circulation, and posting conspicuous place in the municipality of Pastrana Province of Leyte as required under the Local Government code of 1991, Republic Act 7160.

**MINUTES OF THE PUBLIC HEARING ON THE MUNICIPAL ORDINANCE IMPOSING TRUCK BAN HOURS FROM 6:00 PM TO 6:00 AM IN THE HAULING AND TRANSPORTING OF SAND AND GRAVEL WITHIN THE MUNICIPALITY OF PASTRANA AND PROVIDING PENALTIES THEREOF HELD LAST APRIL 20, 2023 AT THE MUNICIPAL AUDITORIUM, THIS MUNICIPALITY.**

**I. Preliminaries**

- a. The Public Hearing was conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by the SB Committee Chairman on Environment and Natural Resources and was joined by majority of the members of the Sangguniang Bayan.
- b. It was well participated by all the Barangay Chairpersons and some members of their Barangay Council, MLGOO, representatives from the Treasurer's Office, PNP personnel interested to listen to this particular public hearing. (Attached is the Attendance sheet)
- c. The said public Hearing was Presided over by Honorable Angelina C. Diola, SB Committee Chairman on Environment and Natural Resources.
- d. The said Public Hearing Started at exactly 10:15 in the morning, and Prayer was led by Hon. Suzieta Omoy followed by the singing of the Philippine National Anthem through an overture.

**II. Parliamentary Proceedings**

- a. The Draft Ordinance, an Ordinance Imposing Truck Ban hour from 6:00 pm to 6:00 am in the Hauling and Transporting of Sand and Gravel within the Municipality of Pastrana and Providing Penalties Thereof, was read by the SB-Local Legislative Staff Ms. Vernadith N. Dizon, with a power point presentation. After which Hon. Diola proceeded to Section 2 and asked the participants if they agree on the proposed time of truck ban hours from 6:00 pm to 6:00 am. Then the presiding officer asked for Hon Tan's opinion on the concern. Hon. Tan explained to the audience that this ordinance was made to solve the problem on violators who are transporting sand and gravel on peak hours. He added that instead of 6:00 pm to 6:00 am it would be better to have it from 8:00 am to 5:00 pm since there are still personnel on duty from the municipal treasury. He also added that adjusting the time would be very convenient to everyone especially the personnel from the LGU. He then asked for the concessionaire's side on the concern.
- b. According to the concessionaire from Red Dragon they will just follow whatever is in the Ordinance, however there are instances that emergencies will arise like vehicle problems or even the crusher itself which may cause their clients to transport sand and gravel during the proposed truck ban hours. As a matter of fact, their employees are going out at 5:30 pm which means work is already done.
- c. Hon. Carian added that he was able to justify that Red Dragon never goes out with their vehicle loaded with sand and gravel beyond the said time but there are those

who really transport beyond office hours wherein no more LGU collectors are present.

- d. Hon. Letrodo expressed that 6:00 pm to 6:00 am is okay with him but we can also make it during office hours from 8:00 am to 5:00 pm and that passing/transporting with sand and gravel beyond that time will consider them violators or better assign collectors in the night shift for this concern.
- e. As to Hon. Tan designating personnel to stay in the area beyond office hours is also a violation . He reiterated that passing through the municipality without sand and gravel loaded to the truck is not a violation, but if there will be PNP personnel as law enforcer that will take over provided that the ordinance will already exist. He also introduced representatives from the Municipal Treasurer's Office to further address the concern.
- f. Mr. Rogelio Gerilla a representative from the Municipal Treasurer's Office explained that they don't want to deploy collectors beyond office hours but if the proposed truck ban hours of 6:00 pm to 6:00 am will push through they are ready to designate personnel and have a shifting schedule for the staff. He assured that 6:00 pm to 6:00 am is okay with them, and this is to give allowance to the travel time of the concessionaire, and so for those concessionaires who will transport beyond office hours they are ready to adjust and instruct their staff about it. But for those who will be transporting beyond the designated time PNP will take over and violators will just go to MTO to pay for the penalty.
- g. Hon Tan added that proper posting and information dissemination should be done since this will be submitted to Sangguniang Panlalawigan.
- h. Hon Jennifer J. Abretil Brgy. Chairperson of Brgy. Guindapunan expressed that she wanted to suggest to add a particular concern to the proposed ordinance and that the concessionaire should give attention to the disturbance that they create and the damage to the roads that they made when their trucks pass loaded with sand and gravel. She also added that these truck drivers should be cautious because there are children passing the area and so they need to slow down to avoid accidents. And she also appealed that the concessionaire should help the barangays concerned in repairing the damages in their roads.
- i. Hon Carian added that it is true that this truck drivers are causing disturbance every time they are passing the area and that the appeal of Brgy Chairperson of Brgy Guindapunan should be given prior attention.
- j. Red Dragon representative expressed that they are willing to give the materials needed in the repair of the roads identified however they are asking for help from those barangays concerned.
- k. Hon Tan added that this is better because if we will still wait for the action from the province it will surely take time.
- l. Hon Villablanca expressed that if the concessionaire is willing to give sand why not include cement to fully repair the roads.
- m. But the concessionaire stated that they can only provide sand as of the moment.
- n. The presiding officer then reiterated that this public hearing was conducted to solve the issue on the time as to whether 6:00 pm to 6:00 am is approved by everybody. She also added that as per Local Chief Executive she stated that office hours is more convenient to avoid conflicts or issues that may arise since PNP personnel are not allowed to collect payments. And as per Barangay Resolution during her time as Barangay Chairperson of Bahay 5 pm to 5 am was practiced. She presented this to clearly show that their main concern of the public hearing is the time.
- o. Hon Carian asked if there are other suggestions.
- p. Hon Jerlyn Borja Brgy Chairperson of Brgy Bahay asked that if there will be untoward incidents and operation will restore at 6:30 pm, will the concessionaire be able to pass or will just wait for the next day.


- q. Hon. Tan answered that it is an exemption. He added that for every rule there is always an exemption.
- r. Brgy Chairperson of Brgy. Guindapunan suggested that if that happens they may go to the Brgy. Where the cause of delay occurred and ask for certification or proof in which they may show to the collectors or enforcers.
- s. Hon Carian expressed that considerations will be given for that situation.
- t. Hon Letrodo again reiterated that this ordinance was proposed to address the problem of these violators. He also added that the committee have a thorough deliberation that resulted to the proposal of 6:00 pm- 6:00 am truck ban hours which prohibits the passage of those violators and thus, he cleared that during that proposed time total ban will be imposed.
- u. The concessionaire then added that transporting during the indicated time is considered illegal.
- v. Hon Marlon Depaudhon Brgy. Chairperson of Brgy. Macalpiay concluded that 6:00 pm to 6:00 am is the time for prohibition to avoid the passage of violators. For him, it is the best solution to solve the problem.
- w. With this all the participants approved. And so Hon. Diola proceeded to Section 3 to ask if there are corrections and since there is none, she proceeded to Section 4. Hon Diola then read and discussed the offenses and penalties, thereby asking the participants approval. After which Hon. Diola proceeded to Section 5.
- x. PNP representative expressed that whatever the ordinance is and since it is for the good of the municipality, they will do as what they are told to do so.
- y. Hon Carian expressed that for the appeal of Brgy. Chairperson of Brgy Guindapunan and all the barangays concerned a barangay ordinance should be made and be passed for the Sangguniang Bayan to act on the ordinance being passed.
- z. The representative from the Municipal Treasurer's Office added that they were able to issue 50 pcs of citation tickets to PNP and that an inventory should be done.
- aa. Hon Tan expressed that there is a designated person that will issue the citation ticket. He also added that PNP personnel are not allowed to issue citation ticket and that MTO should also designate personnel beyond office hours.
- bb. As for Hon Carian PNP personnel will only turn over those that are caught since they are only there to conduct checkpoints.
- cc. Hon Villablanca asked the concessionaire's representative on the process since he had been deputized before.
- dd. The concessionaire explained that a request letter to MGB should be given to conduct seminars/trainings to properly identify and be aware of the right process including the issuance of citation ticket.
- ee. The representative from the Municipal Treasurer's Office stated that a checkpoint together with PNP personnel will be conducted and personnel from MTO will be assigned for the receipt and for the issuance of citation ticket.

- III. Finally, the ordinance presented by Hon. Angelina C. Socsocon and Hon Susan Royeras Brgy. Chairperson of Brgy. Halaba.
