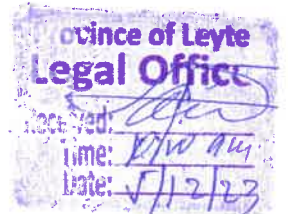

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance Nos. 429, of the SB of Babatngon, Leyte, recommending for the declaration of its validity pursuant to its power under Section 56 (c) of R.A 7160, the same being, to the opinion of the Provincial Legal Office (PLO), an exercise of the power authorized under Section 20 of the Code. Provided, That, All the requisites therein are duly complied with, including the required "Public Hearing". And if the agricultural land is owned by private individual, an application therefor is filed by the owner thereof. Provided, That, pursuant to DILG opinion No. 22, S. 2020 dated January 31, 2020, citing the case of "Chamber of Real Estate and Builder Association, Inc.. (CREBA) V. Secretary of Agrarian Reform (G.R. No. 183409), "Reclassification alone will not suffice to use the agricultural lands for other purposes. CONVERSION is needed to change the current use of reclassified agricultural lands".

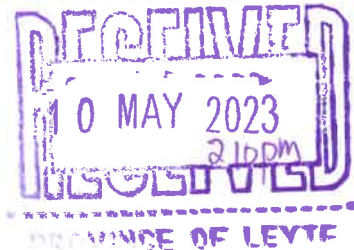

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte in session assembled:

Section 1. – Short Title – This ordinance shall be known as the “Brgy. Bacong Reclassified Ordinance” in the Municipality of Babatngon, Leyte.

Section 2. – Reclassification of Lot – By virtue of this ordinance, the lot measuring Four Thousand (4,000) square meters per Lot No. 1291-B under Cad Lot No. 1291 covered by Tax Declaration No. 2008-04005-00053 located at Barangay Bacong, Babatngon, Leyte, is hereby reclassified from Agricultural to Industrial land.

Section 3. – Repealing Clause. – All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

Section 4. – Effectivity Clause. – This ordinance shall take effect after ten (10) days from the date of its approval and posting in three conspicuous places in the local government unit.


