Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 008 series of 2023 of the Sangguniang Bayan of the Municipality of Pastrana, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160.

The Provincial Legal Office is of the opinion that the power to approve, enact and impliment said ordinance is provided for in section 447 (3) (v) of the Local Government Code. This Office, however, offers the following comments/recommendations:

- A. That the fine provided for in Section 10 of the Ordinance for first offences be reduced to P2,500 as opposed to P5,000 pursuant to Section 447(I)(iii) of the Local Government Code.
- B. That Section 3 (a), requirement item number 5, be modified to include conversion along with reclassification, as per DILG Opinion Circular 22, dated 1-31-20, citing the case of CREBA vs Secretary of Agrarian Reform, stating that reclassification is not enough without conversion to permit usage of agricultural lands for any other purposes.

All other else are deemed to be in consonance with PD 449, otherwise known as the Cockfighting Law of 1974.

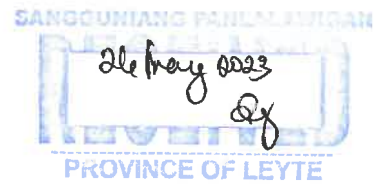



SECTION 1. TITLE OF THE ORDINANCE. This ordinance shall be known as "AN ORDINANCE PRESCRIBING RULES AND REGULATIONS ON THE ESTABLISHMENT, FRANCHISING, OPERATION AND MAINTENANCE OF COCKPITS IN THE MUNICIPALITY OF PASTRANA, PROVINCE OF LEYTE."

SECTION 2. DEFINITION OF TERMS. For purpose of this ordinance, the following terms shall be understood, applied and construed as follows:

- a. **FRANCHISE** – is a right, privilege or license granted to an individual or group, affected with public interest which is informed upon private persons or corporation under such terms and conditions as the government and its political subdivisions may impose in the interest of the public welfare, security and safety.
- b. **Cockpit and Sabungan.** A building with properly fenced premises or compound provided with one or more gates or doors for definite points of entrance and exit, duly licensed in accordance herewith for the holding of cockfighting, derby or pintakasi.
- c. **Cockfighting and Sabong.** Shall mean the commonly known game or term "cockfighting" derby, pintakasi or its equivalent terms in different localities in the Philippines.
- d. **Cockfight or Sultada.** The actual fight or physical combat of two gamecocks, more or less evenly matched, both armed with gaffs where bets on either side are laid and conducted in a duly licensed cockpit.
- e. **Zoning Law Ordinance.** Either or both national, local, municipal legislation which logically arranges, prescribes defines and apportions given political subdivision into specific land uses as present and for future projection of need warrant.
- f. **Residential Area.** Is an area in which homes are located and where people live.
- g. **Commercial Area.** Any establishment dealing in business of buying and selling goods and services which includes retail stores, restaurants, shops, guest houses.
- h. **Clinics.** A place in which outpatients are given medical treatment or advice to people, often connected to a hospital.
- i. **School Building.** Any structure suitable for use of classroom where classes are taught or extracurricular activities are conducted.
- j. **Churches.** A building designated or consecrated for any religious worship.
- k. **Public Building.** A building that belongs to a town or state and in used and accessible to the public.

SECTION 3. REQUIREMENTS FOR FRANCHISE APPLICATION.

Pursuant to section 447 (3) (v) of Republic Act 7160 also known as the Local Government Code of 1991, an applicant for a license to operate any cockpit within the municipality of Pastrana, Province of Leyte shall be required to secure a Legislative Franchise from the Sangguniang Bayan.

The following requirements must be fully complied with before the issuance of a **FRANCHISE**:

A. For New Applicants - every application for New License to operate or maintain a cockpit shall be submitted to the Office of the Mayor concerned accompanied by the following:

1. Registration of the Business from either DTI or SEC.
2. Proof of ownership of the Land or Lease Contract if being leased.
3. Proof of Financial Capacity, Company Profile, Development Program and Project Impact Assessment.
4. Clearance Certification:
 - a. Barangay Clearance
 - b. Mayor Clearance
 - c. DAR Certification
 - d. DENR Certification
 - e. MPDC Certification
 - f. Health Certification of operator and cockpit personnel.
5. Land Reclassification (if Agricultural Land)
6. The Location and vicinity plan for the cockpit.
7. The cockpit building plan/design as approved by the Municipal Engineer in Accordance with the National Building Code, and a certification by the latter, to the effect that the cockpit shall be constructed following such approved plan/design in the area allowed by the zoning law/ordinance. A certification by the Municipal Engineer to the effect that the location/site of the cockpit is not within a radius of 50 linear meter from any existing residential or commercial area, hospitals, school building, churches or other public buildings and further it is not within the radius of one (1) Kilometer from existing cockpit.
8. Official Receipt showing payment of the Municipal taxes, fees and other levies prescribed by the ordinance duly promulgated by the municipality and
9. Health Certification of the operator and cockpit personnel.

B. FOR RENEWAL OF FRANCHISE:

1. Clearance from the Treasurer on payment of dues (Tax Clearance, etc.)
2. New Lease Contract of Land if Applicable.
3. Audited Financial Statement of the last preceding year.

SECTION 4. Franchise to operate a cockpit arena shall be for a period of twenty (20) years renewable for another twenty (20) years subject to approval of the Sangguniang Bayan who shall evaluate the performance of the franchisee vis-à-vis his/her compliance to the terms and conditions of the franchise.

SECTION 5. Franchisee shall have a period of 5 years to comply with all the terms and conditions as provided in Section 8 of this ordinance

SECTION 6. Any person who will apply for franchise to operate a cockpit arena should be a bonafide resident of Pastrana, Leyte.

SECTION 7. In the event that there are 2 or more applicants for franchise to operate a cockpit arena in Pastrana, a majority of the Sangguniang Bayan shall decide as to whom the franchise will be awarded based on the criteria of selection which the Sangguniang Bayan will formulate.

SECTION 8. OTHER TERMS AND CONDITIONS TO BE FOLLOWED BY THE FRANCHISEE;

1. Construction of perimeter fence considering one (1) ENTRANCE and (1) EXIT.
2. Two (2) separate sanitary toilets for Ladies and Gentlemen, and must be well maintained with provision of water connection/facility.
3. Availability of Professional Parking Area
4. Provisions of COCK house (Butangan hit manok nga iburulang for cock safety)
5. Provision of No Smoking Area signage (Designated places for smoking)
6. Must provide a traffic aide during Sundays cockfight and during derby.
7. Health protocol must be strictly observed.
8. Bureau of Fire Protection must be furnished with STRUCTURAL PLAN.
9. Firearms or carrying of deadly weapon are not allowed inside the cockpit.
10. Illegal gambling is not allowed/prohibited inside the cockpit.
11. Franchisee is not allowed to operate an ONLINE SABONG.
12. MINORS are NOT ALLOWED INSIDE THE COCKPIT.
13. Food handlers inside the compound of the cockpit must secure health certificate.
14. Franchisee preferably must be a resident of the municipality of Pastrana, Province of Leyte, and must employ personnel, that are bona fide resident of Pastrana, Leyte, for further economic development in general and for livelihood upliftment in particular.
15. FRANCHISEE must comply all the TERMS and Conditions within a span of FIVE (5) Years after launching of the cockfight at cockpit arena. NON-COMPLIANCE of all the TERMS AND CONDITIONS will mean and resulted to CANCELLATION OF FRANCHISE OF THE FRANCHISEE.

SECTION 9. A franchise Fee in the amount of Two Hundred Thousand Pesos (₱200,000.00) should be paid by the Franchisee before a franchise is issued.





SECTION 10. PENAL PROVISIONS: In case that the FRANCHISEE CAN NOT or will not comply with the terms and conditions under Sec. 08, he/she will be sanctioned with the following to wit:

1st Offence - ₱5,000.00 and or imprisonment of not more than 3 months.

2nd Offence – One (1) Month suspension of its operation.

3rd Offence – CANCELLATION/REVOCAION OF FRANCHISE.

SECTION 11. APPLICABILITY CLAUSE: The provisions of PD 449, otherwise known as the COCKFIGHTING LAW OF 1974 and PD. 1802 Creating the Philippine Gamefowl Commission, and such other pertinent laws shall apply to all matters regarding the establishment and operation of cockpits and holding of cockfight in this municipality. Section 04 of PD 1802 is hereby amended that the Municipal Mayor with the concurrence of respective “Sanggunian” shall have the authority to issue license and regulate regular cockfighting pursuant to the rules and regulations promulgated by the commission and subject to its review and supervision.

SECTION 12. REPEALING CLAUSE. All ordinances, rules and regulations not consistent herewith are hereby repealed.

SECTION 13. EFFECTIVITY CLAUS. This ordinance shall take effect upon approval of the Sangguniang Bayan, and after fifteen (15) days publication in a newspaper of general circulation and after a copy thereof has been posted is at least three (3) conspicuous places within their jurisdiction.

SECTION 14. SEPARABILITY CLAUS. If for any sections or provision of this Ordinance is declared unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.



MINUTES OF PUBLIC HEARING OF MUNICIPAL ORDINANCE NO. 08 SERIES OF 2023 ENTITLED “ORDINANCE PRESCRIBING RULES AND REGULATIONS ON THE ESTABLISHMENT, FRANCHISING, OPERATION AND MAINTENANCE OF COCKPITS IN THE MUNICIPALITY OF PASTRANA, PROVINCE OF LEYTE, HELD LAST FEBRUARY 27, 2023 AT THE MUNICIPAL AUDITORIUM, THIS MUNICIPALITY.

I. Preliminaries

- a. The Public Hearing was conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by the SB Committee Chairman on Franchise, Permits and Licenses and was joined by majority of the members of the Sangguniang Bayan.
- b. It was well participated by all the Barangay Chairman, LGU Department Heads of Offices, Cockpit Fanatics and other sectoral representatives interested to listen to this particular public hearing. (Attached is the Attendance sheet)
- c. The said public Hearing was Presided over by Honorable Angelina C. Diola, SB Committee Chairman on Franchise, Permits and Licenses.
- d. The said Public Hearing Started at exactly 2:00 o'clock in the afternoon, and Prayer was led by Mr. Napoleon Pedrosa Nombre.

II. Parliamentary Proceedings

- a. The Draft Ordinance, an Ordinance Prescribing Rules and Regulations on the Establishment, Franchising, Operation and Maintenance of Cockpits in the Municipality of Pastrana, Province of Leyte, was read by the SB-Secretary designate Ms. Alona A. Mas, with the visual aid of a power point presentation. Queries arises from Section 8 to Section 10 of this said Franchise Ordinance and it was explained Section per Section the content of the Franchise Ordinance by Honorable Angelina C. Diola and she emphasized that what she is discussing is only focused on Franchise Ordinance, Operation and Maintenance of Cockpits in the said Municipality while COCKFIGHTING ORDINANCE is a separate ORDINANCE
- b. Honorable Rodel M. Tobilla inquired if under Section 9 the payment of Two Hundred Thousand (P 200,000.00) for Franchise Fee for Twenty (20) years will be paid in full upon its application? And it was positively responded by Honorable Angelina C. Diola that it must be paid in full and or lump sum.
- c. A stakeholder in the person of Mr. Bobby Enting raised his query if a winning Franchisee could start to operate even if his/her documents are still lacking? It was negatively answered by Hon. Angelina C. Diola
- d. Ms. Vilma O. Villegas – the Sanitary Inspector of LGU Pastrana suggested that it must have a two separate sanitary toilet for ladies and gentlemen at the onset of its operation.
- e. Mr. Alex Sequito suggested that for the cleanliness and maintenance of said toilets it will be at the dispense of the FRANCHISEE.

- f. Honorable Josephine Bohol Barangay Chairman of Barangay Arabunog suggested that a parking area must be provided.
- g. Honorable Gerado S. Carian suggested that the FRANCHISEE must be responsible for an orderly parking area.


III. Finally, the presented ordinance by Hon. Angelina C. Diola – “An Ordinance Prescribing Rules and Regulations on the Establishment, Franchising, Operation and Maintenance of Cockpits” was well applauded by all who attended the recently concluded PUBLIC HEARING dated February 27, 2023

IV. Since all participants were happy on the result of the Public Hearing with the approval of all the majority participants present, so be it.


V. Adjournment

There being no other matters to be discussed, Public Hearing was adjourned at 3:45 P.M. in the afternoon.

- Hon. Angelina C. Diola discuss and read aloud to the Committee the DRAFT OF FRANCHISE ORDINANCE.
- Mr. Napoleon P. Nombre suggested that all definition of terms be supplied by all concerned agencies.

- Engr. Eliseo M. Lucinario suggested that FRANCHISEE must strictly follow the Term and Conditions stipulated in the FRANCHISE ORDINANCE.
- Hon. Angelina C. Diola that as per SB Session dated February 06, 2023 which she inquired from the August Body, if how many years can be granted to an applicant applying for FRANCHISE. Majority of the member of the Honorable Legislative Body suggested for a maximum of 20 years granting of franchise while Honorable Loida B. Villablanca suggested for a 10 – year granting of Franchise to a Franchisee. BFP Conrado O. Peñaranda suggested to a grant 5 years franchise.
- Mr. Jose Eric Aguilar suggested that a Franchise Fee of ₱10,000.00 per year X Franchise Longevity be paid only once, lump sum and Cockpit Permit Fee of ₱5,000.00 per year
- Franchise to operate cockpit arena for period of 20 years renewal to 20 years subject to approval of the Sangguniang Bayan who shall evaluate the performance of FRANCHISEE vis-a-vis his/her compliance to the terms and condition of the franchise
- Franchise shall have period of 5 years and will comply with all the terms and conditions as provided in section 8 of this ordinance
