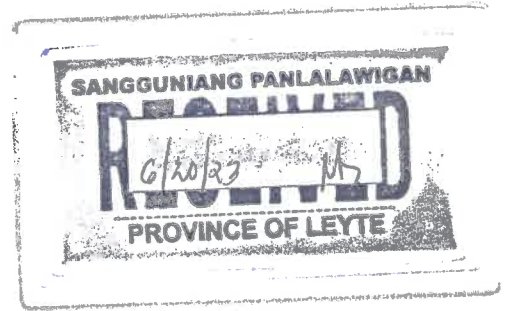

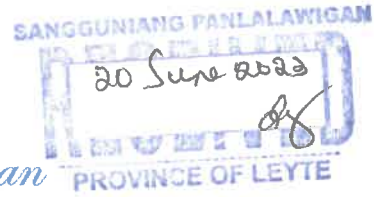

ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES AND CAUSING THE EXPLOSION OF THE SAME OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF PASTRANA, LEYTE.

SECTION 1. TITLE – This Ordinance shall be known as the “Total Ban On Manufacture, Sale, Distribution, Possession and Use of Firecrackers or Pyrotechnic Devices Within the Territorial Jurisdiction of Pastrana, Leyte”.

SECTION 2. PURPOSE OF THIS ORDINANCE – It is the purpose of this Ordinance to Prohibit the Manufacture, Sale, Distribution, Possession and Use of Firecrackers or Pyrotechnic Devices and causing the explosion of the same within Pastrana, Leyte, to promote public safety, peace, order and security.

Firecrackers, as fire hazards, and known to cause bodily harm, injuries and even deaths, have been shown and proven in studies to also cause the following:

- Increase in toxic fumes and gases like carbon dioxide, Sulfur dioxide and nitrogen dioxide, as well as suspended particulate matter (SPM) in the air;
- Increase in noise pollution above 125 decibel (dB), which is above the tolerable limits, and can cause deafness;
- Increase in incidents of respiratory diseases such as acute bouts of asthma and bronchitis, and may also trigger heart attacks.

SECTION 3. TYPES OF FIRECRACKERS AND PYROTECHNIC DEVICES – The Following are common types of firecrackers and pyrotechnic devices:

A. Firecrackers

1. Baby rocket – A firecracker within a stick so constructed that lighting of the wick will propel the whole thing to lift a few meters before exploding. The firecracker is about 1 ½ inches in length by 3/8 inch in diameter while the stick is about a foot in length;
2. Bawang – A firecracker larger than a triangulo with 1/3 teaspoon of powder packed in cardboard tied around with abaca strings and wrapped in shape of garlic;
3. Small Triangulo – A firecracker shaped like a triangle with powder content less than the bawang and usually wrapped in brown paper measuring ¾ inch length in its longest side;
4. Pulling of Strings – A firecracker consisting of a small tube about an inch in length and less than ¼ of an inch in diameter with strings on each end. Pulling both strings will cause the firecrackers to explode.
5. Paper Caps – Minute amount of black powder spread in either small strips of paper on a small sheet used for children’s toy guns.
6. El Diablo – Firecrackers tubular in shape about 1 ¼ inches in length and less than ¼ inch in diameter with a wick also known as labintador;
7. Watusi – Usually reddish in color about 1 ½ inches in length and 1/10 inch in width usually ignited by friction to produce a dancing movement and a crackling sound;





8. Judahs Belt – A string of firecrackers consisting or ether diablos or small triangulo that can number up to a hundred or thereabout and culminating in large firecrackers usually a bawang;
9. Sky rocket – (kwitis) – A large version of a baby rocket designed to be propelled to a height of forty (40) to fifty (50) feet before exploding;
10. Other types with equivalent of more explosive content to the foregoing items.

B. PYROTECHNIC DEVICES

1. Sparklers – Pyrotechnic devices usually made of black powder on a piece of wine or inside a paper tube designed to light up and glow after igniting;
2. Luces – Any of several kinds of sparklers;
3. Fountain – A kind of sparkler conical in shape which is lighted on the ground and designed to provide various rising colors and intermittent lights upon being ignited;
4. Jumbo Regular and Special – A kind of sparkler similar to a “fountain” but bigger in size;
5. Mabuhay – Sparklers bunched into a bundle of a dozen pieces;
6. Roman Candle – A sparkler similar to a “fountain” but shaped like a big candle;
7. Trompillo – A pyrotechnic device usually fastened at the center and designed to spin first clockwise and then counter-clockwise and provides various colored lights upon being ignited;
8. Air-wolf – A kind of sky rocket shaped like an airplane with propeller to rise above forty (40) or fifty (50) feet and provide various kinds of light while aloft;
9. Whistle Device – Any of the various kinds of firecrackers or pyrotechnic designed to either simply emit a whistle – like sound or explode afterwards upon being ignited;
10. Butterfly- Butterfly-shaped pyrotechnic device designed to lift above the ground while providing light;
11. Other types equivalent to the following devices.


SECTION 4. PROHIBITED ACTS – It shall be unlawful for any person, natural or juridical, to manufacture, sell or offer sale, distribution, possess or use any firecracker or pyrotechnic devices and causing the explosion of the same within the territorial jurisdiction of Pastrana, Leyte.

SECTION 5. EXCEPTIONS – A fireworks exhibition for special occasion or celebration may be granted an exemption to the section 4 provisions of this ordinance under special permit issued by the Office of the Municipal Mayor.

SECTION 6. PENALTIES – Violation of any of the provisions of Section 4 of this Ordinance shall be penalized as follows:

- A. FOR THE FIRST OFFENSE** – a fine of One Thousand Pesos (PHP.1000.00) or imprisonment of not more than one (1) month but not less than twenty (20) days, or both fine and imprisonment, at the discretion of the court. In addition, thereto, the concerned business establishment stocks of fireworks or pyrotechnic devices shall be immediately confiscated by the Municipal Government.







B. FOR THE SECOND OFFENSE – a fine of One Thousand Five Hundred Pesos (PHP. 1,500.00) or imprisonment of not more than Three (3) months but not less than one (1) month, or both fine and imprisonment, at the discretion of the Court. In addition, thereto, the concerned business establishment’s stocks of fireworks and pyrotechnics shall be immediately confiscated by the Municipal Government.

C. FOR THE THIRD OFFENSE – a fine of Two Thousand Five Hundred Pesos (PHP. 2,500.00) or imprisonment of not more than six (6) months but not less than Three (3) months, or both fine and imprisonment at the discretion of the Court. In addition, thereto, the concerned business establishment’s stocks of fireworks and pyrotechnic devices shall be immediately confiscated and its business permit shall be immediately revoked by the Municipal Government.

SECTION 7. CONFISCATION- all confiscated firecrackers and pyrotechnic devices shall be destroyed under the supervision of the Municipal Mayor and the members of the Municipal Peace and Order Council.

SECTION 8. The office of the Municipal Mayor shall formulate the implementing Rules and Regulations (IRR) necessary for the effective implementation of this Ordinance.

SECTION 9. SEPARABILITY CLAUSE – Should any of the provisions of this Ordinance be declared inoperative by the Courts for being inconsistent with the Constitution or the Law, the other unenacted provisions of this Ordinance shall retain its full force and effect.

SECTION 10. REPEALING CLAUSE – any and all ordinances or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 11. This Ordinance shall take effect after its approved and following its publication in a newspaper or general circulation.

MINUTES OF PUBLIC HEARING OF MUNICIPAL ORDINANCE NO. 09 SERIES OF 2023 ENTITLED “ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES AND CAUSING THE EXPLOSION OF THE SAME OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF PASTRANA, LEYTE”.

I. Preliminaries

- a. The Public Hearing was Conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by Hon. Nathan G. Letrodo the SB Committee Chairman in Market and Slaughterhouse, and was joined by Majority of the members of the Sangguniang Bayan.

II. Parliamentary Proceedings

- a. Public Hearing was finally started at about 3:48 in the Afternoon, and was presided over by the Honorable Nathan G. Letrodo and he was the one who personally read the Draft of the Ordinance entitled ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES AND CAUSING THE EXPLOSION OF THE SAME OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF PASTRANA, LEYTE, Hon. Nathan G. Letrodo explained to all the participants in the Public Hearing the contents of the Ordinance present in the said Public Hearing are all the Barangay Chairman, Store Owners and LGU Pastrana personnel all businesses and storeowners within the municipality and the office -in-charge of Bureau of Fire Protection.
- b. Explanation of Hon. Nathan G. Letrodo was so vividly and thoroughly understandable that no question was raised.

III. Finally, the presented ordinance by Hon. Nathan G. Letrodo – “ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES AND CAUSING THE EXPLOSION OF THE SAME OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF PASTRANA, LEYTE, to promote public safety, peace, and order and security ended with the general support of all the populace of the Municipality of Pastrana being well represented by all stakeholders.
