Section 1. – Short Title – This ordinance shall be known as the "Brgy. Naga-Asan Reclassified Ordinance" in the Municipality of Babatngon, Leyte.

Section 2. — Reclassification of Lots — By virtue of this ordinance, under Cadastral Lot No. 295 covered by Tax Declaration No. 2008-04014-0050, the three (3) parcels of land located at Barangay Naga-Asan, Babatngon, Leyte, identified in the vicinity map as Lot No. 295-B-1 is reclassified from Agricultural to Institutional; while Lot No. 295-C-4 and Lot No. 295-D-1 are hereby reclassified from Agricultural to Commercial land in classifications.

<u>Section 3.</u> – Repealing Clause. – All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

<u>Section 4.</u> – Effectivity Clause. – This ordinance shall take effect after ten (10) days from the date of its approval and posting in three conspicuous places in the local government unit.
