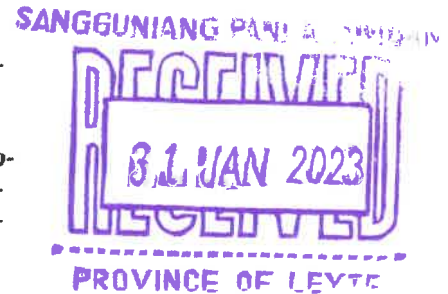

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF BUSINESS TAXES, FEES & CHARGES IN THE MUNICIPAL GOVERNMENT OF CALUBIAN, LEYTE UNTIL JANUARY 31, 2023 WITHOUT SURCHARGES OR PENALTIES .

*WHEREAS, the LCE in his letter dated Jan. 18, 2023 has asked the Sangguning Bayan to pass an ordinance extending the deadline of payment until Jan. 31, 2023 of Mun. Business Permits without penalties and surcharges;*

*WHEREAS, on July 27, 2015, the Honorable Sangguniang Bayan of Calubian, Leyte had enacted Ord. No. 2014- 02, otherwise known " An Ordinance Enacting the 2014 Revenue Code of Calubian, Leyte, as Amended " ;*

*WHEREAS, at present, people from all walks of life, are experiencing economic plight due to inflation and increase of prices of basic commodities, transportation and related items;*

*WHEREAS, under Article C. Payment of Business Taxes, Section 2C.03 . Time of Payment of the 2014 Revenue Code of Caluban provides that xxx The tax shall be paid once within the first twenty (20) days of January or in quarterly installments within the first twenty (20) day of January, April, July and October of each year. The Sangguniang Bayan may, for a justifiable reason or cause, extend the time of payment of taxes without surcharges or penalties, but only for a period not exceeding six (6) months ;*

**NOW THEREFORE**

**BE IT ORDAINED,** by the Sangguniang Bayan of Calubian, Leyte, in a session assembled, that;

**SECTION 1. TITLE.** *This Ordinance shall be known as " AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF BUSINESS TAXES, FEES & CHARGES IN THE MUNICIPAL GOVERNMENT OF CALUBIAN, LEYTE UNTIL JANUARY 31, 2023 WITHOUT SURCHARGES OR PENALTIES".*

**SECTION 2. RATIONALE OF THE ORDINANCE .** *A. Section 447 (a)(2) of R. A. 7160, otherwise known as the Local Government Code of 1991 provides that (ii) Subject to the provisions of Book II of this Code ( R. A. 7160 ) and applicable laws and upon the majority vote of all the members of the Sangguniang Bayan, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs. xxx ;*

*B. The Sangguniang Bayan of Calubian, Leyte fully considers the plight of local businessmen of the municipality to cope up, sustain and endure their means of income and livelihood amidst the economic crisis the country is facing .*

**SECTION 3. PERIOD OF EXTENSION.** *The deadline for the payment of Business Taxes, Fees and Charges in the municipal government of Calubian, Leyte due and payable on or before 20<sup>th</sup> day of January of the current year 2023, is hereby extended until January 31, 2023, without any surcharges or penalties.*



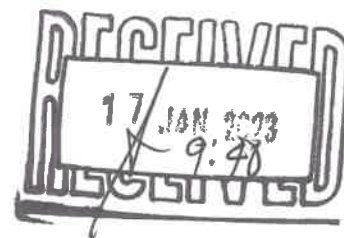
