Section 1. – Short Title – This ordinance shall be known as the "Brgy. Rizal II Reclassified TE

Section 2. — Reclassification of Lots — By virtue of this ordinance, a parcel of land measuring ten (10) hectares being a portion of Cad Lot No. 1923 covered by Tax Declaration No. 2008-04018-00094 located at Brgy. Rizal II, Babatngon, Leyte is hereby reclassified from Agricultural to Institutional area. While the remaining area of Cad Lot No. 1923 which is 1.824 sq.m. shall be reclassified from Agricultural to Residential land in classification.

<u>Section 3.</u> — Repealing Clause. — All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

Section 4. – Effectivity Clause. – This ordinance shall take effect after ten (10) days from the date of its approval and posting in three conspicuous places in the local government unit.
