AN ORDINANCE ENACTING THE SOCIAL PROTECTION INTEGRATION PROGRAM AND DEVELOPMENT CODE OF THE MUNICIPALITY OF CALUBIAN, LEYTE.

WHEREAS, the main economic justification of government provision of social protection is to redistribute income to help the poor and marginalized in society . In a developing country such as the Philippines, social protection is a consistent priority of government;

WHEREAS, social protection constitutes programs and policies that seek to reduce poverty and vulnerability to risks and enhance the social status and rights of the marginalized by promoting and protecting livelihood and employment, protecting against hazards and sudden loss of income, and improving people's capacity to manage risks";

WHEREAS, the Department of Social Welfare and Development (DSWD) , is the primary government agency that is mandated to develop, implement and coordinate social protection and povertyreduction solutions for and with the poor, vulnerable and the disadvantaged;

WHEREAS, on the part of the Local Government of Calubian, Leyte, pursuant to Section 17 (b) (iv) of R.A. 7160 is enjoined to provide xxx (iv) Social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;

WHEREAS, Section 447 (a)(5)(xiv) empowers the Sangguniang Bayan to approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, that xxx (iv) Provide for the care of paupers, the aged, the sick, persons of unsound mind, disabled persons, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age and, subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons;

**NOW THEREFORE** 

BE IT ORDAINED by the Sangguniang Bayan of Calubian, Leyte in a session assembled, that:

ARTICLE I (TITLE, RATIONALE, OBJECTVES & DEFINITION OF TERMS)

SECTION 1. TITLE. - This ordinance shall be known as "AN ORDINANCE ENACTING THE SOCIAL PROTECTION INTEGRATION PROGRAM AND DEVELOPMENT CODE OF THE MUNICIPALITY OF CALUBIAN, LEYTE".

SECTION 2. RATIONALE. -A. It is hereby declared the policy of the municipality of Calubian, Leyte to ensure the efficient and effective delivery of the basic services and facilities, that particularly xxx (iv) Provide for the care of paupers, the aged, the sick, persons of unsound mind, disabled persons, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age and, subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons:

C. The Municipal Government of Calubian, Leyte shall seek to formulate development and management policies and strategies on social protection and establish a system and mechanism that create opportunities for learning, sharing and continuous improvement of the unit's performances towards its constituents.

SECTION 3. OBJECTIVES. A. The Municipal Government of Calubian, Leyte thru its implementing offices, shall institute policies and programs that seek to reduce poverty and vulnerability to risks and enhance the social status and rights of the marginalized by promoting and protecting livelihood and employment, protecting against hazards and sudden loss of income and improving people's capacity to manage risks.

- B. The Municipal Government of Calubian, Leyte thru its primary offices and departments and in coordination with some national offices and agencies, shall likewise implement development strategies and interventions warranting an effective, responsive and accountable delivery for social services for its constituents, build capacity and adaptability to quality of life that is better maintained and sustained.
- C. The Municipal Government of Calubian, Leyte thru its primary offices and departments shall also adopts measures to enhance employment opportunities, protect the rights and welfare of workers, programs to support the minimum basic needs of the poor and provides urgent responses and mechanisms that address effects of socio-economic shocks, disaster and calamities on vulnerable groups.

SECTION 4. DEFINITON OF TERMS. - The following terms are defined in this ordinance, as follows:

- A. Social Protection constitutes policies and programs that seek to reduce poverty and vulnerability to risks and enhance the social status and rights of the marginalized by promoting and proetct8ing livelihood and employment, protecting against hazards and sudden loss of income and improving people's capacity to manage risks.
- B. Early Childhood Care and Development (ECCD) System shall refer to the full range of health, nutrition, early education and social services development programs that provide for the basic holistic needs of young children from age zero (0) to four (4) years; and to promote their optimum growth and development.
- C. Pantawid Pamilyang Pilipino Program (4Ps) is a human development measure of the national government that provides conditional cash grants to the poorest of the poor, to improve the health, nutrition and education of children -18.
- D. Supplementary Feeding Program for Children- is the provision of food in addition to the regular meals to children currently enrolled in the day care centers as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government.
- E. SOCIAL PENSION of SENIOR CITIZENS- is an additional government assistance in the amount of Five Hundred Pesos Only (P500.00) monthly stipend to augment the daily subsistence and other medical needs of indigent senior citizens, subject to a review every two years by Congress in consultation with the DSWD.
- F. Alternative Learning System (ALS) ALS Education of the Department of Education ALS is a practical option to the existing formal instruction so students can complete basic education in a mode that fits their distinct situation and needs.
- G. AICS- Assistance to Individuals in Crisis Situation- The Assistance to Individuals in Crisis Situation (AICS) is part of the DSWD's protective services for the poor, marginalized and vulnerable /disadvantaged individuals.
- H. GIP Government Internship Program- The DOLE-Government Internship Program in coordination with the LGU of Calubian, Leyte implemented this program. It provides three to six (3-6) month's internship opportunity for high school, technical-vocational, or college graduates who wants to pursue a career in public service in either local or national government.
- I. SPES The Special Program for Employment of Students is DOLE's youth employment-bridging program which aims to provide temporary employment to poor but deserving students, out-of-school youth, and dependents of displaced or would-be displaced workers during summer and/or Christmas vacation or any time of

the year to augment the family's income to help ensure that beneficiaries are able to pursue their education.

- J. Forced Evacuation means an evacuation ordered as a resort when a disaster or emergency has been declared and danger of loss of life is imminent, and conditions exist that critically imperil or endanger the lives of those in a defined area.
- K. Magna Carta for Disabled Persons Republic Act No. 7277 otherwise known as the Magna Carta for Disabled Persons was enacted for the primary reason that persons with disabilities have the same rights as other people. The measure promotes their full participation in society and integration into the mainstream of society.
- L. TUPAD Program- TUPAD or Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers is a community-based package of assistance that provides emergency employment for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed.
- M. GAD Program- The Magna Carta of Women (Republic Act No. 9710) defines Gender and Development Program (GAD) as the development perspective and process that is participatory and empowering, equitable, sustainable, free from violence, respectful of human rights, supportive of self-determination and actualization of human potentials. It seeks to achieve gender equality as a fundamental value that should be reflected in development choices and contends that women are active agents of development, not just passive recipients of development.
- N. ECCD- Early Childhood Care and Development (ECCD) System shall refer to the full range of health, nutrition, early education and social services development programs that provide for the basic holistic needs of young children from age zero (0) to four (4) years; and to promote their optimum growth and development.
- O. "Curfew hours"- refers to the hours prescribed / fixed so that no minors can be seen on the streets or roads doing business or just roaming around for their own safety and protection;
- P. "Minor" refers to any person under seventeen (17) years of age who has not been emancipated by court order.
- Q. Tree planting is the process of transplanting tree seedlings, generally for forestry, land reclamation, or landscaping purpose.
- R. VAW C- Violence against women and their children refers to any act or a series of acts committed by any persons against a woman who is his wife, former wife or against a woman with whom the person has or had sexual or dating relationship, or with whom he has a common child, or against her child whether legitimate or illegitimate, with or without the family abode, which result in or is likely to result in physical, sexual, psychological harm or suffering or economic abuse including threats of such acts, battery, assault, coercion, harassment of arbitrary deprivation of liberty.
- S. Sustainable Livelihood Program is a capability-building program of the DSWD that provides access to opportunities that increase the productivity of the livelihood assets of the poor, vulnerable, and marginalized communities, in order to improve their socioeconomic well-being.
- T. Vaccination is a simple, safe, and effective way of protecting people against harmful diseases, before they come into contact with them.
- U. Persons with Disability ( PWD ) means a person that suffers from long term physical, mental, intellectual or sensory impairments which upon interaction with various barriers, may hinder his or her full and effective participation in society on an equal basis with others.
- V. Motorcycle helmets- all motorcycle riders, including drivers and back riders, shall at all times wear standard protective motorcycle helmets while driving, whether long or short drives, in any type of road and highway.
- W. Solo Parent- a person with valid solo parent ID. Alternately, an affidavit of circumstances of solo parenthood (e. g. abandonment, death, imprisonment or incapacity of the other parent) along with the birth certificate of the applicant's child with an age of seventeen (17) years or below.
- X. Maternal and Child Health Care Program- includes the total packages of services provided to mothers and children. For the mother from prenatal, during delivery, up to the postpartum period; for the children, it will include babies from birth up to one (1) year of age.
- Y. Coastal Shores Clean up or Beach Clean up- is the process of removing solid litter, dense chemicals, and organic debris deposited on a beach or coastline by the tide, local visitors, or tourists. Humans pollute beaches with materials such as plastic bottles and bags, plastic straws, fishing gear, cigarette filters, six pack rings, surgical masks and many other items that often lead to environmental degradation.

AA. Cash for Work is a short term intervention to provide temporary employment to distressed/displaced individuals by participating in or undertaking preparedness, mitigation, relief, rehabilitation or risk reduction projects and activities in their communities or in evacuation centers.

# ARTICLE II ( COMPONENTS OF SOCIAL PROTECTION PROGRAMS & SERVICES )

SECTION. 5. COMPONENTS OF SOCIAL PROTECTION PROGRAMS & SERVICES - The following are considered Social Protection Programs & Services in the municipality of Calubian, Leyte in coordination with the concerned national agencies and local offices, which ought to be served and delivered towards its clientele, i.e. the local residents, to wit:

- A. Social Insurance. These are programs that aim to mitigate income risk.
- 1.) Social Pension of Indigent Senior Citizens- is one of the provisions stated under Section 5 Republic Act 9994 otherwise known as the Expanded Senior Citizens Act of 2010.

Objectives: Social Pension is an additional government assistance in the amount of Five Hundred Pesos Only (P500.00) monthly stipend to augment the daily subsistence and other medical needs of indigent senior citizens, subject to a review every two years by Congress in consultation with the DSWD.

Who are eligible? As defined in Section 3 of Republic Act 9994, indigent senior citizens refer to any elderly who is:

- a. Frail, sickly or with disability;
- b. Without pension; and
- c. No permanent source of income, compensation or financial assistance from relatives to support is/her basic needs.
- 2.) The Pantawid Pamilyang Pilipino Program (4Ps) is a human development measure of the national government that provides conditional cash grants to the poorest of the poor, to improve the health, nutrition and education of children 0-18.

The LGU of Calubian, Leyte supports the implementation of this 4 Ps in the municipality as spearheaded by the lead government agency, the Department of Social Welfare & Development (DSWD). The 4Ps also helps the Philippine government fulfill its commitment to the Millennium Development Goals, specifically in eradicating extreme poverty and hunger, in achieving universal primary education, in promoting gender equality, in reducing child mortality and in improving maternal health care.

Complementing the 4 Ps is the Modified Conditional Cash Transfer (MCCT) Program, which caters to families in need of Special Protection. These include street families, itinerant indigenous families, families displaced by natural and man -made disasters, families with a person with disability (PWD), child labors, children in conflict with the law, and families with members with terminal disease and victims of human trafficking.

B. Labor Market Interventions: These are measures to enhance employment opportunities and protect the rights and welfare of workers.

1.) Implementation of KALAHI- CIDSS follow- up project and other community -driven development projects .

This is implemented by the Office of the DSWD in coordination with the Barangay Government where the KALAHI- CIDSS Project is implemented in the barangay, with funds shared by counterparting scheme. Kapit-Bisig Laban sa Kahirapan – Comprehensive and Integrated Delivery of Social Services (Kalahi-CIDSS) – National Community-Driven. Development Project (KC-NCDDP) is one of the Philippine government's. poverty alleviation programs being implemented by the Department of. Social Welfare and Development (DSWD).

#### 2.) Implementation of TUPAD Program

TUPAD or Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers is a community-based package of assistance that provides emergency employment for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed. This program is a program initiated by the Department of Labor and Employment with the coordination of LGU of Calubian, Leyte thru its Public Service Employment Office (PESO).

Agro-forestry community projects, such as tree planting, seedling preparation, and reforestation.

#### 3.) GIP - Government Internship Program

The DOLE- Government Internship Program ( GIP) in coordination with the LGU of Calubian, Leyte implemented this program. It provides three to six (3-6) month's internship opportunity for high school, technicalvocational, or college graduates who wants to pursue a career in public service in either local or national government.

#### 4.) SPES- The Special Program for Employment of Students

SPES is DOLE's youth employment-bridging program which aims to provide temporary employment to poor but deserving students, out-of-school youth, and dependents of displaced or would-be displaced workers during summer and/or Christmas vacation or any time of the year to augment the family's income to help ensure that beneficiaries are able to pursue their education.

The Municipal Government of Calubian, Leyte thru the Public Service Employment Office ( PESO) fully implemented this program in coordination with the Department of Labor & Employment (DOLE.) The following are the Qualifications to avail the SPES Program:

- Students or out-of-school youth (OSY) at least 15 but not more than 30 years of age
- Combined net income after tax of parents, including his/her own, if any, does not exceed the regional poverty threshold
- Students must have obtained a passing general weighted average (GWA)
- OSY must be certified by the local Social Welfare and Development Office (SWDO) as OSY.

#### 5.) Sustainable Livelihood Program (SLP)

The Sustainable Livelihood Program (SLP) - is a capability-building program of the DSWD that provides access to opportunities that increase the productivity of the livelihood assets of the poor, vulnerable, and marginalized communities, in order to improve their socio-economic well-being.

The LGU of Calubian, Leyte likewise supports this program to give and enhance the livelihood opportunities and productivity of marginalized workers in the locality and improve their socio- economic well being. The SLP aims also to help poor and vulnerable families, low-income workers, solo parents, and other individuals belonging to the marginalized sector by providing them with livelihood interventions and programs.

#### 6.) Cash for Work Program

Cash for Work is a short term intervention to provide temporary employment to distressed/displaced individuals by participating in or undertaking preparedness, mitigation, relief, rehabilitation or risk reduction projects and activities in their communities or in evacuation centers. Work areas/programs are identified by the community under the leadership of local leaders. In exchange for the work rendered, program recipients are provided with cash to meet their requirement for food and other basic necessities. Cash for Work may be undertaken before, during or after the occurrence of any disaster whether natural or human induced.

The LGU of Calubian, Leyte supports the implementation of the Cash for Work of the Department of Social Welfare and Development Office (DSWD).

7.) Recognition of CSOs, civil society groups or non-government organizations ( NGOs) as active partners in the development of the town and residents.

The municipal government recognizes the role and participation of CSOs or non- government organizations (NGOs) as active partners in the development of the town and residents.

C. Social Welfare: These are preventive and developmental interventions which support the minimum basic needs of the poor.

#### 1.) ECCD - Early Childhood Care and Development (ECCD) System

ECCD - Early Childhood Care and Development (ECCD) System shall refer to the full range of health, nutrition, early education and social services development programs that provide for the basic holistic needs of young children from age zero (0) to four (4) years; and to promote their optimum growth and development. support thereof, the Sangguniang Bayan of Calubian, Leyte enacted an Ordinance No. 2020-07 entitled: "AN ORDINANCE RECOGNIZING THE AGE FROM ZERO (0) TO EIGHT (8) YEARS AS THE FIRST CRUCIAL STAGE OF EDUCATIONAL DEVELOPMENT AND STRENGTHENING THE EARLY CHILDHOOD CARE AND DEVELOPMENT SYSTEM IN THE MUNICIPALITY OF CALUBIAN, LEYTE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES."

#### 2.) Supplementary Feeding Program complements ECCD

Supplementary Feeding Program for Children- is the provision of food in addition to the regular meals to children currently enrolled in the day care centers as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government. The LGU of Calubian, Leyte likewise supports this program for the children as a supplement to come up with good nutrition and health for them.

#### 3.) Assistance to Individuals in Crisis Situation (AICS)

The Assistance to Individuals in Crisis Situation ( AICS ) is part of the DSWD's protective services for the poor, marginalized and vulnerable/disadvantaged individuals.

The LGU of Calubian, Leyte fully supports this program in coordination with the Department of Social Welfare & Development (DWD). The Assistance to Individuals in Crisis Situation is a social safety net or a stop-gap mechanism to support the recovery of individuals and families from unexpected crisis such as illness or death of a family member, and other crisis situations.

The Crisis Intervention Unit (Office of the Mun. Social Welfare & Development Office) is a special unit operating as an action center to immediately respond to cases of individuals and families in crisis situations. It provides integrated services such as immediate rescue/ and protection provision of direct financial and material assistance, augmentation during disaster and referrals for immediate medical, legal, psycho-social services. The immediate response to cases of individuals and families in crisis situation is through the provision of financial and material assistance.

#### 4.) ALS Education

Alternative Learning System is a practical option to the existing formal instruction so students can complete basic education in a mode that fits their distinct situation and needs.

The LGU of Calubian, Leyte fully supports this Program in coordination with the Department Education (DEPED), especially Out of School Youth attain and or complete his/ her education by an alternative modules/ manner until college.

#### 5.) Maternal & Child Health Care & Benefit Program.

The municipal government of Calubian, Leyte through its lead office, the Rural Heath Unit of Calubian, Leyte is committed to provide quality maternal and child health care, such: providing them the basic package of needed services and skilled birth attendant in the Calubian Rural Health Unit Maternity and Child Health Clinic. This is supported by the passage of Ord. No. 2012-01 entitled: An Ordinance Prescribing the Rate of Service Fees & Charges ordered by the newly completed Calubian Rural Health Unit's Maternity Care & Child Health Clinic, its operations as well as the Giving of Incentives to Skilled Health Professional of the municipality of Calubian, Leyte.

Section 4 B. of Ord. No. 2012- 01 provides that Service Clients with our without PHILHEALTH CARDS are exempted from payment of services charges in the Calubian Rural Heath Unit's Maternity & Child Health Clinic, provided said obstetric patients is duly certified by the Mun. The LGU of Calubian, Leyte likewise enacted Ord. No. 2017-03 entitled: AN ORDINANCE ADOPTING THE 2017 MATERNAL & CHILD HEALTH CARE CODE OF CALUBIAN, LEYTE AND FOR OTHER PURPOSES. The ordinance primarily includes the total packages of services provided to mothers and children. For the mother from prenatal, during delivery, up to the postpartum period; for the children, it will include babies from birth up to one (1) year of age.

6.) Immunization Program on COVID- 19 vaccines and other essential vaccines for children & adults.

The municipal government of Calubian, Leyte through its lead office, the Rural Heath Unit of Calubian, Leyte and the Department of Health is committed to provide Immunization Program on COVID-19 vaccines and other essential vaccines for children & adults for their heath, well - being & protection.

#### 7.) Magna Carta for Disabled Persons

Republic Act No. 7277 otherwise known as the Magna Carta for Disabled Persons was enacted for the primary reason that persons with disabilities have the same rights as other people. The measure promotes their full participation in society and integration into the mainstream of society.

#### 8.) R.A. 8972 or the Solo Parent's Welfare Act

R. A. 8972 or the Solo Parent's Welfare Act provides for benefits and privileges to solo parents and their children. It aims to develop a comprehensive package of social development and welfare services for solo parents and their children to be carried out by the Department of Social Welfare and Development (DSWD), as the lead agency, various government agencies including NSO and other related NGOs.

The Municipal Government of Calubian Leyte, thru its lead agency, the Office of the Mun. Social Welfare & Development fully supports the implementation Republic Act No. R.A. No. 8972 or the Solo Parent's Welfare Act. The comprehensive package of programs/services for solo parents includes livelihood, self-employment and skills development, employment-related benefits, psychosocial, educational, health and housing services.

#### 9.) Gender And Development (GAD) Program

The Magna Carta of Women (Republic Act No. 9710) defines Gender and Development Program (GAD) as the development perspective and process that is participatory and empowering, equitable, sustainable, free from violence, respectful of human rights, supportive of self-determination and actualization of human potentials. It seeks to achieve gender equality as a fundamental value that should be reflected in development choices and contends that women are active agents of development, not just passive recipients of development.

The Municipal Government of Calubian, Leyte had been supported the GAD Program by virtue of its Mun,. Ord. No. 2017- 07 entitled:" An Ordinance Providing for a Gender and Development Code in the municipality of Calubian, Leyte ", The municipal ordinance is aimed to mainstreaming women's concern, ensure fundamental equality before the law, open an whole arena for active participatory role in the development process, for equal rights and opportunities. Gender and Development (GAD) focuses on Gender Mainstreaming or a strategy for:

- i. making women's as well as men's concerns and experiences an integral dimension of the design, implementation, monitoring, and evaluation of policies, programs and projects in all social, political, civil, and economic spheres so that women and men benefit equally.
- ii. assessing the implications for women and men of any planned action, including legislation, policies or programs in all areas and at all levels.

D. Social Safety Nets- Urgent Responses & mechanisms that address effects of socio- economic shocks, disaster and calamities of vulnerable groups.

#### 1.) Water Facility Services & Connections of Consuming Residents

The Calubian Water Service Administration (CAWASA) was created pursuant to Ord. No. 2008-02 entitled: "An Ordinance establishing the Calubian Waterworks & Sewerage System". The same helps to make water easy & readily available to local residents for home consumption at a lesser cost, and an income generation on the part of Municipal Government of Calubian, Leyte.

#### 2.). Motorcycle Helmet Law

The Municipal Government of Calubian, Leyte fully supports REPUBLIC ACT NO. 10054 also known as "AN ACT MANDATING ALL MOTORCYCLE RIDERS TO WEAR STANDARD PROTECTIVE MOTORCYCLE HELMETS WHILE DRIVING AND PROVIDING PENALTIES THEREFOR", Thus, in support thereof, the Sangguniang Bayan of Calubian, Leyte enacted Ord. No. 2013-02: Motorcycle Helmet Ordinance.

The Motorcycle Helmet Ordinance of Calubian was designed to secure and safeguard its residents, particularly the operators or drivers of motorcycles and their passengers, from the ruinous and extremely injurious effects of fatal or life threatening accidents and crashes. Towards this end, it shall pursue a more proactive and preventive approach to secure the safety of motorists, their passengers and pedestrians at all times through the mandatory enforcement of the use of standard protective motorcycle helmet.

#### 3.) Environmental Safety & Protection and Campaign against Illegal Fishing

The Ord. No. 2020- 10 entitled: "AN ORDINANCE ENACTING THE 2020 ECOLOGICAL SOLID WASTE MANAGEMENT CODE OF THE MUNICIPALITY OF CALUBIAN, LEYTE" is designed to ensure the proper segregation, collection, transport, storage, treatment and disposal of solid waste through the formulation and adoption of the best environmental practice in ecological waste management in the municipality.

The 2015 Fishery Ordinance of Calubian, Leyte was passed, one objective of which is to implement the municipality's campaign against illegal fishing and boost and enhance productivity & livelihood of local fisher folks from the seawaters of Calubian.

The Ord. No. 01, s. 1997 entitled: The Calubian Fish Sanctuary Ordinance was enacted in order to conserve the coral reefs of the municipality of Calubian, Leyte aimed for the preservation of the natural breeding grounds and habitat of fish supply for the growing residents of Calubian, Leyte.

The Ord. No. 2017- 01 entitled: "AN ORDINANCE REGULATING THE SALE AND USE OF FIRECRACKERS, FIREWORKS AND ANY OTHER PYROTECHNIC DEVICES IN THE MUNICIPALITY OF CALUBIAN, LEYTE, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF", is designed to ban the use of dangerous firecrackers, fireworks and pyrotechnics that would endanger loss of properties and even loss of lives.

#### 4.) Disaster Preparedness Program.

The LGU of Calubian, Leyte enforces Disaster Preparedness Program and Implementation of forced evacuation as a social protection strategy when a disaster or emergency has been declared and danger of loss of lives are imminent within their area of jurisdiction. In line with this, the Sangguniang Bayan of Calubian, Leyte enacted Ord. No. 2022-10 entitled: "AN ORDINANCE IMPLEMENTING FORCED EVACUATION AS A RESORT WHEN A DISASTER OR EMERGENCY HAS BEEN DECLARED IN THE MUNICIPALITY OF CALUBIAN, LEYTE AND DANGER OR LOSS OF LIVES BECOMES IMMINENT, PROVIDING PENALTIES THEREOF AND FOR OTHER PURPOSES."

5.) Curfew on Minors and Protection of Minors from Exploitation, Pornography & Sexual Abuses.

Curfew hours" refers to the hours prescribed / fixed so that no minors can be seen on the streets or roads doing business or just roaming around for their own safety and protection.

The LGU of Calubian, Leyte fully supports this Program in coordination with the Department Social Welfare & Development & the Calubian National Police, fully support this intervention. Thus enacted a Municipal Ordinance entitled: An Ordinance imposing curfew of minors below 18 yrs. old in Calubian pursuant to Article 139 of PD 603, otherwise known as "The Child & Youth Welfare Code of the Philippines".

Likewise, the LGU of Calubian, Leyte passed Ord. No. 2008-01 entitled: Regulation on Internet Cafes, Computer Shops, Billiard Centers, Videokes & Sing-along, the objective of which is to address fundamental concerns in efforts at promoting the general welfare of the youth generation and help them evade from any forms of illegal vices and surfing into pornographic or lewd materials, violent content, sexual exposures or exhibitions and those that provoke prostitution.

#### 6.) VAW C- Violence against women and their Children Program

VAW C- Violence against women and their children - refers to any act or a series of acts committed by any persons against a woman who is his wife, former wife or against a woman with whom the person has or had sexual or dating relationship, or with whom he has a common child, or against her child whether legitimate or illegitimate, with or without the family abode, which result in or is likely to result in physical, sexual, psychological harm or suffering or economic abuse including threats of such acts, battery, assault, coercion, harassment of arbitrary deprivation of liberty.

The municipal government of Calubian, Leyte fully supports the implementation of R. A. 9262, otherwise known as the Anti – Violence Against Women and their Children Act of 2004, in coordination with the concerned national and local government agencies into the municipality.

A Women and Children's Welfare Desk shall be established under the Municipal Social Welfare & Development Office and in all barangays, to address the problems related women and children.

In compliance with Article V of Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, and its Implementing Rules and Regulations and DOLE Department Order No. 53-03, series of 2003 (Guidelines for the Implementation of a Drug-Free Workplace Policies and Programs for the Private Sector), the Sangguniang Bayan of Calubian, Leyte hereby enacted Ordinance No. 2020- 08 - AN ORDINANCE INSTITUTIONALIZING A DRUG FREE WORKPLACE IN ALL GOVERNMENT OFFICES IN THE MUNICIPAL GOVERNMENT OF CALUBIAN, LEYTE AND APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF."

#### 8.) Anti- Smoking Campaign Program

No. 2018- 04 of Calubian, Leyte entitled : "AN ORDINANCE PROHIBITING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS IN CERTAIN PLACES IN THE MUNICIPALITY OF CALUBIAN, LEYTE, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

The aforementioned ordinance supports R.A. No. No. 8749 (Philippine Clean Air Act of 1991) and recognizes that tobacco consumption and exposure to tobacco smoke cause death, disease and disability and leads to devastating health, social, economic and environmental consequences; and places burdens on familis, on the poor and on national and local health system.

#### 9. ) Children Welfare & Development Code

The municipal government of Calubian, Leyte fully implemented this program thru its newly enacted Ord. No. 2022-03 of Calubian, Leyte entitled: "CHILDREN'S WELFARE & DEVELOPMENT CODE OF 2022 OF THE MUNICIPALITY CALUBIAN, LEYTE". It's primary objective is It is the policy of the Municipality of Calubian, Leyte to provide special protection to all Children from all forms of abuses, neglect, cruelty, exploitation and discrimination. Likewise, to intervene in behalf of the child when the parents, guardian, teachers , persons having care or custody of the child fails to protect the child against abuses, exploitation and discrimination. And furthermore, it is the policy of this municipality, to protect and rehabilitate children gravely threatened or endangered by circumstances that will affect their survival and normal development and over which they have no control.

#### 10.) Tree Planting Program

Tree-planting is the process of transplanting tree seedlings, generally for forestry, land reclamation, or landscaping purpose. WHY ARE TREES IMPORTANT TO THE ENVIRONMENT? Trees help clean the air we breathe, filter the water we drink, and provide habitat to over 80% of the world's terrestrial biodiversity. Our Forests provide jobs to over 1.6 billion people, absorb harmful carbon from the atmosphere, and are key ingredients in 25% of all medicines.

Trees play a key role in capturing rainwater and reducing the risk of natural disasters like floods and landslides. Their intricate root systems act like filters, removing pollutants and slowing down the water's absorption into the soil. This process prevents harmful waterslide erosion and reduces the risk of over-saturation and flooding.

The municipal government of Calubian, Leyte fully supports Tree Planting Program in the municipality and as such, the Sangguniang Bayan of the municipality shall declare an Annual Tree Planting Program every 30th May of every year and onwards.

#### 11.) Coastal Shores Clean up

Coastal Shores Clean up or Beach Clean up- is the process of removing solid litter, dense chemicals, and organic debris deposited on a beach or coastline by the tide, local visitors, or tourists. Humans pollute beaches with materials such as plastic bottles and bags, plastic straws, fishing gear, cigarette filters, six pack rings, surgical masks and many other items that often lead to environmental degradation. Every year hundreds of thousands of volunteers comb beaches and coastlines around the world to clean this debris. These materials are also called "marine debris" or marine pollution" and their quantity has been increasing due to anthropocentric activities. These" pollutants may harm marine life and ecology, human health, and coastal tourism.[3] Hartley et al.'s study shows that environmental education is important to eliminate many beach pollutants on beaches and the marine environment.

The municipal government of Calubian, Leyte fully supports Coastal Shores Clean up in the costal shores of municipality and as such, the Sangguniang Bayan of the municipality shall declare a Coastal Shores Clean up every \_semester , specifically April 30th and Oct. 10th of every year and onwards.

#### 12.) Mangrove Restoration & Rehabilitation Program

Rehabilitated and restored mangrove ecosystems have important ecological, economic, and social values for coastal communities. Although a sine qua non of successful mangrove rehabilitation or restoration projects is accurate attention to local hydrology and basic biology of mangrove trees and their associated fauna, their longterm success depends on far more axes, each with their own challenges. Rehabilitation projects: are planned, designed, executed, and managed by people with diverse backgrounds and different scientific and socio-political agendas; need to be responsive to these multiple stakeholders and agents who hold different values; are often influenced by laws and treaties spanning local to international scales; and must be able to adapt and evolve both geo-morphologically and socioeconomically over decades-to-centuries in the context of a rapidly changing climate.

The municipal government of Calubian, Leyte fully supports The municipal government of Calubian, Leyte fully supports Coastal Shores Clean up in the costal shores of municipality and as such, the Sangguniang Bayan of the municipality shall declare a Mangrove Tree Panting & Restoration Activity every 30th of May of every year onwards.

#### ARTICLE III (FUNDING & APPROPRIATIONS)

SECTION 6. FUNDING & APPROPRIATIONS - The amount needed for the initial implementation of this Ordinance shall be charged against the current year's appropriations of the Office of the Mun. Social Welfare & Development Officer under its MOOE Fund. Thereafter, an allocation or sums as may be necessary for the continued implementation of all the programs and services reflected in this Ordinance shall be included in the Annual Budget and or in the Annual Investment Program ( AIP) of the municipality.

#### ARTICLE IV (FINAL PROVISIONS)

SECTION 7. REPEALING CLAUSE - All ordinances or resolutions, local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 8. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

SECTION 9. EFFECTIVITY- This Ordinance shall take effect immediately upon approval from the Honorable Sangguniang Panlalawigan of Leyte.

The undersigned Chairmen, Vice Chairmen & Members of the Committee on Rules, Laws & Privileges & Committee on Human Resource Development respectfully submit to the Honorable August Body, the following committee findings:

- 1. The proposed Ord. No. 2022- 12 is known as ""AN ORDINANCE ENACTING THE SOCIAL PROTECTION INTEGRATION PROGRAM AND DEVELOPMENT CODE OF THE MUNICIPALITY OF CALUBIAN, LEYTE";
- 2. The Local Chief Executive in his letter dated Nov. 14, 2022 together with the letter of the MSWDO ( Mrs. Corazon D. Lerios) addressed to the Sangguniang Bayan of the municipality had requested for the enactment of an Ordinance that would give emphasis on using Social Protection, likewise its polices and laws for LGU to address the needs of the marginalized sector;
- 3. The Honorable Sangguniang Bayan had been cognizant of the request of the Local Chief Executive hence proposed an ordinance entitled: AN ORDINANCE ENACTING THE SOCIAL PROTECTION INTEGRATION CODE OF THE MUNICIPALITY OF CALUBIAN, LEYTE". PROGRAM AND DEVELOPMENT
- 4. Section 17 (a) of R. A. 7160, otherwise known as the Local Government Code of 1991 provides that xxx Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein. Xxx (b) Such basic services and facilities include, but are not limited to, the following: (2) For a municipality: xxx (iv) Social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; communitybased rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, & victims of drug abuse; livelihood & other pro-poor projects; nutrition services, xxx;
- 5. Under this proposed ordinance, the Municipal Government of Calubian, Leyte thru its primary offices and departments and in coordination with some national offices and agencies, shall likewise implement development strategies and interventions warranting an effective, responsive and accountable delivery for social services for its constituents, build capacity and adaptability to quality of life, that is better maintained and sustained;
- 6. Under this proposed ordinance, the Municipal Government of Calubian, Leyte thru its primary offices and departments shall also adopt measures to enhance employment opportunities, protect the rights and welfare of workers, programs to support the minimum basic needs of the poor and provides urgent responses and mechanisms that address effects of socio-economic shocks, disaster and calamities on vulnerable groups;
- 7. The proposed ordinance has emphasized the need to implement social protection services & development, all of which are integrated into one, so that main objectives and goals of which are implementable for the welfare and benefits of all concerned in the municipality of Calubian, Leyte be undertaken;
- 8. Since the proposed ordinance does not have any penal provision therein , the same is no longer subject for a Public Hearing; and
