ORDINANCE NO. 2023-06

AN ORDINANCE AMENDING SECTION 7 OF MUNICIPAL ORDINANCE NO. 2018-03, ENTITLED "AN ORDINANCE IMPLEMENTING THE MATERNAL CARE INCENTIVE PROGRAM (MCIP) OF ALBUERA, LEYTE"

Introduced by: HON. MARY JANE B. CAGULA

BE IT ORDAINED by the Sangguniang Bayan of Albuera, Leyte in Session assembled, to amend Section 7 of Municipal Ordinance No. 2018-03, entitled "An Ordinance Implementing the Maternal Care Incentive Program (MCIP) of Albuera, Leyte, as follows:

SECTION 1. Amendment. Section 7 of Municipal Ordinance No. 2018-03, shall now read as follows:

Section 7

I. PHILHEALTH Reimbursement for MCP

A. Maternity Care Package; (Php. 8,000.00/client)

- 50% for operating costs (Php. 4,000.00)
- 50% for Personnel PF/Incentives (Php. 4,000.00)
  - Handling Personnel - (Php. 2,000.00) or 50%
  - Assisting Personnel - (Php. 650.00) or 16.25%
  - Staff involved in the delivery of service at birthing facility (Midwives, Nurses, MHO, and Med Tech) - (Php. 750.00) or 18.75%
  - Staff not involved in delivery services at the delivery room such as RSI, Dentist, Dental Aid, clerks, utility workers, and others - (Php. 600.00) or 15%
    - ~ Job Order (JO) Midwives' share is equal to that of Regular Midwives' share.

C. Family Planning

a. IUD insertion; (Php. 2,000.00/client)

- 50% for operating costs (Php. 1,000.00)
- 50% for Personnel PF/Incentives (Php. 1,000.00)
  - Service Provider - (Php. 650.00) or 65%
  - RHM in charge of patient/client - (Php. 350.00) or 35%

b. IMPLANON NTX Insertion; (Php. 3,000.00/client)

- 50% for operating costs (Php. 1,500.00)
- 50% for Personnel PF/Incentives (Php. 1,500.00)
  - Service Provider - (Php. 750.00) or 50%
  - RHM in charge of patient/client - (Php. 525.00) or 35%
  - To be shared by staff who assisted in the operating procedure - (Php. 225.00) or 15%

**TB DOTS;** (Php. 4,000.00/client)

- 50% for operating costs (Php. 2,000.00)
- 50% for Personnel PF/Incentives (Php. 2,000.00)
  - MHO - (Php. 600.00) or 30%
  - NTP Coordinator – (Php. 300.00) or 15%
  - Medical Technologist) – (Php. 300.00) or 15%
  - Nurse Non-coordinator – (Php. 300.00) or 15%
  - RHM in charge – (Php. 300.00) or 15%
  - Treatment Partner – (Php. 200.00) or 10%

**Section 2. Repealing Clause.** The provisions of the previous Ordinance, or all other Ordinances enacted by the Sangguniang Bayan of Albueria, Leyte which are inconsistent with this decree are hereby repealed & modified accordingly.

**Section 3. Date of Effectivity.** This amendatory act shall take effect after fifteen (15) days following the completion of the publication & posting thereof as required by law.


