

Provided, That, All the requisites are duly complied with. Provided, That, pursuant to DILG Opinion No. 22, S. 2020, dated January 31, 2020, citing the Supreme Court Decision in the case of "Chamber of real Estate and Builders Association, Inc. (CREBA) v. the Secretary of Agrarian Reform (G.R. No. 18 3409)", reclassification alone will not suffice to use the agricultural lands for other purposes. CONVERSION is needed to change the current use of reclassified agricultural lands".

Be it enacted by the Sangguniang Bayan of the Municipality of Bayangon, Leyte in session assembled:

PROVINCE OF LEYTE

Section 1. – Short Title – This ordinance shall be known as the "Sitio Magsaigad, Brgy. District 1 Reclassified Ordinance" in the Municipality of Babatngon, Leyte.

Section 2. — Reclassification of Lot — By virtue of this ordinance, a portion of Lot 3-G, Psd 08-020529-D measuring one hundred (100) square meters covered by Tax Declaration No. 2008-04001-00603, located at Sitio Magsaigad, Brgy. District 1, Babatngon, Leyte is hereby reclassified from Agricultural to Commercial Land.

<u>Section 3.</u> – Repealing Clause. – All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

Section 4. – Effectivity Clause. – This ordinance shall take effect after ten (10) days from the date of its approval and posting in three conspicuous places in the local government unit.
