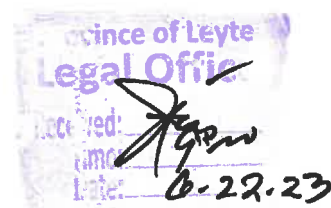



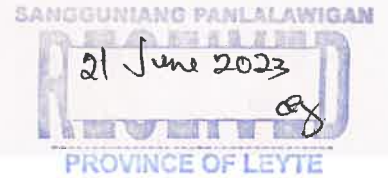

**SECTION 1. TITLE.** – This ordinance shall be known as the Authority of the Municipal Mayor and the Presiding Officer of the Sangguniang to use savings for augmentation in accordance with the Local Government Code of 1991.

**SECTION 2. USE OF SAVINGS AND AUGMENTATION.** – Under Section 336 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Governor/Mayor and/or the Presiding Officer of the Sanggunian is/are authorized to augment any item/s in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

**SECTION 3. PRIORITY IN THE USE OF PERSONAL SERVICES SAVINGS.** Priority shall be given to the personnel benefits of local employees in the use of Personal Services savings.




