

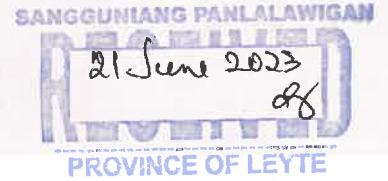



SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.






