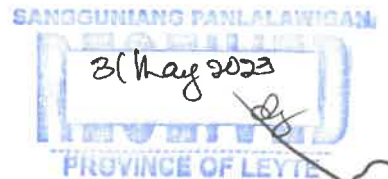

“AN ORDINANCE CREATING AND ESTABLISHING A BLOOD SERVICE FACILITY (BSF) IN THE CITY OF BAYBAY, AND FOR OTHER PURPOSES”

PREFATORY STATEMENT

Whereas, the City of Baybay is mandated under the Local Government Code to provide the best health service to its constituents and the communities within its territorial jurisdiction;

Whereas, the expansion of the health services of the city that includes the Baybay City Immaculate Conception Hospital (BCICH), Baybay City Medical Diagnostic and Dialysis Center (BCMDDC) and the outpatient units of the City Health Center and the BCICH, needs a consistent and safe supply of blood, which presently requires five hundred (500) units of blood annually and is expected to reach 1,500 units in the next three (3) years to serve its constituency;

Whereas, there is a need to establish a blood service facility to address the growing need of blood supply in the city;

Now therefore, on motion of SP Member Dr. Fulton Ike C. Arradaza duly seconded by the majority SP members present,

Be it Ordained, by the 6th Sangguniang Panlungsod, this city, in its 17th Regular Session assembled on May 4, 2023, as hereby is adopted, to wit:

Section 1. Title. This ordinance shall be known as **“An Ordinance Establishing a Blood Service Facility in the City of Baybay and for Other Purposes.”**

Section 2. Definition of Terms. These terms used in this ordinance shall have this meaning:

1. Blood Service Facility (BSF) – a health service facility that collects, stores, and distribute blood units to its clientele for a fee.
2. Blood Compatibility Testing – is a procedure conducted in a medical laboratory to identify potential incompatibilities between blood group systems during blood transfusion.

3. TTI – Transfusion-Transmitted Infection such as HIV (Human Immune Deficiency Virus), Hepatitis Virus, and Syphilis
4. Phlebotomist – a trained person who draws blood for tests, transfusions, research and blood donations.
5. BSF Revenues – computed as the number of blood units served multiplied by the fee.

Section 3. Functions of the BSF. The primary functions of the BSF are the following:

1. Storage, issuance, transport and distribution of whole blood and packed red blood cells;
2. Collection of blood (mobile or facility-based) from qualified voluntary donors;
3. Transport of blood to DOH-BC for testing and processing, and if the facilities warrant, conduct testing of blood components upon prior approval by the Philippine Blood Coordinating Council (PBCC)
4. Conduct bloodletting activities to collect more blood from voluntary donors for storage

Section 4. Fees. The fee a patient shall pay in accessing a unit of blood from the BSF is One Thousand Eight Hundred Pesos (P1,800.00). Patients who are entitled to discounts as provided for by law and ordinances shall continue to enjoy the benefits given to them. All fees collected shall be remitted to the City Treasurer's Office and deposited in the general fund.

Section 5. Operational Supervision. The supervision and control of the BSF shall be exercised by the City Health Office (CHO). Its budget, personnel, programs and projects, formulation of new systems, processes, and procedures shall be reviewed by the CHO before its submission for approval to the City Mayor. Upon approval of this ordinance, the CHO shall formulate the processes in conducting blood collection, whether mobile or facility-based, and the steps and documentation a patient need to access blood from the BSF.

Section 6. Location. A new building for the BSF shall be erected inside the Super Health Center situated at the former location of the Western Leyte Provincial Hospital.

Section 7. Personnel Complement. The required personnel complement of the BSF in order for the facility to deliver its current and future function is sixteen (16) consisting of the following;

1. 1 - Medical Technologist III with salary grade 18,
2. 3 - Medical Technologist II with salary grade 15
3. 5 - Medical Technologist I with salary grade 11
4. 2 - Laboratory Technician II with salary grade 8
5. 2 - Laboratory Aide II with salary grade 4
6. 2 - Utility Worker I with salary grade 1
7. 1 - Nurse I with salary grade 11.

However, for its initial operation as a blood collecting unit/blood station, the BSF requires a minimum of three (3) Medical Technologist, one (1) Nurse, and two (2) Laboratory Technician Aide.

Section 8. Appropriation. Upon the effectivity of this ordinance, all expenses for the establishment, facilities, equipment, salaries and wages, regulatory fees and other operational expenses of the BSF shall be included in the City's annual budget sourced

from the annual National Tax Allotment (NTA) received by the city in accordance with existing laws, government accounting and auditing rules and regulations.


Section 9. Separability Clause - If for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

Section 10. Repealing Clause - All ordinances, rules, and regulations or parts thereof in conflict with this Ordinance are hereby repealed, provided that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.

Section 11. Effectivity Clause - This ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.





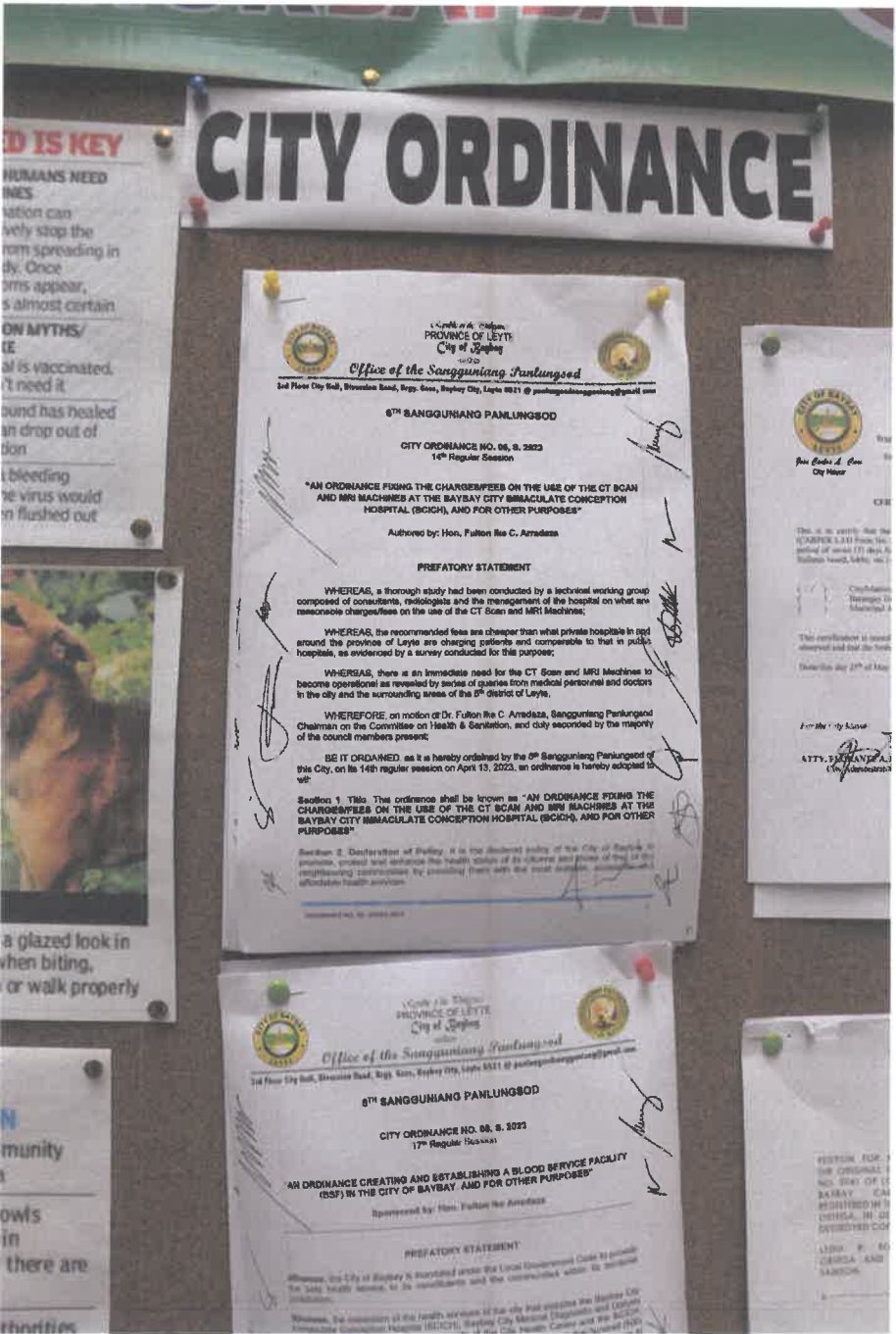
