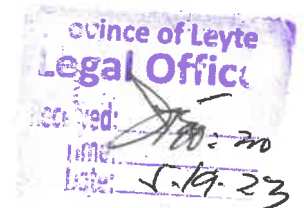

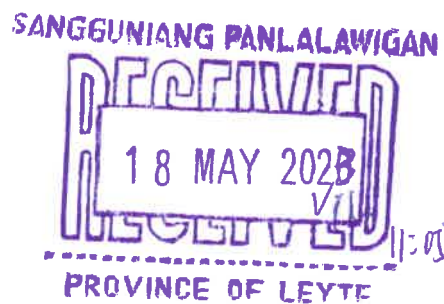

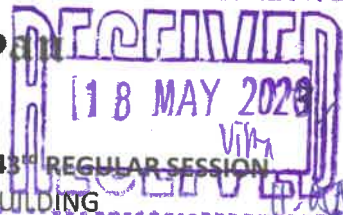

ORDINANCE NO. 3, Series of 2023

ORDINANCE ABOLISHING THE PLANTILLA POSITION OF VETERINARIAN UNDER THE MUNICIPAL AGRICULTURE OFFICE (MAO)

WHEREAS, Section 76 of Republic Act 7160 states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability";

NOW THEREFORE, be it resolved, as it is hereby resolved that in session assembled, the Sangguniang Bayan of the Municipality of Capoocan, Leyte, enact the following:

Section 1. The PLANTILLA POSITION of VETERINARIAN under the MUNICIPAL AGRICULTURE OFFICE (MAO) is hereby ABOLISHED.

Section 2. Repealing Clause. Any ordinance found inconsistent hereof, in whole or in part, is hereby repealed or modified accordingly.

Section 3. Effectivity. This ordinance shall take effect immediately upon approval.


