The Leyte III Electric Cooperative, Inc. (LEYECO III) has been providing reliable electricity services to the nine districts within its franchise coverage area for over four (4) decades. It was formed mainly to purposely supply, promote and encourage the fullest use of electric service to its members on an area coverage basis, in accord with the provisions of RA 6038 and Presidential Decree No. 269, as amended.

Over the years, LEYECO III has contributed to countryside development by implementing electrification programs to provide accessible electricity for all in this side of the country under the supervision of the National Electrification Administration.
