



MUNICIPAL ORDINANCE NO. 25, 2023-2025



AN ORDINANCE ENACTED TO REGULATE FISH PEDDLERS IN THEICE OF LEYTE MUNICIPALITY OF VILLABA AND IMPOSING PENALTIES FOR THE VIOLATION THEREOF

Introduced by: Hon. FELIPE S. CASAS, SR. SB Member, Chairman Committee on Agriculture.

WHEREAS, Section 447 of Republic Act No. 7160 allows the Sangguniang Bayan as a legislative body of the Municipality, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Code;

WHEREAS, Fish Vendors occupying and renting Fish Stalls in the public market are complaining that their sales are affected and reduced due to the presence of the peddling fish vendors in the Poblacion area of the Municipality;

WHEREAS, peddling of fish and other fishery products in the población shall be strictly prohibited, which covers, Barangay Poblacion Del Sur, Barangay Poblacion Del Norte, Barangay Suba and Barangay Fatima;

WHEREAS, the barangays not mention above are free to peddle their fish and other fishery products anywhere they wish to market;

WHEREAS, Section 149 of the Local Government Code of 1991 authorizes the Local Government Units (LGU) to impose charges to violators of any ordinance;

NOW THEREFORE, in view of the foregoing, be it ORDAINED by the Sangguniang Bayan of Villaba in session assembled that.

ARTICLE 1 General Provisions

Section 1-TITLE- This Ordinance shall be known as "An Ordinance Enacted to Regulate Fish Peddlers in the Municipality of Villaba and Imposing Penalties for the Violation Thereof and for Other Purposes.

Section 2-COVERAGE- This ordinance shall only govern to all Fish Peddlers within the Población area of the Municipality of Villaba, Province of Leyte, which covers only

Barangay Poblacion Del Sur, Barangay Poblacion Del Norte, Barangay Suba and Barangay Fatima.

SECTION 3-Definition of Term — words and phrases used in this Ordinance are conceptually and operationally defined as:

- 1. Fish Vendor are those persons engaged in buy and sell and peddle within the población area of the municipality of Villaba
- 2. Public Fish Vendors are those persons selling fish in their respected assigned area in the public market.
- 3. Fish are those marine products sold in the market for human consumption. This includes all fish and other aquatic species such as crustaceans crabs, prowns, shrimp.
- 4. Fish Buyers are those persons who buy fish for their consumption.
- 5. Fish Peddlers- are those persons selling fish anywhere in the jurisdiction of the municipality of Villaba and or neighboring Towns in the Province of Leyte.
- 6. Peddling selling to be consuming public along the Municipal streets of the Poblacion area.

ARTICLE II FISH VENDOR REGISTRATION

SECTION 4 – REGISTRATON – Any person who wish to peddle fish in the upland area of the municipality of Villaba shall secure a registration permit from the Municipal Agriculture's Office; secure a barangay clearance and pay the registration fee in the amount of (P 200.00) pesos to the Municipal Treasurer every year thereafter.

However, any person who sells fish in the Poblacion area of this Municipality through peddling shall be prohibited.

ARTICLE III PENALTIES for Violations

SECTION 5– PENALTIES – Fish Peddlers who did not secure registration permit from the municipal agriculture's office and also did not pay the registration fee as stipulated in Section 4, The selling of fish in the restricted area should be fined accordingly Five Hundred Pesos (Php 500.00) for the first offense, One Thousand Pesos (Php 1,000.00) for the second offense and Two Thousand Pesos (Php 2,000.00) for the third and succeeding offenses;

Peddlers caught violating this Ordinance shall have their goods confiscated and their weighing scales impounded in the Treasurer's Office. However, if said peddler can pay the penalty immediately, the goods and weighing scale shall be released immediately.

All agricultural products confiscated and not paid can be donated to the detained person in the prison jail in the Municipality or to the Evacuees detailed in the Evacuation Center.

SECTION 6 – REPEALING CLAUSE – All existing municipal Ordinances, Resolutions, Executive Orders, rules and regulations thereof, which are inconsistent with this Ordinance are hereby amended, repealed modified accordingly;

SECTION 7 – SEPARABILITY CLAUSE – Should any part or provision of this ordinance be found unconstitutional or invalid by a court of law, such part or provision shall be covered from this ordinance and such action shall not affect the enforceability of the remaining parts or provisions,

SECTION 8 – **EFFECTIVITY CLAUSE** - this ordinance shall take effect upon its approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirements of the Local Government Code.

On motion for approval by the Hon. Felipe S. Casas, Sr., SB Member, duly seconded en masse, this ordinance was approved.

This Ordinance was approved by the Sangguniang Bayan on March 13, 2023.

Fish Vendors of the Municipality of Villaba

The Chairman, Committee on Agriculture conducted a public hearing for the Fish Vendors of the Public Market and Fish Peddlers peddling fish in the restricted area of Villaba, the public hearing started at 10:00 in the morning this was attended by Hon. Roque M. Compra, the Vice Chairman of the committee, Municipal Administrator Mr. Teddy L. Vapor, Representative from the Police Station of the Municipality, Mrs. Ruth Segovia from the Municipal Agriculture's Office and to all Fish Vendors Peddling Fish in the Municipality.

The Chairman, presented the prepared Ordinance by merely reading the content, after reading, the Chairman asked the participants for any comments, suggestions on the restricted area for peddling fish in the jurisdiction of the Municipality.

The area of restriction was made clear to them and so, some of the participants requested the Municipal Administrator to provide a place in the Public Market for them to sell their fish procured from the Fishermen, the agreement was made and to be finalized this coming Monday March 13, 2023, the implementation of this Ordinance will start as soon as it is approved by the members of the Sangguniang Bayan and after this shall been posted in 3 conspicuous places in accordance with the postal requirements of the Local Government Code.

This well be further disseminated by the Municipal Administrator to commence the implementation for their information and guidance,

There being no other concern, the Public Hearing was adjourned at exactly 11:30 in the morning of March 10, 2023.
