281	and comments to wit:
282	"The fine provided for in Section 10 of the Ordinance for first offenses be reduced
283	to P2,500 as opposed to P50,000 pursuant to Section 447 (I)(iii) of the Local
284	Government Code. And,
285	That Section 3(a), requirement item number 5, be modified to include conversion
286	along with reclassification, as per DILG Opinion Circular 22, dated 1031-20, citing the
287	case of CREBA vs. Secretary of Agrarian Reform, stating that reclassification is not
288	enough without conversion to permit usage of agricultural lands for any other purposes.
289	All other else are deemed to be in consonance with PD 449, otherwise known as
290	the Cockfighting Law of 1974."
