254 Honorable Reposar is recognized.

255 HON. RONNAN CHRISTIAN M. REPOSAR: 1<sup>ST</sup> DISTRICT BOARD MEMBER

256 Thank you very much Honorable Presiding Chair, and Honorable Floor Leader.

257 Item Nos. 2, 3, 4, 5, 6, 7, 8, 9, & 10 are Ordinances coming from the  
258 municipalities of the 1<sup>st</sup> District.

259 Item No. 2, is Municipal Ordinance No. 2023-02 of Palo, Leyte, “An Ordinance  
260 Providing the Guidelines for the Registration of Fishing Vessel Three (3) Gross  
261 Tonnage and below in the Municipality of Palo, Province of Leyte.” This is already  
262 recommended for the declaration of its validity by the Provincial Legal Office.

263 Item No. 3, is Ordinance No. 2023-02 from Tanauan, Leyte, entitled “An  
264 Ordinance Establishing a Drug-Free Workplace in the Municipal Government of

265 Tanauan, Leyte, Appropriating Funds for the Purpose and Providing Sanctions for  
266 Violations Thereof.”

267 Item No. 04 is Ordinance No. 2023-04 of Tanauan, Leyte, entitled: “An Ordinance  
268 Authorizing the Municipal Mayor to Initiate an Expropriation Proceedings over a Parcel  
269 of Land Located at Brgy. Maribi, Tanauan, Leyte, Designated as Lot No. 1912-1 Psd-  
270 08-043756 (AR), To Be Used for the Construction of Housing Units for the Relocation of  
271 Families Affected By Calamities and for the Informal Settlers.”

272 Items No. 5, 6, 7, 8, and 9 are ordinances coming from the municipalities of Babatngon,  
273 Leyte. Item Nos. 5, 6, 7 & 8 are all reclassification ordinance involving different parcels  
274 of land.

275 Item No. 5 is “An Ordinance Reclassifying the Lot Measuring Four Thousand  
276 (4,000) Square Meters Located at Barangay Bacong, Babatngon, Leyte, per Lot No.  
277 1291-B under Cad. Lot No. 1291 Covered by Tax Declaration No. 2008-04005-00053  
278 from Agricultural to Industrial Land in Classification.

279 Item No. 6, Ordinance No. 430 of Babatngon, Leyte, “An Ordinance Reclassifying  
280 Three (3) Parcels of Land Identified in the Vicinity Map as: Lot No. 295-B-1 Containing  
281 an Area of Five Thousand (5,000) Square Meters; Lot No. 295-C-4 Containing an Area  
282 of Three Thousand (3,000) Square Meters and Lot No. 295-D-1 Containing an Area of  
283 Two Thousand (2,000) Square Meters, Under Cad Lot No. 295 Covered By Tax  
284 Declaration No. 2008-04014-0050, Located at Barangay Naga-asan, Babatngon, Leyte  
285 From Agricultural to Institutional and Commercial Land in Classifications.”

286 Item No. 7, is Ordinance No. 431, “An Ordinance Reclassifying a Parcel of Land  
287 Measuring Ten (10) Hectares Being a Portion of Cad Lot No. 1923 Covered by Tax  
288 Declaration No. 2008-04018-00094 Containing an Area of 11.824 Sq. M. Located at  
289 Brgy. Rizal II, Babatngon, Leyte From Agricultural to Institutional Area, while the  
290 Remaining Area of Cad Lot No.1923 which is 1.824 Sq. M. shall be Reclassified From  
291 Agricultural to Residential Land in Classification.”

292 Item No. 8 is Ordinance No. 432 of the same municipality, “An Ordinance  
293 Reclassifying The Lot Measuring One Hundred (100) Square Meters, A Portion Of Lot



294 3-G, Psd 08-020529-D Covered By Tax Declaration No. 2008-04001-00603, Located At  
295 Sitio Magsaigad, Brgy. District 1, Babatngon, Leyte from Agricultural To Commercial  
296 Land in Classification”, and

297 Item No. 9, is Ordinance No.433 of the Municipality of Babatngon, “An Ordinance  
298 Institutionalizing the Business Permit and Licensing System (BPLS) in the Municipality  
299 of Babatngon, Leyte.”

300 Lastly, from the First District is Item No. 10, an Ordinance No. 03, from the  
301 Municipality of Tolosa, “An Ordinance Operationalizing Republic Act No. 10173, or the  
302 Data Privacy Act of 2012 in the Municipality of Tolosa and Providing Guidelines  
303 therefore.”

304 The ordinances mentioned had all been recommended to be declared valid by  
305 the Provincial Legal Office except for the Ordinances on Items 5, 6, 7 and 8 where  
306 conditions set forth recommended to be observed by the Provincial Legal Office relative  
307 to the reclassification ordinance.

308 That being the matter recommended for the declaration of validity, I therefore  
309 move that a resolution be issued approving all the said ordinances on review. And let  
310 the conditions set forth by the Provincial Legal Office be observed particularly for the  
311 reclassification ordinance of Babatngon, Leyte. I so move Mr. Chair.

315 Discussion, Mr. Chair.

316 HON. LEONARDO M. JAVIER, JR.: VICE-GOVERNOR/PRESIDING OFFICER

317 Go ahead Floor Leader.

318 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

319 I wish to manifest my second to Honorable Reposar’s motion, but take exception  
320 as to Items 5, 6, 7 and 8. Let me explain, Mr. Chair. Items 5, 6, 7 and 8 are ordinances  
321 reclassifying certain parcels of land in Babatngon. It is true it has been recommended  
322 for the declaration of validity by the Provincial Legal Office. However, I cannot see in the

323 review of the Provincial Legal Office whether or not they have complied it all the  
324 requirements under the Local Government Code. For instance, it is necessary that  
325 there is a certification that the reclassifications of land will not minimize the agricultural  
326 area in Babatngon to such an extent that they will not be able to self-sufficient so, it's  
327 necessary that there's a certification from the Department of Agriculture. It is also  
328 required under the Local Government Code that there's a certification from the  
329 Department of Agrarian Reform that the subject lands have not been covered by the  
330 Agrarian Reform Program. No. 3, it is also required that there is a tax clearance from  
331 the Provincial Government, or from the Municipal Government as a collection agent of  
332 the Provincial Government of Leyte.

333 On that note, Mr. Chair, I urge the Honorable movant if it's possible to exempt  
334 Items 5, 6, 7 and 8. Because there's no attachment to their submission it's only the  
335 ordinance. How can we intelligently review these ordinances if the attachments are not  
336 submitted to us, Mr. Chair?

340 Go ahead, Honorable Ebbie.

341 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

342 Thank you, Mr. Chair.

343 Now, I have observation on Item No. 04, "An Ordinance Authorizing the  
344 Municipal Mayor to Initiate an Expropriation Proceedings over a Parcel of Land Located  
345 at Brgy. Maribi, Tanauan, Leyte.

346 So, this land is a request to the mayor. So, I think the mayor first initiate for the  
347 reclassification of this particular land of relocation of families which have been affected  
348 by calamities. That is my observation Mr. Chairman, Mr. Floor Leader. It is addressed  
349 to the mayor to initiate expropriation proceedings. So, I think we have to wait the  
350 initiation of the mayor for the expropriation proceedings of this parcel of land.

351 That's my observation.

355 Yes, Mr. Chair. Will you please recognize the distinguished movant, Honorable  
356 Reposar?

358 Honorable Reposar is recognized.
