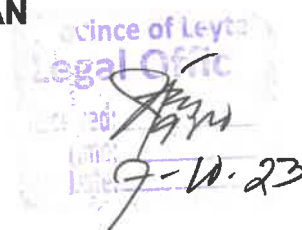

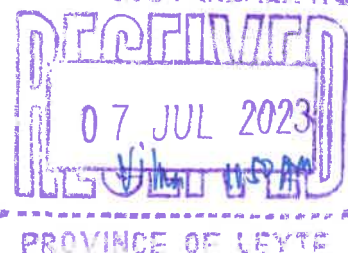

Be it ORDAINED in session assembled that:

Section 1: Section 76 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability subject to the minimum standard and guidelines provided by the Civil Service Commission;

Section 2: Section 447 (a) (1) (VIII) of the same code provides that the Sangguniang Bayan has the power to determine the positions and salaries including allowances and benefits of employees of the Municipal Government.

Section 3: The Administrative Aide III item with salary grade 3 under the Municipal Disaster Risk Reduction Management Office is hereby created in accordance with the staffing pattern of the Municipality of Alangalang, Leyte in conformity with the plantilla of approved by the Civil Service Commission.

Section 4: This ordinance shall take effect immediately upon approval.


