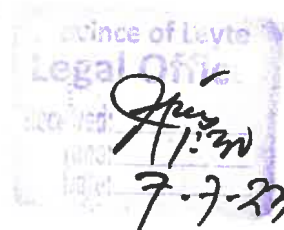

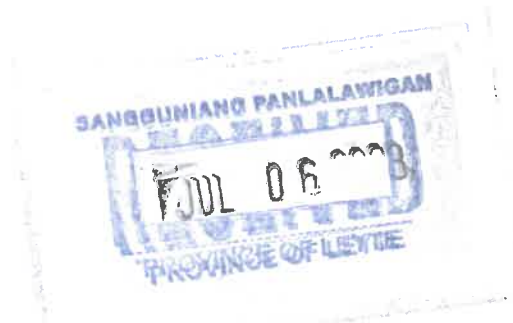

Section 1. Section 6 of Municipal Ordinance No. 2022-08 is hereby amended, by addition, to read as follows:




