



AN ORDINANCE ON THE NEW TRAFFIC SCHEME IN THE BURAUEN PUBLIS MARKET, BRGY. POBLACION DISTRICT VIII, BURAUEN, LEYTE, TO MAKE ONE-WAY STREET TRAFFIC ROUTING (ALONG SAN RAMON ST. [SOUTHBOUND]; SAN AGUSTIN ST. [EASTBOUND]; SAN LUIS ST. [NORTHBOUND]; SAN LUIS ST. TO SAN AGUSTIN ST. [WESTBOUND]; ALL EXITING TO SAN RAMON ST. [SOUTHBOUND]) AND ONE-SIDED STREET PARKING, PROVIDING FUNDS THEREFORE, AND PRESCRIBING PENALTIES AND SANCTIONS FOR VIOLATION THEREOF, AMENDING MUNICIPAL ORDINANCE NO. 22-15, SERIES OF 2022.

WHEREAS, Section 447 (5) of RA 7160, otherwise known as The Local Government Code of 1991, states to; Approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall; (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same:(vi) Regulate traffic on all streets and bridges, prohibit the putting up of encroachments or obstacles thereon, and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal construction in public places;

WHEREAS, there was an increase in the number of vehicles and motorcycles that pass through the Burauen Public Market and its periphery, especially during Wednesdays and Sundays, or the socalled Market Day;

WHEREAS, there is a necessity to implement a new traffic scheme to prevent chaos and to maintain peace and order in the said area to be able to safeguard the pedestrians and motorists alike;

NOW, THEREFORE, on motion of Honorable Cipriano R. Relatorres, Jr., Chairperson, Committee on Transportation, Public Utilities and General Services, duly seconded by all Sangguniang Bayan Members present,

BE IT ORDAINED, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 - Title. This ordinance shall be called AN ORDINANCE ON THE NEW TRAFFIC SCHEME IN THE BURAUEN PUBLIC MARKET, BRGY. POBLACION DISTRICT VIII, BURAUEN, LEYTE, TO MAKE ONE-WAY STREET TRAFFIC ROUTING (ALONG SAN RAMON ST. [SOUTHBOUND]; SAN AGUSTIN ST. [EASTBOUND]; SAN LUIS ST. [NORTHBOUND]; SAN LUIS ST. TO SAN AGUSTIN ST. [WESTBOUND]; ALL EXITING TO SAN RAMON ST. [SOUTHBOUND]) AND ONE-SIDED STREET PARKING,

PROVIDING FUNDS THEREFORE, AND PRESCRIBING PENALTIES AND SANCTIONS FOR VIOLATION THEREOF, AMENDING MUNICIPAL ORDINANCE NO. 22-15, SERIES OF 2022.

SECTION 2 – Coverage. All motorists, residents and non-residents, passing through the streets of the Burauen Public Market and the streets of Brgy. Poblacion Dist. VIII, are required to obey and follow this New Traffic Scheme.

### SECTION 3 – The New Traffic Scheme.

- A. Streets with One-Way Traffic Flow:
  - 1. San Luis St. (northbound) to Los Angeles St.
  - 2. San Ramon St. (southbound)
  - 3. Del Rosario St. (southbound) from Los Angeles St.
  - 4. San Roque St. (westbound) from San Luis St.
  - 5. San Agustin St. (eastbound) to San Ramon St.
- B. San Agustin St. from San Luis St. (westbound) to San Ramon St. is a One-Way Street.
- C. Streets with One-Sided Parking (right side only)
  - 1. Los Angeles St. from San Ramon St. to Sta. Ana St.
  - 2. San Agustin St. from Sta. Ana St. to San Ramon St.
  - 3. Del Rosario St. from Los Angeles St. to Sto. Nino St.
  - 4. San Roque St. from San Ramon St. to Sta. Ana St.
- D. No Parking or Tow Away Zone
  - 1. San Agustin St. from San Luis St. to San Ramon St.
  - 2. All alleys of Buildings 1, 2, 3 and 4 of the Burauen Commercial Complex.
- E. Designated Motorcycle For Hire (MCH) and Public Utility Vehicle (PUV) Terminal
  - 1. San Ramon St. from San Agustin St. to Sto. Nino St. (should park and face southbound)
  - 2. Side of Centennial Building at San Luis St. (northbound) (should be limited to 10 MCH at a time)
  - 3. Building No. 6 All others
- F. 5 minutes loading and unloading rule shall be strictly followed and observed.

**SECTION 4** – *Penalties.* All penalties shall be the same as prescribed in the ordinance creating the Comprehensive Traffic Code of the Municipality of Burauen.

**SECTION 5** – *Deputation*. Authorized personnel to implement this ordinance are the:

- 1. Office of the Municipal Engineer shall provide the installation of permanent signages in the designated roads affected, for the guidance of all motorists and pedestrians.
- 2. Elements of the Philippine National Police Burauen Police Station.

#### 3. Green cops.

The implementation shall be 24/7, unless there is a need to suspend in a particular area/s, only for reasons of emergencies such as fire, calamities, disasters, fiesta or special occasions.

**SECTION 6** – *Repealing Clause.* All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed to be repealed or modified accordingly.

SECTION 7 – Separability Clause. If any of the provisions of this ordinance is declared valid and unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.

SECTION 8 - Effectivity. This ordinance shall take effect upon approval.



ORDINANCE ON THE NEW TRAFFIC SCHEME IN THE BURAUEN PUBLIC MARKET AT BRGY. POBLACION DISTRICT VIII, TO MAKE ONE-WAY STREET TRAFFIC ROUTING AND ONE SIDED STREET PARKING, PROVIDING FUNDS THEREFORE, AND PRESCRIBING PENALTIES AND SANCTIONS FOR VIOLATION THEREOF

WHEREAS, Section 447 (i), (ii), (v) and (vi) of RA 7160, otherwise known as the Local Government Code of 1991. provides for the power, duties and functions of the Sangguniang Bayan, to wit:

- "(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same:
- (vi) "Regulate traffic on all streets and bridges, prohibits encroachments or obstacles thereon and, when necessary in the interest of the public welfare, xxx";

WHEREAS, there was an increase in the number of vehicles and motorcycles that pass through the Burauen Public Market and its periphery, especially during Wednesdays and Sundays, or the so-called Market Day;

WHEREAS, there is a necessity to implement a new traffic scheme to prevent chaos and to maintain peace and order in the said area to be able to safeguard the pedestrians and motorists alike;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BURAUEN, LEYTE, IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known and referred to as the NEW TRAFFIC SCHEME IN THE BURAUEN PUBLIC MARKET AND ITS PERIPHERY AT BRGY. POBLACION DISTRICT VIII;

SECTION 2. COVERAGE – All motorists, residents and non-residents, passing through the streets of the Burauen Public Market and the streets of Brgy. Poblacion Dist. VIII, are required to obey and follow this New Traffic Scheme:

#### SECTION 3. THE NEW TRAFFIC SCHEME

- A. Streets with One-Way Traffic Flow
  - 1. San Luis St. (northbound) to Los Angeles St. to the corner of Sta. Ana St.,
  - 2. San Ramon St. (southbound) to the corner of Sto. Niño St.;
  - 3. Del Rosario St. (southbound) from the corner of Los Angeles St. up to the corner of Sto. Niño St.;
  - 4. San Roque St. (westbound) from the corner of San Luis St. up to the corner of Sta. Ana St.;
  - 5. San Agustin St. (eastbound) from Sta. Ana St. to San Ramon St.;
- B. San Agustin St., from San Luis St. up to San Ramon St. is a Two-Way street;
- C. Streets with one-sided Parking (right side only)
  - 1. Los Angeles St. from San Ramon St. to Sta. Ana St.;
  - 2. San Agustin St. from Sta. Ana St. to San Ramon St.;
  - 3. Del Rosario St. from Los Angeles St. to Sto. Niño St.,
  - 4. San Roque St. from San Ramon St. to Sta. Ana St.;
- D. No Parking or Tow Away Zone:
  - 1. San Agustin St. from San Luis St. to San Ramon St.,
  - 2. All alleys at Bldg. 1, 2, 3 & 4
- E. Designated MCH and PUV Terminal
  - 1. San Ramon St. from San Agustin St. to Niño St.; (should park/face southbound)
  - 2. Side of Centennial Building at San Luis St. (northbound) (but limited to 10 MCH at a time)
  - 3. Building No. 6 All others
- F. 5 Minutes loading and unloading rule shall be strictly followed and observed.

SECTION 4. PENALTIES – All penalties shall be the same as prescribed in the Ordinance Creating the Comprehensive Traffic Code of the Municipality of Burauen;

SECTION 5. DEPUTATION – Authorized personnel to implement this ordinance are:

- The Office of the Municipal Engineer shall provide the installation of permanent signages in the designated roads affected for the guidance of all motorists and pedestrians.
- 2. Elements of the PNP assigned at the Municipal Police Station;
- 3. Green Cops personnel.

The implementation shall be on a 24/7 basis, unless, there is a need to suspend in particular areas only for reasons of emergencies such as fire, calamities, disasters, fiesta or special occasions;

**SECTION 6. REPEALING CLAUSE** – All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed repealed or modified accordingly;

**SECTION 7. SEPARABILITY CLAUSE** – If any of the provision of this ordinance is declared valid and unconstitutional, other parts or provision hereof shall continue to be in full force and effect;

**SECTION 8. EFFECTIVITY** – This ordinance shall take effect upon approval and the posting requirement.
