Section 1. Title. This Ordinance shall be known as "AN ORDINANCE AMENDING SUB-SECTION 1.5 OF SECTION 2 OF MUNICIPAL ORDINANCE 2021-07, SERIES OF 2021 BY ADDENDUM AND INCORPORATING THE CREATION OF A SUB-OFFICE UNDER THE OFFICE OF THE MUNICIPAL MAYOR, THE POSITION OF ONE (1) LABOR AND EMPLOYMENT OFFICER III WITH A SALARY GRADE (SG) 16, AS SECTION HEAD OF THAT OFFICE.

Section 2. The following position is hereby created and incorporated on sub-section 1.5 of Section 2 in the existing Organizational Structure and Staffing Pattern, Position Titles and Salary Grades of the Municipal Government of San Miguel, Leyte enacted under Municipal Ordinance No. 2021-07, Series of 2021, a sub-office under the Office of the Municipal Mayor, to wit:

LABOR AND EMPLOYMENT OFFICER III

Office Assignment **PESO Office**

Qualification Standards

Education Bachelor's Degree preferably in any of the following:

Operations Management (OM); Human Resource

Management (HRM); Human Resource Development (HRD);

and/or allied fields

Residency Must be a bonafide resident of the Municipality of San Miguel, Leyte

Experience 1 year experience in program management relative to

employment facilitation

Training 4 hours of relevant training on employment facilitation

Eligibility Career Service (Professional)/Second Level Eligibility

Salary Grade (SG) 16

Job Description

- 1. Provides technical assistance in the implementation, monitoring, and evaluation of programs or projects of the LGU and DOLE;
- Establishes and maintains linkages with the government agencies and nongovernment agencies;
- 3. Supervises the activities and outputs of personnel under or assigned in PESO Office;
- 4. Prepare and submit periodic reports to immediate supervisor;
- 5. Performs other related works and functions as may be provided by law or assigned by the immediate supervisor.

Section 3. Abolishment of the Position of the Labor and Employment Officer 1. The position of the Labor and Employment Officer I under the Office of the Mayor, under sub-section 1.5.1 of the aforementioned existing ordinance which is still vacant and is no longer needed is hereby abolished.

Section 4. Separability Clause. All other sections and provisions of the Municipal Ordinance No. 2021-07, Series of 2021 otherwise known as "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2009-05, SERIES OF 2009, (otherwise known as "An ordinance Establishing the Revised Organizational Structure and Staffing Pattern, Position Titles, and Salary Grades of the Municipal Government of San Miguel, Leyte effective January 01, 2022) not affected by this amended Ordinance shall remain in effect. If for any reason, any section or provision of this amended Ordinance be held unconstitutional or invalid by competent authority, no other sections or provisions hereof shall be affected.

Section 5. Effectivity. This ordinance shall take effect immediately upon approval.


