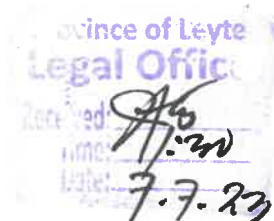

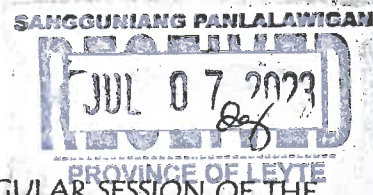

RESOLUTION NO. 2023-096

A RESOLUTION ENACTING AN ORDINANCE ESTABLISHING A SENIOR CITIZENS CENTER IN THE MUNICIPALITY OF MACARTHUR, LEYTE AND APPROPRIATING FUNDS THERETO

WHEREAS, Section 11, Article XIII of the 1987 Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;

WHEREAS, considering that Senior Citizens are integral part of the Philippine society, it is the policy of the city government to extend full support for the improvement of the total well-being of the elderly and their full participation in the society, as well as to motivate and encourage the senior citizens to contribute to nation building;

WHEREAS, by virtue of the objectives of Republic Act No. 9994 or the "Expanded Senior Citizens Act of 2010", the government is mandated to adopt measures whereby our Senior Citizens are properly assisted, accommodated, and appreciated by the community as a whole. The government is likewise mandated to establish mechanisms whereby the contributions of the senior citizens are maximized;

WHEREAS, under Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the local government units, more particularly the barangays, shall exercise such powers, and discharge such functions and responsibilities which are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities. These facilities would include, but are not limited to, infrastructure facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center, and other similar facilities;

WHEREAS, by virtue of the provisions of Republic Act No. 9498, also known as the "2003 General Appropriations Act", the Local Government Units (LGUs) shall set aside one percent (1%) from their General Budget to fund the various programs/projects and activities of the Senior Citizens and Persons with Disabilities

WHEREFORE, on motion of Honorable Trina C. Burawis duly seconded by Honorable Gwendolyn M. Beriso, Honorable Raul E. Mundala, Honorable Ireneo G. Remanes Jr., Honorable Leonardo R. Leria Jr., and Honorable Xandrix P. Pantin, be it

RESOLVED, as it is resolved to enact the following Ordinance:

SECTION 1. SHORT TITLE – An ordinance ESTABLISHING A SENIOR CITIZENS CENTER in the Municipality of MacArthur, Leyte AND APPROPRIATING FUNDS THERTO.


SECTION 2. ESTABLISHMENT OF SENIOR CITIZENS CENTER – By virtue of this Ordinance, it is hereby allowed the establishment of a Senior Citizens Center in the Municipality of MacArthur, Leyte.

SECTION 3. PURPOSE. The purpose of the Senior Citizens Center is to provide our Senior Citizens a venue where they can stage their social, recreational, educational, health, and leisure programs and activities designed for their full enjoyment and benefit.

SECTION 4. FUNCTIONS OF THE SENIOR CITIZENS CENTER – The Senior Citizens Center shall carry out the following functions:


- (a) Identify the needs, trainings and opportunities of senior citizens in the municipality;
- (b) Initiate, develop and implement productive activities and work schemes for senior citizens in order to provide income or otherwise supplement their earnings in the barangay community;



(c) Promote and maintain linkages with local government units and other instrumentalities of government for the elderly and other nongovernment organization for the delivery of health care services, facilities, professional advice services, volunteer training and community self-help projects; and (d) To exercise such other functions which are necessary to carry out the purpose for which the center is established.

SECTION 5. LOCATION OF THE SENIOR CITIZENS CENTER - The Senior Citizens Center shall be established within the municipal compound where it is deemed viable.

SECTION 6. WORKERS OF THE CENTER - The Senior Citizens Center shall be under the direct administration of the MSWDO, which shall among others, provide the necessary manpower, coordinate with the appropriate agencies of the government for its implementation and conceptualize the center's program of activities according to the respective needs of their Senior Citizens and PWDs. They may also designate volunteer workers for this purpose.

SECTION 7. FUNDING FOR THE SENIOR CITIZENS' CENTER - The amount necessary for the establishment and continuous implementation of the Senior Citizens Center shall be subsidized in part by the LGU and other government and non-governmental units concerned.

SECTION 8. IMPLEMENTING RULES AND REGULATIONS - The President of Liga ng mga Barangay, MSWDO, Office of the Senior Citizens Affairs (OSCA), Municipal Budget Office, and MLGOO shall be enjoined to craft the Implementing Rules and Regulations of this ordinance.

SECTION 9. SEPARABILITY CLAUSE - Should any provision of this Ordinance be declared unconstitutional or illegal by any court of competent jurisdiction, those parts that are not so declared shall remain in full force and effect.


SECTION 10. REPEALING CLAUSE - Any previous Ordinance/s or parts thereof, which are inconsistent with this Ordinance are hereby repealed, superseded or modified accordingly.

SECTION 11. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval by the Sangguniang Panlalawigan.

ENACTED by the Sangguniang Bayan in session assembled on June 19, 2023 at MacArthur, Leyte, Philippines.
