AN ORDINANCE EXTENDING THE UTILIZATION OF A PORTION OF STO. NINO STREET, FROM THE CORNER OF LA PURISIMA STREET UP TO THE CORNER OF STA. BARBARA STREET AS STAGING OR HOLDING AREA FOR PUBLIC HEALTH EMERGENCY AND FOR PURPOSES OF CARRYING OUT GOVERNMENT SERVICES **AND ACTIVITIES UNTIL DECEMBER 31, 2023**

WHEREAS, it is a declared policy of the state to protect and promote the right to health of people and instill health consciousness among them;

WHEREAS, it is the duty and obligation of the Local Government Unit, to protect and cater the needs of the populace such as staging or holding area on public health emergency and carrying out other government services and activities to shed them from heat and rain;

WHEREAS, the COVID-19 pandemic is not yet over;

WHEREFORE, to ensure that health protocols is still be strictly observed, such as maintaining the required physical distancing within the area during activities, upon request of Burauen IATF-EID, and to provide a wider venue, that will serve as the staging area of the municipality, on the motion of Hon. Vincent G. Enerlan, duly seconded by all Sangguniang Bayan members present;

BE IT ORDAINED, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 - A portion of Sto. Nino Street, starting at the corner of La Purisima Street, up to the corner of Sta. Barbara Street, should still, be temporarily closed to all vehicular traffic, to serve as the Municipal Staging Area for Health and Carrying Out Other Government Services and Activities until December 31, 2023.

SECTION 2 - Effectivity Clause - This ordinance shall take effect upon approval hereof.
