



**A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2022-04, MUNICIPAL ORDINANCE NO. 2022-05, MUNICIPAL ORDINANCE NO. 2022-06, MUNICIPAL ORDINANCE NO. 2022-07 AND MUNICIPAL ORDINANCE NO. 2022-08, ALL OF JULITA, LEYTE.**

**WHEREAS**, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunians of component cities and municipalities;"

**WHEREAS**, submitted to the Sangguniang Panlalawigan are various Ordinances from Julita, Leyte for approval, to wit:

- 3. Municipal Ordinance No. 2022-06** entitled: "AN ORDINANCE CREATING THE POSITION OF LABOR AND EMPLOYMENT OFFICER II WITH A SALARY GRADE 13 (ITEM NOS. 01/68) AT THE PUBLIC EMPLOYMENT SERVICE OFFICE OF THE MUNICIPALITY OF JULITA, LEYTE AND APPROPRIATING THE FUNDS NEEDED THEREOF";
- 4. Municipal Ordinance No. 2022-07** entitled: "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE III (UTILITY WORKER II) WITH A SALARY GRADE 3 (ITEM NOS. 01/69) AT THE PUBLIC EMPLOYMENT SERVICE OFFICE OF THE MUNICIPALITY OF JULITA, LEYTE AND APPROPRIATING THE FUNDS NEEDED THEREOF";

**5. Municipal Ordinance No. 2022-08 “AN ORDINANCE CREATING THE POSITION OF PHARMACIST II (B) WITH A SALARY GRADE 12 (ITEM NO. 01/70) AT THE MUNICIPAL HEALTH UNIT OFFICE OF THE MUNICIPALITY OF JULITA, LEYTE AND APPROPRIATING THE FUNDS NEEDED THEREOF”;**

**WHEREAS**, the Provincial Legal Office was requested to review and submit recommendation on the subject Ordinances pursuant to Section 481 (3) (vii) of R.A. 7160;

**WHEREAS**, the Provincial Legal Office through Atty. Jose Raymund A. Acol, Assistant Provincial Legal Officer, per attached Indorsements, all dated July 19, 2022, recommended for the declaration of validity of the subject Ordinance pursuant to Section 56 (c) of R.A. 7160, the same being an exercise of the power authorized under Section 447 (I), (viii) of the Code, provided that, the creation of New Plantilla Positions does not violate the prohibition under Section 325 (a) and (g) thereof”;

**WHEREAS**, the August Body, upon review, finds the subject Ordinances to be in conformity with the existing laws, rules and regulations;


**NOW, THEREFORE**, on omnibus motion presented by Honorable Trinidad G. Apostol, duly seconded by Honorable Wilson S. Uy, Honorable Raissa J. Villasin, Honorable Ma. Corazon E.
