

ORDINANCE NO. 23-07 SERIES OF 2023

AN ORDINANCE PROTECTING OUR RIVER SHORELINES AND AN ADDITIONAL ENVIRONMENT PROTECTION BY REQUIRING SAND AND CRAVEL CONCESSIONAIRES TO PLANT FIFTY (50) BAMBOO TREES ON EVERY BUSINESS PERMIT RENEWAL

WHEREAS, Article II, Section 16 of the 1987 Philippine Constitution provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, the Local Government Unit of Burauen upholds the safety of the people and the protection of the environment and natural resources;

WHEREAS, Bamboo trees can mitigate flooding and its wide spreading root system and canopy makes the bamboo an effective erosion-control plant and its net-like root system holds the soil together in critical riverbanks, deforested areas, and even in places prone to earthquakes and landslides;

WHEREFORE, to ensure the protection of our river shorelines while pursuing economic development, on motion of Hon. Bryan R. Cinco, duly seconded by all Sangguniang Bayan members present;

BE IT ORDAINED, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 – *Title.* This ordinance shall be referred to as, "An Ordinance Protecting Our River Shorelines and an Additional Environment Protection by Requiring Sand and Gravel Concessionaires to Plant Fifty (50) Bamboo Trees on Every Business Permit Renewal".

SECTION II – *Scope and Coverage*. This ordinance shall cover all Sand and Gravel Applicants for Renewal of their Business Permit which shall form part as one of the requirements in obtaining the said permit at the Business Permit and Licensing Office.

SECTION III – *Tree Planting Site Areas and Reporting.* The bamboo plants shall be planted along the river side of the extraction area through the barangay, Civil Society Organizations (CSO) or any foundation partnership. There should be a tree planting report which consists of pictures, date, location and signature of the applicant and partnered organization or offices.

SECTION IV - Separability Clause. If any provision of this ordinance shall be held invalid, the remaining provisions shall be given full force and effect as completely as if the provision held invalid had not been included therein.

SECTION V - Repealing Clause. All laws, ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance, are hereby repealed, amended and modified accordingly.

SECTION VI - Effectivity Clause. This ordinance shall take effect upon approval hereof.
