

EXCERPT FROM THE MINUTES OF THE 35th REGULAR SESSION OF THE SANGGUNIANG BAYAN OF BURAUEN, LEYTE, HELD AT THE MUNICIPAL SESSION HALL, EXECUTIVE AND LEGISLATIVE BUILDING ON FEBRUARY 27, 2023

ORDINANCE NO. 23-08 SERIES OF 2023

AN ORDINANCE CREATING THE MUNICIPAL EPIDEMIOLOGY AND SURVEILLANCE UNIT (MESU) OF THE MUNICIPALITY OF BURAUEN, PROVINCE OF LEYTE

Sponsor: HON. FE S. RENOMERON Chairman, Committee on Health and Public Sanitation

WHEREAS, Republic Act 11332, otherwise known as Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act, of 2018, mandates that, "The DOH, in coordination with the LGUs, shall ensure that the Epidemiology and Surveillance Units (ESUs) are established and functional in all levels of the DOH and its local counterparts, and in public and private health facilities and laboratories, as well as ports and airports in all provinces, cities and municipalities throughout the country.";

WHEREAS, the creation and establishment of the unit is necessary for the Municipality to ensure that there is a working system that "captures and verifies all reported notifiable diseases and health events of public health concern; provide timely, accurate and reliable epidemiologic information to appropriate agencies; conduct disease surveillance and response activities, coordinates needed response; and facilitates capacity building in the field of epidemiology, disease surveillance and response at the Epidemiology Bureau";

WHEREAS, the Municipality of Burauen do hereby order the organization of the Municipal Epidemiology and Surveillance Unit, integrate support group and provide its composition, duties and functions;

NOW THEREFORE, Be it ordained by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 – *Title.* This ordinance shall be known as, "The Municipal Epidemiology Surveillance Unit (MESU) of Burauen, Leyte".

SECTION II – Legal Basis and Mandate. This ordinance is enacted pursuant to RA 7160, "The Local Government Code of the Philippines"; RA 11332, "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act", and DOH AO No. 2007-0036, "Guidelines on the Philippine Integrated Disease Surveillance and Response (PIDSR) framework".

SECTION III – *Scope and Coverage*. This ordinance shall cover the entire political jurisdiction of Burauen, Leyte.

SECTION IV - Creation of the Unit. A Municipal Epidemiology Surveillance Unit (MESU) should hereby be created. The MESU shall operate under the Municipal Health Office of Burauen, Leyte. It shall maintain a functional Municipal Disease Surveillance System equipped with the necessary resources and adequate local financial support as determined by the municipality government officials.

SECTION V - Composition/Organization. The MESU shall be composed of the following:

- 1. Municipal Epidemiology Surveillance Unit (MESU) Chairman; DOCTOR
- 2. Municipal Disease Surveillance Officer (DSO): NURSE
- 3. Epidemiology Assistant: the existing health personnel of the MHO may serve as personnel of the MESU

SECTION VI - Duties and Functions of the Unit.

- 1. Organize data collection and gather epidemiological data from health facilities such as the Rural Health Units, Health Centers, Barangay Health Stations and the District Hospital;
- 2. Prepare and periodically update graphs, tables and charts to describe time, place and person for Notifiable/Reportable diseases and conditions by maintaining a computer based data storage and analysis;
- 3. Analyze data and provide feedback to health facilities and local leaders;
- 4. Identify and inform concerned personnel such as Rural Health Physicians, Public Health Nurses, Rural Health Midwives, and Barangay Health Workers immediately of any disease or condition in their expected areas that (a) exceeds an epidemic threshold, (b) occurs in locations where it was previously absent, (c) occurs more often in a population group than previously, and (d) presents unusual trends or patterns;
- 5. Carry out outbreak investigations, monitor, assess and report causes of epidemics;
- 6. Coordinate with appropriate laboratory for collection and transport of specimens;
- 7. Liaise with other agencies whose assistance is needed to complete outbreak situations;
- Implement preliminary/appropriate epidemic control measures immediately, if required;
- 9. Forward epidemiological data to the next level on a regular basis and in accordance with the national surveillance protocol;
- 10. Establish, operate and maintain a Municipal Epidemic Preparedness and Response Plan, including the creation of multidisciplinary/multisectoral teams to respond to events that may constitute a public health emergency, and;
- 11. Support municipal surveillance teams in strengthening surveillance and epidemic response through capability training and workshop as well as information education campaign and supervision.
- 12. Declare the existence of epidemic in the Municipality.

SECTION VII - Composition of the Disease Reporting Unit. The Disease Reporting Unit (DRU) is primarily responsible in the detection of cases using the standards prescribed in the Philippine Integrated Disease Surveillance and Response Manual of Procedures. The DRU shall be composed of the following:

CHAIRMAN: Municipal Epidemiology Surveillance Unit (MESU)

VICE CHAIRMAN: Disease Surveillance Officer (DSO)

MEMBERS: Barangay Health Units Burauen District Hospital

SECTION VIII – Composition of the Disease Reporting Advocates. The Disease Reporting Advocates (DRA) who shall be responsible in the reporting of cases of notifiable diseases detected in their respective areas, shall be composed of the following:

- Barangay Health Emergency and Response Teams headed by the Punong Barangay and assisted by the Barangay Kagawad on Health
- 2. Barangay Health Midwives
- 3. Barangay Health Workers
- 4. Barangay Nutrition Scholars
- 5. Barangay Service Point Officers
- 6. School Nurses

SECTION IX – Disease Surveillance Officer (DSO). The Disease Surveillance Officer shall be responsible with the following roles and responsibilities:

- 1. Collection of PIDSR from the different DRUs;
- 2. Encode, consolidate, analyse and interpret data using case investigation forms where files are maintained and to be submitted to the next higher level;
- 3. Conduct preliminary investigation of suspected epidemics;
- 4. Notify the next higher level when an epidemic is suspected;
- 5. Assist in epidemic investigation conducted by PESUs, RESUs and NEC;
- 6. Record in the Weekly Notifiable Disease Report (WNDR) all cases of notifiable disease admitted in the RHU, seen in the community or reported from the District Hospital and Private Clinics;
- 7. Prepare weekly, monthly and annual disease surveillance reports to be submitted to the next higher level, and retain a copy for further data analysis;
- 8. Provide technical assistance in outbreak investigation and response when necessary;
- 9. Conduct regular technical assistance visits with epidemiologist;
- 10. Manage logistics needed in the surveillance operations at his/her level.

SECTION X – *Epidemic Investigation and Control Team.* The Epidemic Investigation and Control Team (EICT) shall be composed of the following:

TEAM LEADER: Municipal Health Officer (MHO)

MEMBERS: 1. MESU

- 2. Public Health Nurses
- 3. Rural Health Midwives
- 4. Medical Technologist
- 5. Sanitary Inspector
- 6. Municipal Engineering Office
- 7. Barangay Health Workers

Duties and Functions of the Team are as follows:

- 1. Conduct Epidemiologic Investigation of epidemics suspected or confirmed;
- 2. Establish active surveillance in the affected areas;
- 3. Implement the epidemic response plan;
- 4. Oversee the implementation of control measures;
- 5. Meet daily during epidemic to review the latest surveillance data and implement additional control measures;
- 6. Ensure the use of standard treatment protocols for the disease by the trained health workers;
- Identify and coordinate other stakeholders for a multi-sectoral team approach, list
 of referral laboratories and available examinations, and list of referral hospitals
 for managing the epidemic;
- 8. Provide regular feedback to the community, LGU, PHO, and DOH CHD;
- 9. Request assistance when necessary, and;

10. Perform other tasks as instructed by the head of the agency.

SECTION XI – *Appropriations*. The budgetary requirement shall be funded through the Annual Budget of Burauen, Leyte Municipal Health Office.

SECTION XII – *Separability Clause*. If for any reasons any part or provisions of this ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION XIII – *Repealing Clause.* All previous ordinances and provisions inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION XIV - Effectivity. This ordinance shall take effect upon approval hereof.
