 - c. That the technical descriptions and Identifying documents of the ordinance and the attachments are inconsistent with each other such as the Tax Declaration, Lot. No., Oct no. etc;

3. Therefore it is this office's recommendation that the inconsistencies and other such related matters and issues mentioned above be resolved first and then re-submitted for further evaluation.
