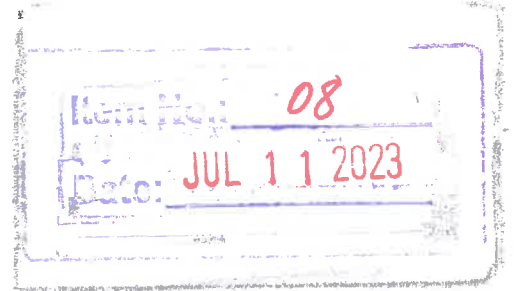
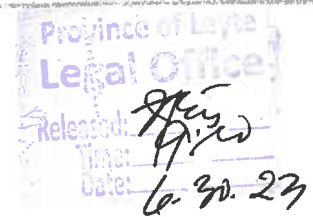

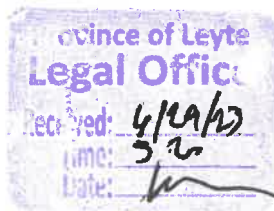

EXCERPT FROM THE MINUTES OF THE 46TH REGULAR SESSION OF THE SANGGUNIANG BAYAN HELD AT THE SB SESSION HALL OF ALBUERA, LEYTE ON MAY 22, 2023

ORDINANCE NO. 2023-05

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR OR THE MUNICIPAL VICE-MAYOR, AS THE CASE MAY BE, PURSUANT TO SECT. 336 OF R.A. 7160, TO AUGMENT FUNDS IN ANY ITEM IN THE 2023 GENERAL FUND ANNUAL BUDGET OF ALBUERA, LEYTE IN CASE THE ALLOCATION OF OTHER ITEM/S OF THE SAME EXPENSE CLASS IS DEPLETED DURING IMPLEMENTATION IN UNFORESEEN EVENTS

Introduced by: **HON. ANALIZA E. DELA VICTORIA**

BE IT ORDAINED, by the Sangguniang Bayan of Albuera, Leyte in Regular Session that:

SECTION 1. USE OF SAVINGS & AUGMENTATION. – In accordance with Section 336 of Republic Act No. 7160, the Local Government Code 1991, Municipal Mayor or the Municipal Vice-Mayor, as the case may be, are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

SECTION 2. PRIORITY IN THE USE OF SAVINGS. – The Office of the Municipal Mayor respectfully requested this august body for an appropriate legislative action to the effect that “the Municipal Mayor or the Municipal Vice-Mayor, as the case may be, be authorized, pursuant to Sect. 336 of R.A. 7160, to augment funds in any item in the 2023 General Fund Annual Budget of Albuera, Leyte in case the allocation of other item/s of the same expense class is depleted during implementation in unforeseen event” is hereby approved.

SECTION 3. SEPARABILITY CLAUSE. – If, for any reasons, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force & effect.

SECTION 4. EFFECTIVITY. – The provision of this Ordinance shall take effect immediately upon approval.


