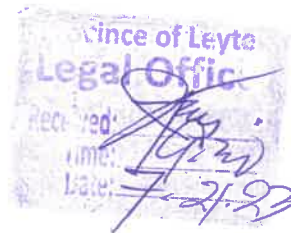

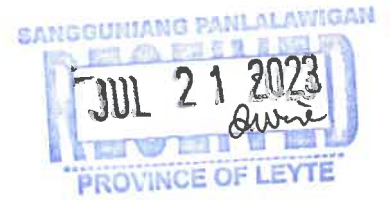

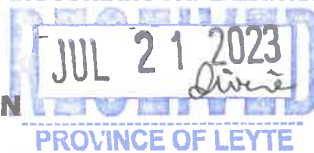

WHEREAS, Executive Order No. 278, s. 1949, signed by President Elpedio Quirino on October 10, 1949 created in the Province of Leyte a municipality to be known as the Municipality of Julita;

WHEREAS, the Municipality of Julita, Leyte recognized the need to have a seal that will represent the principles and aspirations of the Municipality. Adopting an official seal for the Municipality serves the purpose of having a concrete symbol of its authority as well as constant reminder of the duties and responsibilities of its officials and employees as defined under the Local Government Code, other laws, rules and regulations affecting local governance and public service;

WHEREAS, the municipality official seal is likewise necessary to identify official transactions and documents of the Municipality of Julita, Leyte;

WHEREAS, the Municipality of Julita, Leyte has been using an official seal but there is no record showing its adoption as the official seal of the municipality;

NOW THEREFORE, BE IT ENACTED by the Sangguniang Bayan of Julita, Leyte, in session duly assembled, that:

SECTION 1. Title. This Municipal Ordinance shall be known as "An Ordinance Adopting the Official Seal of the Municipality of Julita, Leyte, Prescribing the Use and Imposing Penalty for Unofficial/Unauthorized Use Thereof"

SECTION 2. Official Seal. The Official Seal of the Municipality of Julita, Leyte shall be as depicted below:



SYMBOLS AND REPRESENTATIONS

The Circles

The yellow, black, and blue circles enclosing the seal and caption of Municipality of Julita, Leyte, symbolize the unity and oneness of the people of Julita. It represents the unified goal, dreams and aspiration of every Julitanhon to become part and parcel of building a progressive and peaceful community centered on faith and driven by the desire to contribute one's talents and skills in order for the change and development to happen.

Blue, Red and Yellow Colors

These three colors represent essential qualities of every Julitanhon. Blue represents the peace. Red represents bravery. Yellow represents hope.

Pocket Shape inside the Logo

This signifies that the municipality belongs to the Province of Leyte. The idea of the pocket shape was taken from the Official Seal of the Province of Leyte.

Laying Down "S" Letter

This is a Baybayin letter for 'HA' which is equivalent to J in the English alphabet. The letter 'J' stands for Julita.

The Radiant Sun

This represents the bright future of the municipality through proactive cooperation and engagement between the Local Government Unit and through the leadership of responsible and committed leaders. The 26 rays represents the twenty-six (26) barangays composing the Municipality of Julita, Leyte.

The Carabao and Rice Field

This hardworking animal represents the abundance of fertile land suitable for different agricultural crops which the municipality constantly produces throughout the year. Agriculture is the main economic activity in the municipality providing income to rice farmers and farm laborers through employment and marketing of agricultural products.

Nipa Hut with Tree

This represents the origin of the town as it is used as a waiting area and resting place of travelers plying between the nearby towns of Burauen and Dulag. The place where the town is now erected was originally called "Hulatan", which means "waiting place" in local dialect.

The River

This represents the rivers that cuts through the town that are abundant source of fish and other food and are also used for leisure. The Daguitan River has also a mine in the form of a sand and gravel quarry.







The colors, fonts, sizes, effects, masks and layers shall be preserved by saving the official seal image in Adobe Photoshop format (PSD).

SECTION 3. Purpose of Seal and Authorized Use of Seal. The Official Seal of the Municipality of Julita, Leyte shall be used for official purposes only.

- a. To authenticate all public documents and other administrative issuances.
- b. As letterhead in official communication or correspondence in the exercise of the Local Government of Julita's power and other functions;
- c. To be affixed upon such other official documents, plates and papers of the Local Government Unit of Julita, Leyte as may be provided by a Sangguniang Bayan resolution or ordinance, or as may be required by custom or usage;
- d. As symbol of the Municipality of Julita, Leyte in all its affairs within or outside of its territorial jurisdiction.
- e. To be affixed upon the Municipality of Julita, Leyte pins, service rings, stickers or be embroidered and affixed upon the uniforms of Municipality of Julita, Leyte officials and employees.

SECTION 4. Guidelines on Authorized Use of Seal by Barangays. The barangays composing the Municipality of Julita, Leyte not having an official seal of their own, shall use the Official Seal of the municipality in official purposes only.

- a. To authenticate all public documents and other administrative issuances.
- b. As letterhead in official communication or correspondence in the exercise of the Barangay's power and other functions;

SECTION 5. Display, Custody and Change in Design of the Official Seal
Permanent Display of Carved Corporate Seal

As a sign of authority, there shall be made two (2) carved official seals of Municipality of Julita, Leyte either in wood, stone, brass, clay or other medium. They shall be permanently attached/displayed at the Office of the Municipal Mayor and at a place easily accessible and visible within the premises of the Municipal Hall. These shall be in bigger sizes proportionate with the wall or room, and placed in an elevated, centermost dominant position.

Custody of the Original Layout of the Seal

The Office of the Mayor and the Office of the ICT shall have custody of the original file of the Official Seal of the Municipality of Julita in Adobe Photoshop format (PSD). It shall be saved in a computer, in a disc and in an icloud storage. The Office of the ICT shall be responsible in migrating the file into a new version or format to preserve the design of the Official Seal of the Sangguniang Bayan of Julita.

Change in the Design of the Official Seal


- a. The seal provided herein shall only be changed for a justifiable reason and by a unanimous vote of all the members of the Sangguniang Bayan, and no new seal shall be adopted within ten (10) years from the date of approval hereof.



b. Any change in the design of the seal provided herein, without changing the entire design shall be made only for a justifiable reason, not more than once every ten years and by a unanimous vote of all the members of the Sangguniang Bayan.

SECTION 6. The Official Seal used as the Official Logo

The Official Seal of the Municipality of Julita, Leyte shall also be utilized as the official logo of the Municipality of Julita, Leyte until such time that an official logo shall be adopted by the municipality through an ordinance. The logo shall appear in bulletin boards, publications, reports, stationeries, online materials and others.

SECTION 7. Unauthorized use of the seal/logo. It shall be unlawful for any person, natural or juridical, to:

- a. To mutilate, deface, defile, trample on, or cast contempt by any act or omission casting dishonor or ridicule upon the official seal;
- b. To display the seal under any frame or picture;
- c. To display the seal in a platform or stage during programs not hosted by the Municipal Government of Julita;
- d. To add any word, figure, mark, picture, design, drawings, advertisements, or imprint of any nature on the seal;
- e. To print, paint or attach representation of the seal on handkerchief, napkins, cushions, and other articles of merchandise except upon authority of the Sangguniang Bayan through a resolution for the purpose of promoting tourism and legislative education which shall be under the control and supervision of the Office of the Municipal Mayor;
- f. To use or display the seal as part of any advertisement or infomercial, except when undertaken by the Municipal Government itself and approved by the Sangguniang Bayan;
- g. To use the Official Seal of the Municipality of Julita, Leyte as personal seal of any local official including the Municipal Mayor by indicating the name or position within the ring border of the seal.

SECTION 8. Penal Clause.

Any violation of this provision shall be punishable by **an imprisonment of not more than thirty (30) days** or a **fine of not more than Two Thousand Five Hundred Pesos (P 2,500.00)** or **both**, subject to the discretion of the Courts.

If and when the violator is a public officer or employee, he or she shall be subject to reprimand, discipline, suspension or any administrative liability depending on the gravity of the offense, without prejudice to the filing of appropriate civil or criminal action;

SECTION 9. Separability Clause. If, for any reason or reasons, any part or provision of this ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 10. Repealing Clause. All ordinances, rules and regulations, or parts thereof, in conflict with or inconsistent to the provisions of this ordinance are hereby repealed or modified accordingly.

Minutes of the Public Hearing for **Municipal Ordinance No. 2023-01** (Sangguniang Bayan Logo) and **Municipal Ordinance No. 2023-02** (Municipal Seal) held at the Municipal Gym on **March 06, 2023**.

The Public Hearing started at 11:00 o'clock in the morning with a prayer led by Hon. Advincula and followed by the singing of the Pambansang Awit and the Julita Hymn through an overture.

Hon. Mark Joy E. Macaso the proponent of two (2) Municipal Ordinances, presented first Municipal Ordinance No. 2023-02 which pertains to the Municipal Seal.

Hon. Mark Joy E. explained to those who attended the Public Hearing that he made the necessary research and consultation if there was already an existing ordinance regarding the Municipal Seal but had found nothing.

It should be noted that Hon. Mark Joy E. Macaso informed those who attended the Public Hearing that in this Ordinance there were only two (2) minor changes that he had made on the existing Municipal Seal and that is, (1) the two pins on it were change to a circle and (2) the rays of the sun were change to 26 rays which represents the 26 barangays of the municipality instead of the original 8 rays.

It should be noted further that the proponent of the Municipal Ordinance No. 2023-02 explained the other provisions in it specially the authorized usage of the Municipal Seal and its prohibitions.

It was also made clear on this Public Hearing that those who will violate the provisions of this Municipal Ordinance will be subjected to some penal sanctions.

After presenting the different provisions of the Municipal Ordinance No. 2023-02, Hon. Mark Joy E. Macaso proceeded in presenting Municipal Ordinance No. 2023-01 which pertains to the Sangguniang Bayan Logo of the municipality.

Hon. Mark Joy E. Macaso presented to the floor the importance of having a Sangguninag Bayan Logo which represents the Office of the Sangguniang Bayan of the municipality.

Hon. Mark Joy E. Macaso further presented on this Public Hearing the meaning of the different symbols found in the Sangguniang Bayan Logo.

It was also presented by its proponent the authorized usage of this logo as well as its prohibitions together with its penalties to those who will violates it.

After the presentation of the two (2) Municipal Ordinances, the members of the Sangguniang Bayan opened the floor for some clarifications, questions and even suggestions.

Mr. O neal T. Opiniano raised a question to the proponent if on which part of a document of a certain barangay having its own barangay seal does the Municipal Seal be placed.

Hon. Tubi explained that there is no specific provision on the ordinance that states where the Municipal Seal be placed on a certain document.

Engr. Johnny Cabebehan the MPDO-Designate of the municipality presented his opinion that it should be put on the right side of the document.

Hon. Mark Joy E. Macaso the proponent of this Municipal Ordinance explained that this matter will be settled by his colleagues in one of their sessions.

Hon. Dy explained on this Public Hearing that the Sangguniang Bayan Logo should be placed on the right side of the document when facing it and the Municipal Seal on its left.

Engr. Cabebehan further asked the proponent if it would be allowed for the Municipal Seal to be used as a watermark or a background of a document coming from the LGU.

Hon. Mark Joy E. Macaso explained to Engr. Cabebehan that it can be allowed as long as the documents are coming from the LGU and that it cannot be considered as tampering.

Hon. Daya also told Engr. Cabebehan that it can be allowed.

The members of the Sangguniang Bayan who were present on this Public Hearing assured those who attended it that all their suggestions will be considered and be deliberated by them.

Ms. Purita Y. Lao the LCR of the municipality asked the proponent if during his investigation and research regarding the existence of an ordinance pertaining the Municipal Seal, was he not able to find any documents, resolutions or even an ordinance in relation to it considering that the existing Municipal Seal was already being used by the LGU long time ago.

According to Hon. Mark Joy E. Macaso, during his research he found nothing and that he told those who attended the Public Hearing that no major changes were made on it, except with the two (2) minor changes as stated on its presentation.

Hon. Tubi explained that the Municipal Seal and the Sangguniang Bayan Logo should be printed in a colored manner in order for its symbols and colors to be known.

There having no more discussions, clarifications and even suggestions to the two (2) Municipal Ordinances, the Municipal Vice Mayor gave the Closing Remarks.

The Public Hearing was adjourned at 12:45PM.
