There are actually 3 Ordinances coming from the Municipality of San Miguel, Mr.
Chair. If I may be allowed, I would like to actually pass for an omnibus motion for these
3 Ordinances? Since, the 2 Ordinances are just actually amendatory Ordinances of
their existing Ordinance, which were already approved by the Sangguniang
Panlalawigan.

The first Ordinance on Item No. 02, is the expanded 4Ps Ordinance which is merely a general Ordinance for the benefit of the constituents of the Municipality of San Miguel, Leyte as per Section 16 of the Local Government Code. Perusing on the records on file, the Provincial Legal Office did not find any provision contrary to the constitution or any other existing laws of the Republic of the Philippines. And on their Indorsements, all the 3 Ordinances were recommended to be declared valid pursuant to the provisions of the Local Government Code.

That being said, Mr. Chair, I would like to pass an omnibus motion declaring Items 2, 3 and 4 which are Ordinances coming from San Miguel, Leyte, valid, Mr. Chair.
