Item Nos. 1 and 2 are Ordinances coming from the Municipalities of Alangalang and San Miguel, Leyte within the First District which are all general Ordinances for the general welfare of the constituents of the municipalities.

Ordinance No. 10 series of 2023 of Alangalang, is “An Ordinance Creating of One (1) Administrative Aide III Item with Salary Grade 3 under the Municipal Disaster Risk Reduction Management Office in the Municipal Government of Alangalang, Leyte.” The same has been recommended for the declaration of validity pursuant to its power under the Local Government Code.

And same as well as Municipal Ordinance No. 2023-07 of San Miguel, Leyte, entitled, “An Ordinance Prohibiting the Use, Sale, Distribution, and Advertisement of Cigarettes and other Tobacco Products, Electronic Nicotine and Non-Nicotine Delivery Systems, Heated Tobacco Products and other Novel Tobacco Products, in certain

149 places, imposing Penalties for violations thereof and Providing Funds therefore, to instill  
150 Health Consciousness and for other purposes (Otherwise  
151 known as the "Comprehensive Smoke-Free Ordinance of the Municipality of San  
152 Miguel, Leyte).

153           These 2 Ordinances have been recommended for approval after review, hence,  
154 this representation would like to pass a resolution, approving the said Ordinances. I so  
155 move.

166           As I perused the Ordinance of San Miguel, Leyte, the Provincial Legal Office,  
167 recommended that, any violation of this ordinance should not exceed P2, 500 for the  
168 penalty. But as I look at the ordinance, I see here that the 3<sup>rd</sup> and subsequent offense is  
169 P3,000. So, I strongly suggest to request the Municipality of San Miguel, Leyte, to make  
170 the proper correction on the penal provision that instead of P3,000 it should be P2,500  
171 pesos.

173           I submit, Honorable Chair and Honorable Floor Leader. Yeah, it should be  
174 approved, however, the penalty for the 3<sup>rd</sup> violation should not exceed P2,500 as  
175 mandated by the Local Government Code.
