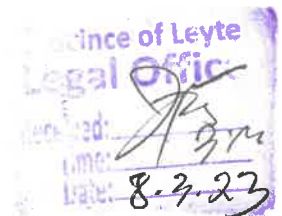

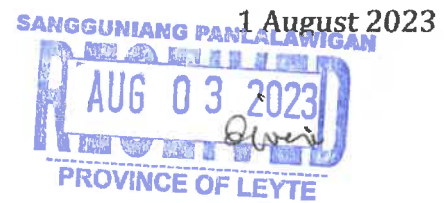

MUNICIPAL ORDINANCE NO. 2023-14

**AN ORDINANCE PRESCRIBING NEW TRICYCLE FARE RATES FOR MOTORCYCLE FOR HIRE AND 3WETAXI FARE MATRIX WITHIN THE JURISDICTION OF THE MUNICIPALITY OF HILONGOS**

Chairperson, Committee on Public Order, Safety and Public Utilities and Transportation

**WHEREAS**, the Federation of Motorcycle Operators and Drivers in the Municipality of Hilongos has submitted their request for tricycle fare increase to the Honorable Council as well as the fare matrix for the 3WETAXI;

**WHEREAS**, a resolution was approved sometime in 2011 regarding tricycle fare rates, but to this date the rate has not been adjusted;

**WHEREAS**, it is of common knowledge that prices of all goods and prime commodities had gone up including gasoline and motorcycle vehicle spare part;

**WHEREAS**, said increases had adversely affected the income of all sectors particularly the transport group;

**WHEREAS**, after its consultation, said request has been considered favorable;

**NOW THEREFORE, BE IT ORDAINED BY THE 16<sup>TH</sup> SANGGUNIANG BAYAN OF HILONGOS** during the regular session assembled, that;

**SECTION 1. TITLE** - This ordinance shall be known as the **"New Tricycle Fare Rates for Motorcycles for Hire and 3WETAXI in the Municipality of Hilongos"**.

**SECTION 2. NEW TRICYCLE FARE RATES** - The New Tricycle Fare Rates in the Municipality of Hilongos is as follows:

**SECTION 3. FARE MATRIX FOR 3WETAXI-** 3WETAXI operates within the Urban Hilongos and has the following fare matrix:

- As regular fare - ₱15.00
- Students (8 years old above) - ₱10.00
- Senior Citizens/ PWDs - ₱10.00
- Pupils/ Children below 7 years old - ₱5.00

Moreover, the fare of cargoes will be the same rate of a regular passenger, while fare during early dawn from Port Area to Poblacion proper will be ₱40.00.

**SECTION 4. SEATING CAPACITY** - the seating capacity of Motorcycle and 3WETAXI must be in consonance with the approved **Municipal Ordinance No. 2018-09** (Ordinance Prohibiting and Regulating the Seating Capacity of Passenger Vehicle on Any Tricycle, School Bus and Other Mode of Public Transportation Within the Municipal Jurisdiction of Hilongos, Leyte And Penalizing Violators Thereof).

**SECTION 5.** All tricycle and 3WETAXI drivers/operators should post or make known to the riding public the regular fare and discounted fare of the privileged sectors and the necessity of presenting their identification cards for the availment of discount for students, persons with disability and Senior Citizens.

**SECTION 6.** The Office of the Sangguniang Bayan shall issue an official Tricycle/3WETAXI Fare Matrix to be given to all Operators, which the driver must post and attach to the inside portion of the tricycle/3WETAXI for the passengers' reference.

**SECTION 7. FINAL PROVISION** - Tricycle/3WETAXI operators/drivers who are found violating this ordinance shall be fined:

- First Offense - ₱500.00
- Second Offense - ₱1,000.00
- Third Offense - ₱2,500.00 or imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the court.

**SECTION 8. SEPARABILITY CLAUSE** - If any provision of this Act is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

**SECTION 9. REPEALING CLAUSE** - pertinent provisions of all other laws, ordinances executive orders and rules and regulations contrary to inconsistent with the provisions of the Ordinance are hereby repealed or modified accordingly.





**MINUTES OF THE PUBLIC HEARING ON COMMITTEE ON PUBLIC SAFETY & ORDER, PUBLIC UTILITIES AND TRANSPORTATION ON WEDNESDAY, MARCH 29, 2023 AT THE HILONGOS MUNICIPAL GYM, BARANGAY WESTERN, HILONGOS, LEYTE.**

The Public Hearing started at 1:50 in the afternoon with a prayer led by Mr. Charleto Mondala, Traffic Officer of HTMG. Thereafter, Ms. Catherine A. Fabular, Secretary to the Sangguniang Bayan, greeted everyone with a pleasant afternoon. Then she introduced and welcomed the presence of Hon. Albert "Bentong" Villahermosa- Municipal Vice Mayor, Hon. Manuel M. Gabisan- Chairperson of the Committee on Public Safety & Order, Public Utilities and Transportation together with the Committee Members: Hon. Manuel V. Lora, Hon. Francisco M. Ortega, Hon. Cris Antonio Ong, Hon. Joyce Kristy P. Flanco and Hon. Edwin Faller (absent). After that, Ms. Fabular handed over the floor to Hon. Manuel Gabisan, Chairperson of the Committee to give an overview about the meeting.

Then, Hon. Gabisan welcomed the presence of Municipal Vice Mayor, PPA Officer/Terminal Port Supervisor, PPA Civil Security Officer, Committee Members, and the driver operators. He explained the purpose of the public hearing which was to discuss and inform the driver operators about the alleged overcharging of fare and other issues or concerns from the complaint of the passengers because it will cause a lot of shame in the town. Hilongos is also the way for all passengers going to other places in Leyte that's why it is necessary to preserve the good image. After that, Ms. Fabular called the presence of the Vice Mayor for his message and as a Presiding Officer of the public hearing.

Hon. Albert "Bentong" Villahermosa, Municipal Vice Mayor greeted everyone with a pleasant afternoon and acknowledged the presence of the Honorables, the Chairperson of the Committee, the visitors especially the PPA Officers, OSCA Chairman, representatives from DEPED, driver operators, PNP Chief and PNP Officers. Then, he said that he had received complaints from passengers before (during his term as a Mayor) about the overcharging of fares and other issues. So, it should be addressed and controlled to prevent increasing "lubag" drivers that will affect good drivers and will reflect the management of Hilongos. According to Hon. Villahermosa, one point to another is part of the service and then the exchange of service. He requested Hon. Joyce Kristy P. Flanco, SK Federation President to read the FB post of "DIY Travel Philippines".

Hon. Joyce Kristy P. Flanco said that "DIY Travel Philippines" is an FB page wherein people (followers of the page) can access it by posting their opinions or criticisms of someone or something. The FB page contains one hundred seventy to one hundred eighty thousand followers. Then, there was a passenger who had a complaint and posted it on the page. Hon. Flanco read the FB post of DIY Travel Philippines about an advisory not to go to hilongos because there were regular colorum tricycle drivers and the overcharging or rampant collecting of fares.

Hon. Villahermosa added that they will not discriminate against the passengers and find a way or solution to the problem. He asked the operators for suggestions, and the following were recommended solutions from the operators:

- They are not allowed from operating or driving the tricycle/electric trike. (agreed by everybody)
- Hon. Gil Barbusa suggested suspension for half a month.
- Mr. Angelito Barraca, President of Route 6 suggested suspension for 1 month.
- Mr. Barraca stated his concern about colorum drivers. (motorcycle/tricycle, racal, & badja). He also suggested that if there is one "lubag" driver on Route 6, they will be all suspended.
- Mr. Antonio "Odo" Suarez, Traffic Officer said that it has an existing penalty of ₱200.00 for overcharging of fare.

**Proposed Rate/Penalties, Recommendations & Suggestions**

- Hon. Gabisan suggested a Penalty of ₱1,000.00 (first offense) for the operator. (overcharging)
- Hon Gabisan recommended the "First Come First Serve" for those vehicles or "potpot" drivers lining up for passengers at the port.
- Children must be prioritized first in riding the vehicle.

**Comments, Suggestions or Recommendations of the Committee Members, Operators & Visitors**

- Mr. Melvin Narajos, Terminal Manager of PPA- on his remarks about the drivers and Taripa. (overcharging of fares)
- According to Hon. Villahermosa, they will have a Special Meeting on Monday regarding the Taripa and colorum drivers together with the traffic officers/enforcers and concerned Presidents from each route.
- Policy for "lubag"
- Hon. Villahermosa said that the driver will be restricted from driving while the operator will be fined with ₱500.00 (approved by the body).
- Problem: Identifying the driver  
Solutions:
  - The ID should be hung up on the tricycle/vehicle.
  - An announcement will be posted on social media (Facebook- Hilongos Info Page) stating that if anyone gets caught, they will be reported to the Office of the Traffic.
- Benefits for the drivers thru TUPAD.
- Hon. Gabisan suggested,
  - a total of ₱80.00 (consists of 4 passengers or if only 1 passenger) every travel of the racial (e-trike) or ₱20.00 per passenger during the dawn (2:00 AM - 6:00 AM). Then, back to normal daily fare (7:00 AM onwards).
  - To amend the Ordinance.
- PMAJ Ambrocio V. Demain, PNP Chief, greeted and acknowledged everyone who attended the public hearing. Then, he said that if they would found out during the investigation that there was intimidation, the driver/operator would be filed with forced intimidation or robbery with forced intimidation.
- Hon. Manuel V. Lora, SB Member/Committee Member- on the application for the franchise and gave a message about the issues and concerns regarding the overcharging of fares.
- Hon. Francisco M. Ortega, SB Member/Vice Chairperson of the Committee- said that the operators and drivers must abide the laws.
- Mr. Jose Malda of Brgy. Pa-a, the Operator of Racial- requested a regular meeting of the association to follow up with their drivers or members.
- Hon. Villahermosa advised encouraging the Colorum drivers to be informed about registration.
- Other Matters

After some discussions, the Vice Mayor ended the public hearing. Without any other items to deliberate on, the public hearing was adjourned at 3:25 in the afternoon.

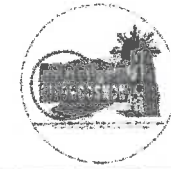
