AN ORDINANCE PRESCRIBING THE ROOM RATES, LABORATORY AND OTHER HOSPITAL SERVICES FEES IN THE JAVIER MUNICIPAL INFIRMARY.

WHEREAS, endorsed to the Sangguniang Bayan are the rates of the infirmary rooms, laboratory tests and other hospital services at the Javier Municipal Infirmary for the purpose to sustainably make it economic enterprise healthcare facility ;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Javier, Leyte, **THAT :**

SECTION 1. There is hereby prescribed rates and fees enumerated hereunder for the services rendered and medicines administered at the Javier Municipal Infirmary which shall be collected to all in-patients and out-patients :

SECTION 2. The use of Patient-Owned Appliances such as electric pot, electric fan, cell phone charging, transistor radio, CD and DVD Player, Computer or other gadget electrically charged to the electric current of the infirmary shall be exacted of P 50.00/day.

SECTION 3. Special discounts shall be availed by the following :

3.A- Javier municipal officials and employees including those employed in the Javier Municipal Infirmary, their spouses and unmarried children (below 21 years old) , shall be given Twenty Percent (20%) discount after PhilHealth deductions from the total bill except pharmacy items.

3.B- Senior Citizens (SC) and Persons With Disability (PWD) residing in Javier, Leyte shall be given Twenty Percent (20%) discount after PhilHealth deductions from the total infirmary bill. However, those Senior Citizens residing outside of Javier, Leyte cannot avail the twenty percent (20%) discount but can utilize their PhilHealth benefits.

SECTION 4. All ordinances, rules and regulations, or parts thereof in conflict, or inconsistent herewith, are hereby repealed, amended or modified accordingly.






