Referred to this committee is Ordinance No. 2023-175 of the Sangguninag Bayan of Carigara, Leyte entitled "AN ORDINANCE RECLASSIFYING THE THREE HUNDRED (343), SQUARE METERS PARCEL OF LAND IDENTIFIED AS LOT NO. 86, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 115-2019000229, and TAX DECLARATION NO. 08-11-0012-00660, IN THE NAME OF ARVYNN R. APILADO, LOCATED AT BRGY. BALILIT, CARIGARA, LEYTE, FROM AGRICULTURAL TO RESIDENTIAL USE."

The said ordinance was referred to this committee for further study in connection to the commitment of the Department of Agrarian Reform (DAR)<sup>1</sup> to guard all remaining arable agricultural lands against conversion into other uses. This declaration actually was made by DAR Undersecretary Luis Pangulayan during a media forum after President Ferdinand "Bongbong" Marcos' signed the New Agrarian Emancipation Act.

There are however no issuances yet of any concrete guidelines, through a memorandum or an executive order for the total ban of the conversion of lands, or in this case the reclassification of lands, after the determination by the concerned Sangguniang Bayan, pursuant to Section 20 of the Local Government Code.

Further, a careful study of the said declaration by the DAR, what is being referred to by the department is the prevention of those wanton, unrestrained and excessive conversion of those agricultural lands that are worked, tilled and ploughed regularly under a system of crop rotation.

It also observed by the committee that the subject property of Ordinance 2023-175 is only a THREE HUNDRED FORTY - THREE SQUARE METER parcel of land, which as determined by the Sangguniang Bayan of Carigara, through recommendation of its Committee on Land Use and Agrarian Reform, would be of more economic value if reclassified from agricultural to residential.

Considering the foregoing, this committee affirms the recommendation of the Provincial Legal Office to declare valid Ordinance No. 2023-175 of the municipality of Carigara.

Referred to this committee is the letter of Mr. Eduardo P. Veloso, who is the applicant for a certificate of title of that portion of an abandoned old Spanish Road/Provincial Road located at Brgy. Maybog, Baybay City, covering an area of 10,362 Square meters.

In his letter dated, March 27, 2023, the same submitted his application for titling accompanied with the following documentary support, to wit;

1. Tax Declaration No. 07-0072-00605 with Property Identification No. 044-07-072-03-075, with assessors Lot No. 075;
2. City Engineering Office Certification dated April 18, 2023 and City Planning and Development Office Certification, dated February 16, 2023. Both certifications attest that the lot covered by Tax Declaration No. 07-0072-00605 with an area of 10,362 Square meters, situated at Brgy. Maybog, Baybay City is classified as an Agricultural Zone (AGZ) based on the approved CLUP of the city of Baybay;
3. Certification from the Office of the Barangay Chairman of Brgy. Maybog, dated February 16, 2023, attesting that the lot being referred to which was formerly used as Spanish Road is now a rice field is owned, possessed, occupied and cultivated by the late spouses Nicolas Veloso and Emerenciana Veloso since the year 1940 and now inherited by Eduardo Veloso. Further attesting that the said lot with an area of 10,362 Square meters is free from claims and conflict;
4. Certification from the Regional Trial Court Br. 14, Baybay City, attesting that Cad. Lot No. )ld Spanish Road with an area of 10,362 Square meters covered by Tax Declaration No. 07-0072-00605 with Property Identification No. 044-07-072-03-075 has not been posted as bail bond in any Criminal Case, nor is it a subject of any pending Civil Case, Cadastral or Land Registration Cases;
5. Report from MARIO R. COSTA, LMO III/Special Investigator (Designate) of the Community Environment and Natural Resources Office, Baybay City, dated October 9, 2017, recommending the issuance of a survey authority for the survey of the said abandoned Spanish/Provincial Road, abutting Lot 8422 and 8411, PSC 5, situated at Brgy. Maybog, Baybay City on the following ground after investigation and inspection:

- a. That it is free from claims and conflict;
- b. That it is not covered by any subsisting Public Land Application;
- c. That it is not subject by any civil, land registration and cadastral case;
- d. That it does not have any certificate of title;
- e. That subject land is agricultural lot in plain terrain;
- f. That it is within alienable and disposable zone per LC Map No. 648, Project No. 9, Certified on April 26, 1927;
- g. That realty property taxes had been paid thereon by Eduardo Veloso from 2004 to 2017;
- 6. Certification from CENR Officer ELIAS AYA-AY, JR, of the Community Environment and Natural Resources Office, Baybay City, dated January 10, 2013 as projected by ELWIN R. VILLAFLORES, Engineer III;
- 7. Certification from Community Environment and Natural Resources Office, Baybay City, dated August 9, 2018 at Baybay City, attesting that abutting Lot 8422 and 8411, PSC 5, situated at Brgy. Maybog, Baybay City is not covered by any subsisting Public Land Application.

Mr. Eduardo P. Veloso is seeking for a resolution "interposing no objection" from the Sangguniang Panlalawigan to support his application for titling. It is observed however, that while the applicant submitted several certifications, some of which, particularly those certifications coming from Community Environment and Natural Resources Office, Baybay City are dated six (6) or ten (10) years past. *Further* it is again stressed that while the resolution being sought for is issued by the Sangguniang Panlalawigan, the said request may actually require an executive act as this may involve a disposal of a property of the provincial government.

It is then recommended that the following documents be submitted to the Sangguniang Panlalawigan by the applicant:

- a. Latest pertinent certifications from the Community Environment and Natural Resources Office, Baybay City particularly certifying that:
  - i. The subject land is not covered by any subsisting Public Land Application;
  - ii. That it is not subject to any case within the jurisdiction of the concerned CENRO;
  - iii. That the land is classified as alienable and disposable;
- b. Lot numbers, names, occupants of the land and adjacent land owners and/or affidavit of no objection from the occupants of the land and adjacent land owners;
- c. Certification from the City Assessors Office stating among others the Lot numbers and Tax Declarant of the adjacent lots;
- d. Certification from the Barangay enumerating the occupants of the land and/or that the subject land does not have any other occupants other than the applicant;
- e. City Planning and Development Office Clearance that the subject property is not covered or part of any future project of the city of Baybay;

For the meantime, this letter request of Mr. Eduardo P. Veloso is hereby noted, subject to the compliance set forth in the recommendation of the committee.



468 **HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER**

469 Thank you, Mr. Chair.

470 The next 2 Items, Items 2 and 3 are Ordinances from Villaba.

471 Will you please recognize the Honorable Remandaban, Mr. Chair?

472 **HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5<sup>TH</sup> DIST. BOARD MEMBER**

473 The Honorable Maricor Remandaban is recognized.

474 **HON. MA. CORAZON E. REMANDABAN: 3<sup>RD</sup> DISTRICT BOARD MEMBER**

475 Thank you, Mr. Chair, Mr. Floor Leader.

476 For Items 2 and 3 are Ordinances both coming from Villaba, Leyte.

477 Item No. 2, is Municipal Ordinance No. 38, s-2023-2025 of Villaba, Leyte, “An  
478 Ordinance Requiring Commercial Service Establishment and other Places and Spaces  
479 considered as High Risk to Install Video Surveillance Cameras or Closed-Circuit  
480 Television and Providing Penalties for violations thereof and for other purposes.”

481 And for Item No. 3 is Municipal Ordinance No. 39, s-2023-2025 of Villaba, Leyte,  
482 entitled, "An Ordinance Enacted to Establish a Poultry and Livestock Auction Market  
483 Center in the Municipality of Villaba, Promulgating Rules and Regulations for the  
484 Operation, Management and Maintenance; Prescribing Fees and Rates of its offered  
485 services; and penalties for violation, providing penalties for violation, providing funds  
486 and for other purposes thereof."

487 Mr. Chair, both Ordinances are valid pursuant to its power under Section 56(c) of  
488 RA 7160 and are likewise in consonance with Section 16 or the general welfare clause  
489 of the code. However, there are requirements that these Ordinances need to comply.  
490 For Ordinance No. 38 Series 2023-25, they need to provide clarification on the penalty  
491 clause as stated in the observation of the Provincial Legal Office and also, they need to  
492 submit the Certificate of Posting.

493 And for Ordinance No. 39, they need to provide Certificate of Posting and  
494 Minutes of the Public Hearing because they only attached the Notice of Hearing and  
495 the Attendance. So, Mr. Chair, I move to return both Ordinances to the SB of origin for  
496 the Municipality of Villaba, Leyte to comply with the mentioned requirements. I so move.

497 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

498 Second.

499 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5<sup>TH</sup> DIST. BOARD MEMBER

500 There is a move by the Honorable Maricor seconded by Carlo, to return both  
501 Items 2 and 3. Just specify the reasons why we returned both Ordinances in the  
502 resolution.

503 HON. RONNAN CHRISTIAN M. REPOSAR: 1<sup>ST</sup> DISTRICT BOARD MEMBER

504 May I be recognized, Mr. Chairman?

505 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5<sup>TH</sup> DIST. BOARD MEMBER

506 Yes, the Honorable Reposar.

507 HON. RONNAN CHRISTIAN M. REPOSAR: 1<sup>ST</sup> DISTRICT BOARD MEMBER

508 In addition to the observation of Honorable Remandaban, I think there is only  
509 what we see a Notice of Public Hearing but I think the Minutes of Public Hearing and the

510 Attendance as well is lacking from Ordinance No. 38, series 2023-25. Same as in  
511 Ordinance No. 39, series of 2023-25. If the movant is amendable, I would suggest that  
512 the same is included for additional compliance.

513 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5<sup>TH</sup> DIST. BOARD MEMBER

514 For additional compliance.

515 So, anymore queries, corrections?

516 None, so, approved.

517 Approved unanimously.

587 provision of Section 187 which is the conduct of public hearing in order that it may be  
588 consider not excessive. So, there is no Certificate of Public Hearing that a public  
589 hearing has been conducted and the minutes, attached to this ordinance. Hence, it is  
590 suggested that the Municipality of Javier be advised to furnish us the copy of the  
591 Minutes of Public Hearing and the Certificate of Posting. Thank you, very much.
