





ORDINANCE NO. 23-13 SERIES OF 2023

AN ORDINANCE AUTHORIZING THE TEMPORARY ROAD CLOSURE OF SAN JOAQUIN STREET STARTING FROM THE CORNER OF STO. NIÑO ST. TO THE BOUNDARY BEFORE BURABOD ELEMENTARY SCHOOL, FOR A PERIOD OF ONE (1) YEAR FROM AUGUST 2023 – AUGUST 2024, TO PAVE THE WAY FOR THE ONGOING CONSTRUCTION OF BURAUEN HEALTH AND WELLNESS BUILDING

BE IT ORDAINED, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 - Authority to Close Roads. The Sangguniang Bayan is empowered to temporarily close roads or alleys, pursuant to Section 21 (a)(c), Chapter II, Book I, Title I, Republic Act No. 7160, otherwise known as the Local Government Code of 1991which states:

"Section 21. Closure and Opening of Roads.-

- (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.
- (c) Any national or local road, alley, park or square may be temporarily closed during... an undertaking of public works....".

SECTION 2 - Road to be Temporarily Closed. Effective August 1, 2023 up to August 31, 2024, San Joaquin St. starting from the corner of Sto. Niño St. to the boundary before Burabod Elementary School, shall be temporarily closed, to fully mobilize the construction and delivery of aggregates for the ongoing construction of Burauen Health and Wellness Building;

SECTION 3 - Administrative Provision. The Office of the Municipal Mayor, through the Office of the Municipal Engineer and Traffic Enforcers shall provide the necessary mechanisms, in the implementation of this ordinance;

The Construction Engineer shall provide the necessary traffic signages, and provide safety precautionary measures to protect the riding public, motorists and pedestrians.

SECTION 4 - Effectivity. This ordinance shall take effect upon approval.
