

Municipal Ordinance No. 155 s. 2023

AN ORDINANCE INTEGRATING THE BARANGAY CLEARANCE FEE TO THE BUSINESS PERMITS AND LICENSING SYSTEM UNDER SEC. 11 OF RA. NO. 11032 ALSO KNOWN AS EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018, IN THE MUNICIPALITY OF SAN ISIDRO, PROVINCE OF LEYTE.

WHEREAS, Section 27 of the Philippine Constitution provides that the State shall maintain honesty and integrity in the public service and take positive and effective measures against graft and corruption;

WHEREAS, the government as it tries to curb the graft and corruption practices in the government offices/agencies, enacted laws such as R.A. 9485 also known as the Anti-Red Tape Act of 2017 to eliminate red tape and to simplify frontline service procedures, formulate service standards to observe in every transaction, and make known these standards to the client.

WHEREAS, R.A. 11032 also known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 was enacted on May 2018 by amending R.A. 9485 to provide a program for the adoption of simplified requirements and procedures that will reduce red tape and expedite business and non-business related transactions in government. "This law seeks to streamline the delivery of government services by (a) prescribing the processing time; (b) streamlining procedures for issuing licenses, clearances, permits or authorizations; (c) automatically approving applications not acted upon within the prescribed processing time; (d) mandating a "zero contact policy" concerning an application or request, except during submission of documents; and (e) establishing a central business portal to receive and capture application data on business-related













transactions, and provide links to online registration of national government agencies";

WHEREAS, Section 11 of the same Act provides that "Barangay Clearances and permits related to doing business shall be applied issued and collected at the Municipality in accordance with the prescribed processing time of the said act. Provided, that the share in the collections shall be remitted to the respective barangays;

WHEREAS, in compliance with the mandate of the barangays provided in RA. 11032, the 19 barangays in the Municipality of San Isidro enacted ordinances authorizing the Municipality of San Isidro, Leyte to issue clearances and collect corresponding fee in the application for any business related transactions cited in Section 11 of R.A. 11032;

NOW, THEREFORE, be it Enacted by the Sangguniang Bayan of San Isidro in session assembled:

Section 1. COVERAGE. This policy applies only to the issuance of Barangay Clearance for business permit and locational clearance (as a requirement for the issuance of building permit) at the Municipality. Other clearance not mentioned in this ordinance shall still be secured at the Barangay.

Section 2. DEFINITION OF TERMS. As used in this Ordinance, the following terms and phrases shall mean as follows:

1. Barangay Clearance - refers to any and all documents issued by the barangays with or without corresponding fees as defined in their ordinances relative to or in relation to the issuance of business permit and locational/zoning clearance by this municipality or any other permit as may be required. (IRR of R.A. 11032)

2. Barangay Clearance Fees – is an amount imposed by the barangays through an ordinance and collected by the municipality in relation to the issuance of business permit and locational/zoning clearance by this municipality.

3. Business Permit – is a document that must be secured from the municipal government, usually through its Business Permits and Licensing Office(BPLO), for a business to legally operated in the locality.

4. Electronic Signature – is any distinctive mark, characteristic and/or sound in electronic form, representing the identity of the person and attached to or logically associated with the electronic data message or electronic document or any methodology or procedures employed or adopted by a person and executed or adopted by such person with the intention of authenticating or approving an electronic data message or electronic document.

5. Locational Clearance — is a clearance issued by the Zoning Administrator/Zoning Officer to a project that is allowed under the provisions of an ordinance in this municipality.

6. Permit – is a permission evidenced by a certificate by the concerned government agency or instrumentality;

Section 3. AUTHORITY TO COLLECT BARANGAY CLEARANCE FEE OR BUSINESS RELATED TRANSACTIONS. The Municipal Treasurer's Office (MTO)

of San Isidro, Leyte shall have the authority to collect *barangay clearance fee* subject to the remittance to the concern barangay.

Section 4. RATE OF BARANGAY CLEARANCE FEE TO BE COLLECTED. The rate of the barangay clearance fee to be collected by the Municipal Treasurer's office shall be computed based on their approved Barangay Revenue/Tax Ordinance.

Section 5. BARANGAY CLEARANCE SIGNATORY. – Electronic signature of Punong Barangay concern shall appear in all barangay clearance issued by the business permitting and licensing office or MTO.

Section 6. REPORTING AND REMITTANCE. – The MTO shall remit the Barangay Clearance Fee collected to the subject Barangay not later than seven (7) days of the ensuing month with the list of the issued Building and Business Permit.

Section 7. SEPARABILITY CLAUSE. – if for any reason, a part of this Ordinance is declared illegal or invalid, other parts of provisions hereof which are not affected thereby shall remain valid and in full force and effect.

Section 8. REPEALING CLAUSE. - All ordinances, local laws or part thereof inconsistent with the provisions of this ordinance are hereby deemed modified or repealed accordingly.

Section 9. EFFECTIVITY. - This Ordinance shall take effect ten (10) days after its posting or publication in compliance to Section 59 of R.A. 7160.
