- 3. SR. ADMINISTRATIVE ASSISTANT I (BUYER III) (SG 13);
- 4. VETERINARIAN III (SG 19);
- 5. INFORMATION SYSTEM ANALYST II (SG 16);

WHEREAS, there is a need to rectify the position title SR. ADMINISTRATIVE ASSISTANT I (BUYER III) (SG 13) to SR. ADMINISTRATIVE ASSISTANT I (BUYER V) (SG 13), pursuant to Department of Budget Management (DBM) Local Budget Circular No. 137 dated July 13, 2021, with subject: Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU) 2021 Edition, stating that Senior Administrative Assistant I, Salary Grade 13 is the generic class title of BUYER V;

Section 3. Qualifications, Powers, Duties and Responsibilities. The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Sovernment Code of 1991 and Civil Service Commission (CSC) and other related laws.

4. Repealing Clause. Any ordinance found inconsistent hereof, in whole or in part, is hereby repeated or modified accordingly.

Section 5. Effectivity. This ordinance shall take effect immediately upon approval.
