

RESOLUTION STRONGLY SUPPORTING SENATE BILL NO. 1378 FILED BY SENATOR MARK A. VILLAR, ENTITLED: "AN ACT PROVIDING FOR AN INCREASE AND AUTOMATIC ADJUSTMENT MECHANISM IN THE PERSONNEL ECONOMIC RELIEF ALLOWANCE (PERA) GRANTED TO GOVERNMENT EMPLOYEES."

WHEREAS, submitted to Sangguniang Panlalawigan of Sorsogon was Resolution No. 2023-352 of the Sangguniang Panlalawigan of Benguet strongly supporting Senate Bill No. 1378 of the 19th Congress which provides for an increase in the Personnel Economic Relief Allowance (PERA) granted to government employees;

WHEREAS, the current PERA that government employees receive is only Two Thousand Pesos (Php2,000.00) which is no longer enough to achieve its intended purpose, considering the continuing and uncontrolled escalation of prices of basic commodities aggravated by high inflation rate in the Philippines;

WHEREAS, an increase of the PERA to P4,000 per month as provided in Senate Bill No. 1378 would be of great benefit to government employees in this time of economic crisis;
