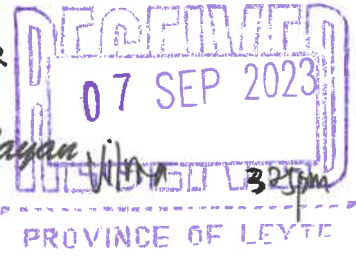

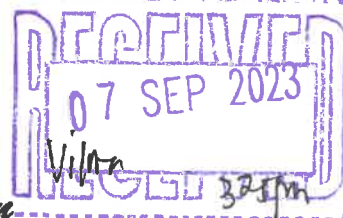

Section 4. Responsibilities, duties and function.

General:

Supervises the conduct of agricultural research, analysis, and related activities that will promote an efficient extension service and implements the program/thrusts of the office.

Specific:

- Directs and supervises the preparation of programs on crops, livestock, fishery, home extension and rural health development.
- Supervise the gathering, processing and the analysis of data information necessary for planning and programming.
- Supervises the preparation of summary reports on the various programs.
- Coordinate with other agencies for necessary inputs on programs preparation;
- and does other related works.

Section 5. Created positions shall be appointed by the municipal mayor subject to the civil service laws rules, and regulations.


Section 6. Appropriation. The budgetary requirement for personal services shall be sourced from the general fund of the LGU, subject to Section 76 of R.A 7160.

Section 7. Effectivity: This ordinance shall take effect upon its approval by the Sangguniang Panlalawigan.
