

#### **MUNICIPAL ORDINANCE NO. 2023-06**

AN ORDINANCE CREATING A TECHNICAL WORKING GROUP TO REASSES, REVISE, AND UPGRADE BARANGAY BOUNDARIES IN THE MUNICIPALITY OF PALO, LEYE, AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, the continued development of Municipality of Palo, Leyte, as an economic, industrial, agricultural, cultural and historical Hub (Center) in Leyte has created a new and greater pressure and demand on systems and policies in the governance of the locality.

WHEREAS, Barangay Officials and stakeholders from barangays have expressed their observation that extent and degree of the existing legislation providing for Barangay Boundaries need reassessment, revision, and upgrading to address existing and future conflicts that would arise therefrom. Hence, this Ordinance:

SECTION 1. TITLE. - "An Ordinance Creating a Technical Working Group to Reassess, Revise, and Upgrade Barangay Boundaries in the Municipality of Palo, Leyte, and Appropriating Funds Thereof."

SECTION 2. DEFINITION OF TERMS - for the purpose of implementing the provisions of this guidelines, the following terms shall apply:

> (a) Assess – evaluate or estimate the nature, ability or quality; to determine the rate or amount of; to make an official evaluation of property for purpose of.

(b) Revise – re- examine and make alteration to; to look over again in order to correct or improve; to study again review; to look at or consider again an idea, piece of writing etc. in order to correct or improve it.

- (d) Re-Assessment a periodic revelation of a property's value of tax purposes.

**SECTION 3. CREATION ON TECHNICAL WORKING GROUP** – There is hereby created a Technical Working Group (TWG) that will reassess, revise and upgrade the existing Barangay Boundaries in the Municipality of Palo.

**SECTION 4. FUNCTIONS** - The Technical Working Group shall perform the following functions:

- to review the existing boundaries of the different Barangays of the Municipality of Palo, determining the scope and degree of its implementation and compliance, coordination with concerned local and national agencies;
- compile, gather data and facilitate, conduct actual cadastral survey on the boundaries of each barangay, which includes the existing metes and bound of the barangay;
- oversee the formulation and execution of mechanism for public consultation, to include public opinion survey among the barangay residents, and other related issues as the Technical Working Group may see fit;
- 4. formulate recommendations, for the revision and upgrading of the Barangay Boundaries, based on the findings of the aforementioned data gathering methods;
- 5. formulate guidelines for possible inclusion of House Numbering taking into consideration on existing ordinance and guidelines.
- 6. submit recommendation(s) to the Office of Municipal Mayor and Sangguniang Bayan, in aid of legislation, for approval.

**SECTION 8. EFFECTIVITY** – This Ordinance shall take effect upon its approval and after the required posting and publication as provided for under the Local Government Code of 1991.
