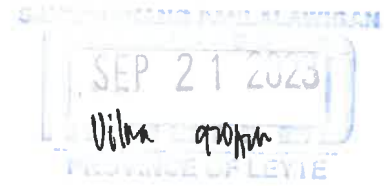

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2023-17 of the Sangguniang Bayan of Julita, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160, the same being to the opinion of the Provincial Legal Office (PLO), an exercise of the power authorized under Section 447 (2)(ii)ⁱ of the Code. ⁱ "Section 447 (2)(ii) - Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the municipality as provided for under section 18 of this Code with particular attention to agro-industrial development and countryside growth and progress, and relative thereto, shall:

Subject to the provisions of Book II of this Code and applicable laws and upon the majority vote of all the members of the Sangguniang Bayan, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs;"

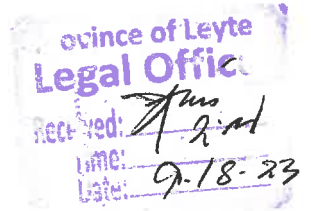

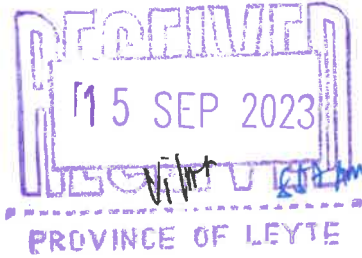

MUNICIPAL ORDINANCE NO. 2023-17

AN ORDINANCE CHARGING FEES FOR REQUEST OF COPIES OF LIVE BIRTH, CERTIFICATE OF NO MARRIAGE (CENOMAR), MARRIAGE CERTIFICATE, DEATH CERTIFICATE AND CERTIFICATE OF NO DEATH RECORD (CENODEATH) USING THE BATCH REQUEST QUERY SYSTEM (BREQS) OF THE PHILIPPINE STATISTICS AUTHORITY (PSA) IN THE MUNICIPALITY OF JULITA, LEYTE.

WHEREAS, Section 5, Article X of the 1987 Philippine Constitution provides that "each local government unit shall have the power to create its own sources of revenues and to levy taxes, fees and charges subject to such guidelines and limitations as the Congress may provide, consistent with the basic policy of local autonomy. Such taxes, fees and charges shall accrue exclusively to local governments";

WHEREAS, the Philippine Statistics Authority (PSA) has developed the BATCH REQUEST QUERY SYSTEM (BREQS), a system that will be utilized by Local Government Units which provides for an off-line method of encoding request for civil registry documents;

WHEREAS, the Local Government Unit of Julita, Leyte had decided to avail this kind of service from the PSA thereby helping its constituents lessen the burden of securing the different civil registry documents as well as earn some revenue on it.

WHEREFORE on motion of the Hon. Mark Joy E. Macaso, duly seconded by the Hon. Geraldine S. Daya, the Hon. Aliana Marie R. Tubi and the Hon. Jude Andrei M. Romualdez,

BE IT, ENACTED BY THE SANGGUNIANG BAYAN OF JULITA, LEYTE IN SESSION ASSEMBLED THAT:

SECTION 1. Title. This Ordinance shall be known as **AN ORDINANCE CHARGING FEES FOR REQUEST OF COPIES OF LIVE BIRTH, CERTIFICATE OF NO MARRIAGE (CENOMAR), MARRIAGE CERTIFICATE, DEATH CERTIFICATE AND CERTIFICATE OF NO DEATH RECORD (CENODEATH) USING THE BATCH REQUEST QUERY SYSTEM (BREQS) OF THE PHILIPPINE STATISTICS AUTHORITY (PSA) IN THE MUNICIPALITY OF JULITA, LEYTE.**

SECTION 2. Imposition of Fees. There shall be collected for services rendered by the Municipal Local Civil Registrar of this municipality the following fees.

SECTION 3. Time of Payment. In availing the BREQS System payment of its corresponding fees shall be paid to the Municipal Treasure's Office and that all of its payments shall accrue to the General Fund of the municipality.

SECTION 4. Separability Clause.

If any provision of this Ordinances be held invalid other parts or provisions that are not affected thereby shall continue to be in full force and effect.

SECTION 5. Effectivity.

This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.




