Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 1 CY 2023** of the **City of Baybay**, **Leyte duly** enacted by the Sangguniang Panlungsod through **Appropriation Ordinance No. 01**, **S-2023** with a total appropriation in the amount of **P159,240,307.57**, forwarded to this level for preliminary review, reveals compliance with the same law and its Implementing Rules and Regulations (IRR), except for the following:


Attention is hereby invited to Section 5 of the Civil Service Commission (CSC) Memorandum Circular (MC) No. 12, series of 2022 which provides that the creation and funding of optional positions may be allowed after the mandatory positions have been created.

The following positions are being identified as mandatory positions under CSC MC No. 12, s. 2022

- 1. City Agricultural and Biosystems Engineer
- 2. City Cooperatives Development Officer
- 3. City Persons with Disability Affairs Officer
- 4. City Public Employment Service Office Manager
- 5. City Senior Citizens Affairs Head, and

In view thereof, appropriations for the creation of the said optional positions is hereby deferred until such time that the mandatory positions have been created.

- 2. That the reversion of appropriations is duly authorized by the concerned officials and are made available to support the expenditures under Supplemental Budget No. 1;
- 3. That the preparation of the Annual Investment Program / Supplemental Investment Program No. 1 shall follow the referencing coding structure prescribed per Budget Operations Manual for Local Government Units. The prescribed coding structure is presented below:



- 4. That the program Poverty Mitigation (AICS) amounting to P3,000,000.00 shall be supplied with proper object of expenditure and account code under column 4 & 5 of LBP Form No. 9;
- 5. That additional appropriation for Terminal Leave Benefits/Monetization of Leave Credits shall be subject to CSC guidelines and Budget Circular No. 2016-2:

- 8. That the procurement of Goods, Supplies, Civil Works and related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations, and
- 9. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

WHEREAS, the Local Chief Executive submitted the 1st Supplemental Budget for CY 2023 of the City of Baybay in the amount of One Hundred Fifty-Nine Million Two Hundred Forty Thousand Three Hundred Seven and 57/100 (P159,240,307.57) pesos.

WHEREAS, the members of this honorable council carefully scrutinized and perused the said supplemental budget including attachments thereof;

WHEREAS, the said 1st Supplemental Budget for CY 2023 of the city of Baybay was unanimously declared to be in accordance with existing laws, rules and regulations

WHEREFORE, on motion of Honorable Dominic Junie F. Murillo, SP Chair on Finance and Appropriations, and duly seconded by Honorable Jorge V. Rebucas and Honorable Jose L. Bacusmo, SP Members.

BE IT ORDAINED, by the 6th Sangguniang Panlungsod of the City of Baybay in its 26th Regular Session assembled on July 20, 2023, at the Session Hall, Legislative Building, this city, an Appropriation Ordinance is hereby adopted, to wit:

Section 1. TITLE: This Ordinance shall be known as, "AN ORDINANCE ADOPTING AND APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF THE CITY GOVERNMENT OF BAYBAY FOR CY 2023 IN THE AMOUNT OF ONE HUNDRED FIFTY-NINE MILLION TWO HUNDRED FORTY THOUSAND THREE HUNDRED SEVEN AND 57/100 (P159,240,307.57) PESOS".
