#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 2 CY 2023** of the **Municipality of Tabango**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2023-02** with a total appropriation in the amount of **P3,793,790.86**, reveals substantial compliance with the same law and its implementing Rules and Regulations.


