172	Mr. Chairman, I subscribed to the observation of the Provincial Legal Officer as
173	follows:
174	"That Ordinance No. 440 intends to grant "Cash Incentives" to passers and
175	Topnotchers of Board, Bar and other National Licensure Examinations;
176	That the subject ordinance, aims to inspire graduates to strive harder to be on
177	top of their chosen fields."

178	However, the source of funds under Section 7 of the same ordinance directs the
179	Municipal Budget Officer to set aside necessary funds without any clear source as to
180	where the funds are to be taken.
181	But under Section 335 Chapter 4 of the Local Government Code, which states that,
182	"No public money or property shall be appropriated or applied for religious or any other
183	private purposes."
184	On view thereof, it has been observed by the Provincial Legal Office, it opines that
185	a revision be made on the subject ordinance where the funds are to be sourced out in
186	reference to the cash incentives which will be intended to be given to the Board Passers
187	and Topnochers.
188	In that note, Mr. Chair, I agree with the Provincial Legal Office that the same
189	ordinance be reviewed in so far as the source of funds or the funding of the said cash
190	funds, Mr. Chair.
191	With that being said, Mr. Chair, I move that this ordinance be returned to the SB of
192	the Municipality of Babatngon to review the source of funding of the said cash incentive.
