There are 3 Ordinances coming from the Municipality of Villaba. 307 Ordinance No. 36, Series of 2023-2025, entitled, "The Municipal Investments and 308 Incentives Code of the Municipality of Villaba, Leyte." This has been reviewed by the 309 Provincial Legal Office and they are recommending for the declaration of its validity 310 311 pursuant to its power under Section 56 (c) of RA 7160 and also Section 447 of the Local

Government Code, which enhances and maximizes revenues and resources for

development plans, program objectives and priorities of the municipality as provided for under Section 18 of the same Code.

Ordinance No. 37, series of 2023-2025 of Villaba, Leyte, entitled: "Strengthening Participatory Governance in the Municipality of Villaba through the Empowerment of Civil Society Organizations, Establishing a People's Council, Prescribing its Powers and Functions, and Providing for their Participation in the Local Legislative Process, and Local Board, Councils, Committees, Task Forces and Similar Work Groups."

This has been recommended for the declaration of its validity by the Provincial Legal Office, pursuant to its power under Section 56 and Section 34, 35, and 36 of the Local Government Code, which enhances Local Autonomy, Empowerment and Participation, to the benefit of the municipality and its constituents.

And lastly, is Municipal Ordinance No. 41, series of 2023-2025 of the Municipality of Villaba, Leyte, entitled, "An Ordinance Implementing the "Bantay African Swine Fever (ASF) sa Barangay" or "Babay ASF" in the Municipality of Villaba, Province of Leyte, providing funds and imposing penalty for the violation thereof and for other purposes." This also has been reviewed by the Provincial Legal Office and they are recommending for the declaration of its validity pursuant to its power under Section 56 of the Code and also Section 447 which seeks to approve measures and adopt quarantine regulations to prevent the introduction and spread of diseases."

For example, I have a sample 923 here in my cellphone, the Environmental Code of Leyte. We input a copy of the 924 ordinance and then in ten minutes, the Artificial Intelligence software produced a 925 module, ten modules. It's a lecture, a kind of lecture. So, it can be used for any purpose. 926 And for our purposes here, considering that we lack classrooms, it is a viable possibility 927 to have virtual classrooms. And the teachers can be assisted to become even better. 928 929 We can produce better material, modules. In which case, we have scheduled, I have invited him for a meeting with the Governor, the Provincial Board and the School Board 930 tomorrow, 10:00 in the morning. He also has a meeting with DepEd tomorrow afternoon, 931 932 I think 2:00 in the afternoon.

933	So, also in speeches, maghihimo ka hin speech, the program can prepare a		
934	power point for you. And also videos, poyde maghimo hin videos. It's amazing, the		
935	possibilities.

937	A minute, Mr. Chair. Is this not an insult to our intelligence? Tell Al to run in the		
938	next election, before he teaches us.
