

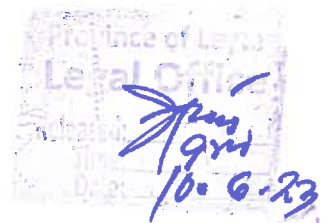

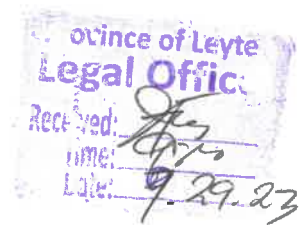

ⁱ Local Government Code - If the sangguniang panlalawigan finds that such an ordinance or resolution is beyond the power conferred upon the sangguniang panlungsod or sangguniang bayan concerned, it shall declare such ordinance or resolution invalid in whole or in part. The sangguniang panlalawigan shall enter its action in the minutes and shall advise the corresponding city or municipal authorities of the action it has taken.

ⁱⁱ . *General Welfare*. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.



ORDINANCE NO. 2023-07

AN ORDINANCE PROHIBITING THE USE OF CASH CARDS ISSUED TO HOUSEHOLD BENEFICIARIES OF THE PANTAWID PAMILYANG PILIPINO PROGRAM OR THE 4PS AS COLLATERAL OF A LOAN, PROVIDING PENALTIES THEREFORE AND FOR OTHER PURPOSES.

WHEREAS, this is a valid exercise of the police power vested upon the Local Government Units pursuant to Section 16 of the Local Government Code of 1991 (RA 7160)

WHEREAS, the Pantawid Pamilya Pilipino Program (Pantawid) supports the achievement of the Millennium Development Goals as follows:

- Eradicating Extreme Poverty and hunger
- Achieve universal primary education
- Reduce child mortality
- Improve maternal health
- Promote gender equality and empower women

WHEREAS, the pantawid Pamilya National Advisory Committee (NAC) in an inter-agency and highest Policy-making body that provides policy directions and guidance on matters pertinent to Pantawid Pamilya Pilipino Program implementation;

WHEREAS, the Grievance Redress System (GRS) of the Pantawid program has been receiving complaints on cash card pawning and making use of Pantawid documents as loan collateral, use of grants for gambling use of grants on vices, collection of fees and false representation of beneficiaries in the program;

WHEREAS, the grants received by the beneficiaries through their compliance to program conditions are owned by the government, which does not authorize the grantee to pawn or use it as loan collateral or to any transaction or undertaking whatsoever;

WHEREAS, to ensure proper utilization of grants, sanctions have to be imposed for every violation so that beneficiaries will recognize and prioritize the education and health of their children only through this program;

WHEREAS, the Pantawid Pamilyang Pilipino Program or 4Ps is a human development measure of government that provides CASH GRANTS to the poorest of the poor, to improve the health, nutrition and the education of children of the household beneficiaries aged 0-18.

WHEREAS, the cash grants are distributed to the household beneficiaries through a Landbank CASH CARD issued to them. In order to protect the interest of the household beneficiaries from an unscrupulous individuals or entities of unlawful machinations and to preserve the integrity of the program, this legislative enactment of crafted.

SECTION I. TITLE.

This ordinance shall be known and cited as **"CASH GRANT PROTECTION ACT OF 2017."**

SECTION II. DECLARATION OF POLICY.

- (a) It is hereby declared the policy of the province to promote the general welfare of its inhabitants;
- (b) It is likewise the policy of the province to protect its inhabitants from deceitful machinations perpetrated by unscrupulous individuals or entity; and
- (c) It is also the policy of the province to help the national government in weeding-out undesirable household beneficiaries from the program.

SECTION III. COVERAGE

- (a) Individuals offering loan to household beneficiaries of Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Cards as collateral;
- (b) Officers or Agents of entities like associations, cooperatives, companies, or corporations offering loan to household beneficiaries of Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Card as collateral; and
- (c) All household beneficiaries of the program including those families in the modified cash transfer program in need of special protection as follows:
 - c.1. street families;
 - c.2. itinerant indigenous families;
 - c.3. families displaced by natural and manmade disasters;
 - c.4. families with a person with disability (PWD);
 - c.5. child laborers;
 - c.6. children in conflict with the law;
 - c.7. families with members with terminal disease; and
 - c.8. victim of human trafficking.

SECTION IV. PROHIBITED ACTS.

- (a) It shall be unlawful for any individual mentioned in Section III (a), officers or agents of entities like associations, cooperatives, companies, or corporations with or without juridical personality to offer loan to household beneficiaries mentioned in Section III (b) requiring Cash Cards as collateral; and
- (b) It shall be unlawful for any household beneficiaries or any member of the families mentioned in Section III (c) to use their CASH CARD as collateral of a

SECTION V. PENALTIES.

- (a) For persons mentioned in Section IV (a), a fine of Four Thousand Pesos (P4,000.00) or imprisonment of four (4) months or both in discretion of the court shall be imposed for the violation of this Ordinance; and
- (b) For household beneficiaries or any members mentioned in Section III (c), a fine of One Thousand Pesos (P1,000.00) or an imprisonment of two (2) months or both in the discretion of the court shall be imposed for the violation of this Ordinance.

SECTION VI. IMPLEMENTING RULES AND REGULATIONS.

The Provincial Social Welfare and Development Office is hereby mandated to formulate the implementing rules and regulations of this ordinance for its efficient and effective implementation, within sixty (60) days after its effectivity.

SECTION VII. REPEALING CLAUSE.

Any ordinance or executive orders, proclamations and administrative regulations or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION VIII. SEPARABILITY CLAUSE.

If, for any reason a portion or portions of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity of the other provisions not affected thereby, pursuant to the provisions of RA 7160 otherwise known as the Local Government Code of 1991.

SECTION IX. EFFECTIVITY CLAUSE.

This Ordinance shall take effect after posting and publication in accordance with the provisions of the Local Government Code of 1991.




