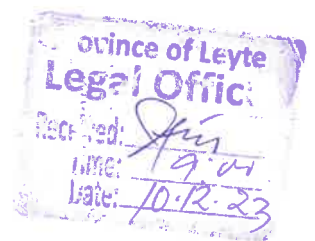

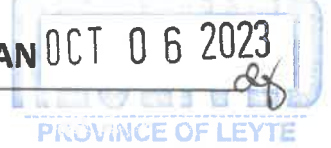

MUNICIPAL ORDINANCE NO. 2023-20

AN ORDINANCE ESTABLISHING AN AWARDS SYSTEM FOR THE THREE-TERMER ELECTIVE BARANGAY OFFICIALS OF THE MUNICIPALITY OF JULITA, LEYTE

Sponsored by Hon: Irvin R. Dy

WHEREAS, this system is giving motivation to dedicated barangay officials to improve their performance;

WHEREAS, there is a need to establish an Awards System to the three-termer elective barangay officials of the municipality to fittingly honor and appreciate their hard work and dedication to the public service;

NOW THEREFORE, on motion of *Hon. Irvin R. Dy*, duly seconded by the *Hon. Aliana Marie R. Tubi*.

BE IT ENACTED by the Sangguniang Bayan of the Municipality of Julita, Leyte in session duly assembled that:

Section 1. Title – This Ordinance shall be known as An Ordinance Establishing an Awards System for the three-termer Elective Barangay Officials of the Municipality of Julita, Leyte.

Section 2. Scope and Coverage – This ordinance shall govern the giving of awards to all elective Barangay Officials who have completed their three (3) consecutive terms in the same position.

Section 3. Recognition Awards – All barangay officials who have completed the three (3) consecutive term for the same position shall be awarded a Plaque of Recognition signed by the Local Chief Executive and the Municipal Local Government Operations Officer, to be given by the Local Chief Executive.

Section 4. Awarding – The Plaque of Recognition shall be given in an appropriate ceremony scheduled at the end of the term of recipient three-termer elective barangay officials.

Section 5. SOURCE OF FUND – The budgetary requirements necessary for the implementation of this ordinance shall be allocated in the Annual Budget in the year the barangay election will be conducted.

The Office of the Municipal Mayor will determine the amount depending on the total number of awardees.

Section 6. Separability Clause - If, for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.
